DA prepares for El Niño in CALABARZON

The Department of Agriculture in Region IV-A has started implementing measures to mitigate the effects of the looming El Niño phenomenon or dry spell in the region's farm production.

The DA's action plan as of May, 2023 includes preparatory activities from prepositioning of seed reserves, planting materials, crop diversification to water manage-

According to the Philippine Atmospheric, Geophysical and Astronomical Administration (Pagasa), El Niño is characterized by unusually warmer than average sea surface temperatures (SSTs) in the central and eastern equatorial Pacific. Below-normal rains are expected, which can cause dry spells and droughts in several areas of the country. The DA identified at least 19 areas in Cavite, Laguna, Batangas and Rizal that are vulnerable to drought,

this payment system, with those already on board passing their respective local ordinances for this purpose.

BSP has led the launching of the Paleng-QR PH Plus program in the cities of Baguio, Cebu, Davao, Naga, Tagbilaran, Pasig, Lapu-Lapu, and Bacolod; and the towns of Camiling in Tarlac province and Carmona in Cavite province.

Romulo-Puyat said Paleng-QR program is among the government's modes of increasing digital payments in the country, with this system using quick response (QR) codes. With the program, a digital database tracks transaction habits and credit worthiness of households and micro, small and medium enterprises (MSMEs) that do not have credit histories and/or sufficient collateral to get loans from the formal financial system. As the program's coverage is expanded, Romulo-Puyat said they want

to study first the system in areas where the program has been launched to ensure it is effective, noting particularly the need for a stable internet connection. "That's the problem and that's what we've asked (for) help not from DILG (Department of the Interior and Local Government) but more from DICT (Department of Information and Communications Technology)," she said in mixed Filipino and English.

Romulo-Puyat disclosed that Baguio City Mayor Benjamin Magalong has secured a deal with an internet service provider for the city and the speed is "really fast." She said such a deal is being eyed to be replicated by Pasig City

Mayor Vico Sotto. "We want to make it work kasi mahirap if masyadong marami tapos failure naman, hindi naman 100 percent. So kini-case study naming lahat (We want to make it work because there's no sense in having so many participants but a failure, not 100 percent (working). So we're using the existing ones as base for case study)," she added. (PNA)

last June 26. The report came from a member of the Philippine Marine Corps, citing the "pulling down, taking turns to tear, and throwing away" of the Philippine flag. These actions are considered

a violation of Republic Act or omission casting dishon-(RA) 8491, also known as "The Flag and Heraldic Code of the Philippines." RA 8491 strictly prohibits to "mutilate, deface, defile, trample, on or cast contempt any act

or or ridicule upon the flag over its surface." Tansingco, meanwhile, said the BI is now preparing to process the deportation of the four foreign nationals following their unlawful action. (PNA)

CCC backs waste-to-energy initiative to make PH climate-resilient

The Climate Change Commission (CCC) on Thursday expressed support for the use of waste-to-energy (WTE) technologies to build a more climate-resilient Philippines.

In a statement, CCC Commissioner Albert dela Cruz Sr. considered the WTE projects as "pro-environment activities and investments" that could help strengthen the country's climate resiliency. Dela Cruz stressed the importance of taking immediate steps to address environmental issues, considering the worsening weather condition that brings at least 20 typhoons every year in the Philippines and the emergence of climate change due to "human activities," which include the use of landfills, deforestation and burning of fossil fuels.

"Since our country is located near the equator, we have warm seas and this is where typhoons are created. In the past 10 years or so, because of global warming, we have experienced super typhoons that not only destroy property and infrastructure but cause the deaths of people and livelihood,"

Dela Cruz issued the statement as he is set to join Pagsanjan, Laguna Mayor Cesar Balbuena Areza on Friday in leading the inauguration of the municipality's bio-methanation and thermolysis machine for the proper disposal of waste.

The launching was in line with the green transition of the landfill using WTE technologies that have been endorsed by the Department of Environment and Natural Resources.

Dela Cruz lauded the Pagsanjan local government, as well as the PEDECO led by executive director Maximino Camacho, for supporting the National Climate Change Action Plan (NCCAP) of the Marcos administration.

Poll body prepares for possible automation of 2 elections in 2025



The Commission on Elections (Comelec) on Thursday said it will study and prepare for a possible automation of two elections in 2025 following the ruling of the Supreme Court (SC) greenlighting the holding of the Barangay and Sangguniang Kabataan Elections (BSKE).

During the Laging Handa public briefing, Comelec chairperson George Erwin Garcia cited a possible tweak to its initial plans, especially in organizing a wider scale of automation. "Mukhang magdadagdag po at magkaroon tayo ng dagdag na budget para diyan at kinakailangan na pong pagdesisyunan kung ang December 2025 BSKE ay kailangan na rin nating gawing automated. Siyempre, magkakaroon po ng dagdag na gastos para diyan (It seems there should be additional and we will have a supplementary budget for that, and [we] need to decide whether the 2025 BSKE shall be also automated or not. Of course, it would entail an additional expense for that)," he

said. Garcia said two automated elections during the year on the BSKE. "Sa part po ng appear to have advantages in the poll body's preparation.

"Dahil mas napagaan nga po hindi po parang, kapag from the point of view of planning, para mas maganda kung nag-automate ka ng national and local election ng Mayo, mas magandang automated na rin po iyong BSKE ng December 2025 (Because it will become more convenient. From a planning point of view, it's better that if you automate May's national and local elections, it's also better to have an automated BSKE in December 2025)," he said.

The Comelec, meanwhile, said it is planning to pilot test automated BSKE in District 6 in Quezon City and Dasmariñas, Cavite on Oct. 30.

According to the poll body, if the pilot test becomes "very successful," succeeding BSKE may be also automated.

Garcia, however, admitted that the planning and preparation may be challenging considering the recently issued ruling of the SC Comelec, medyo mas mabigat po iyong aming gagawing paghahanda sapagkat papatak po na dalawa ang eleksiyon na gagawin ng Comelec sa 2025 -- iyon pong May 2025 national and local elections na automated at pagkatapos po iyong December na Barangay and SK Elections po na sinasabi ng ating Korte Suprema (On the part of Comelec, the preparations will be heavier because there are two elections to be done in 2025 -- the May 2025 automated national and local elections and then the December Barangay and SK elections as cited by the SC)," he said.

The SC earlier issued its ruling declaring unconstitutional Republic Act 11935, the law which postponed the holding of the BSKE from the original schedule of Dec. 5, 2022 to Oct. 30, 2023.

It also ruled that the BSK polls must be conducted on the first Monday of December 2025, and every three years thereafter. (PNA)
