Bucandala suffers unsteady water supply

Residents of Barangay Bucandala 3 in Imus, Cavite lamented that their water supply had been irregular for the past six months.

According to Oscar Oida's report on "24 Oras" on Tuesday, residents said they experienced either low pressure if not an outright water service interruption from 12 p.m. to 9 p.m. daily.

"Sakripisyo po kasi kailangan po talaga namin ng tubig araw-araw para makahugas. 'Yun po ang daily need namin (tubig) kaya sana po maayos po ang tubig," Freddie Cortez, a resident, lamented.

(It is such a sacrifice because we need water daily to wash. I hope the water supply will be fixed.)

Another resident, Corazon Rabimbe urged Maynilad Water Services Inc. to address their water

Remulla meets with DOJ chief for transition

Deputy House Speaker and incoming Justice Secretary Jesus Crispin "Boying" Remulla on Thursday met with outgoing Secretary Menardo Guevarra to discuss the turnover of the Department of Justice (DOJ) to the next administration.

At the end of a two-hour meeting, Remulla said he got a bird's eye view of the DOJ and its attached agencies' situation but declined to give specifics on the issues discussed.

"It's a big work in progress na ating itutuloy at ating ilulunsad ang mga improvements na pwede gawin (It's a big work in progress that we will pursue and launch improvements that we can undertake)," he said in a media interview.

Given the complex work to be done, Remulla said he would ask for a second meeting.

"We might ask for a second one [meeting] kasi masalimuot talaga ang problema ng sistema na kailangan natin isaayos. At talaga nakakatuwa naman na bigyan kami ng impormasyon na ukol sa mga suliranin na sumasambalot sa ating hustisya (We might ask for a second one because the problems are really complicated and we are glad that we were given information on the problems faced by our justice system)," Remulla said.

Government offices under the DOJ are the National Bureau of Investigation (NBI), National Prosecution Service,

supply woes. "Kung wala ka ipon dito ng tubig, saan ka iigib? Kagaya sa akin na nagmamanhind na aking kamay... maglalaba ka, maghihintay ka pa ng 10 p.m. Gaano kahirap yun?" Rambibe said.

(If you cannot store water here, where will you get it? People like me, who have problems with their hands. I have to do the laundry, but I still must wait until 10 p.m.? Can you imagine the difficulty?)

"Ayusin nila ang koneksyon ng tubig dito sa nasasakupan," she added.

(They should fix the water connection in our area.)
Maynilad Corporate

Communications Head Jennifer Rufo apologized for their failure to normalize the water supply for their customers.

Rufo also admitted that it was difficult supplying enough water in the area due to its location.

"Dulong-dulo ito so talagang 'di pa siya talaga 24 hours na may tubig... pag mataas ang lugar, kailangang marami ang supply at kailangan ma-i-push ito ng pumping station para makarating sa elevated portions," she said.

(It is at the far end, so the water supply isn't really available for 24 hours. When the area is in a higher location, there needs to be a lot of water, and the pumping station needs to be able to push it to get to the elevated portions.)

"And unfortunately, kapag mayroon tayong concerns hinggil sa production ng ating mga planta, sila yung unang nakakaramdam dahil dulong-dulo sila ng ating network," she added.

(And unfortunately, when we have concerns with our operation, they are the first to be affected because they are at the far end of our network.)

To fix the problem, Rufo said they were building a third water treatment plant in Laguna Lake.

"Target po natin na mat-

apos 'yan next year. Kukuha rin siya ng tubig sa Laguna Lake... 'pag nabuo na ito, makakadagdag siya ng another 150 million liters of water per day," she stated. "Kapag naging operational 'yan, 'yan po ang long-term solution, magiging 24 hours ang tubig sa Imus."

(Our target is to finish that next year. It will also draw water from Laguna Lake. Once built, it will be able to add another 150 million liters of water per day. Once operational, it will be our long-term solution, and water services will be available for 24 hours.) — Mel Matthew Doctor/DVM, GMA News

Filipinos urged 'to take heart all the learnings from the past'

Outgoing President Rodrigo Duterte has urged Filipinos to "take heart all the learnings from the past" in a speech ahead of the celebration of the 124th Philippine Independence Day.

He delivered his speech during the virtual celebration of Independence Day and the 21st Filipino-Chinese Friendship Day organized by the Federation of Filipino Chinese Chambers of Commerce and Industry, Inc. (FFCCCII).

In his speech, Duterte reminded Filipinos about the importance of celebrating Independence Day on June 12 as a testament to how the country's forefathers fought for the freedoms that Filipinos enjoy today. "May it inspire us to take after the courage of our heroes as well as encourage us to use our ability, skills and knowledge for the benefit of our community," Duterte said. He also urged the public to "take heart all the learnings from the past", especially the countless hardships that Filipinos had to endure as a nation. "Let our rich histories move to translate our love for this country into real acts of goodwill for all our fellow men. Let us also work together so that we could realize our vision of a more harmonious and progressive Philippines. May we have a meaningful commemoration," he added. The country's first president, Emilio Aguinaldo, proclaimed the Philippines' independence from the Spanish colonial rule in Kawit, Cavite on June 12, 1898. From July 4, 1946, the Philippines celebrated Independence Day every July 4. However, the celebration was moved to June 12 by virtue of Proclamation 4166, issued by President Diosdado Macapagal. Incoming President Ferdinand "Bongbong" Marcos Jr., for his part, expressed hope that the centuries-old relationship and friendship between the Philippines and China will continue to be of great mutual benefit to their respective people. "From trade, arts, culture, athletics to regional peace and stability to the employment of opportunities for our people, and all the significantly generous efforts
