One of the banner programs of the DOH, the HFEP assists local government units (LGUs) across the country to rehabilitate and put up Rural Health Units, Level 1 and 2 Hospitals, and even Apex Hospitals to provide the community's medical needs.

Valencia said the super rural health center is also part of the continuous implementation of the Universal Health Care (UHC) Law which enables LGUs to provide medical services that the community and its neighboring areas need.

Initiated by the municipal government, Valencia said the center's construction is expected to be completed in six months or before the year ends.

capitalizes on the areas' strength as the country's primary industrial region with five priority industries -- information technology and business process management (ITBPM), metals, electronics, automotives and petrochemicals.

Agnes Tolentino, director of NEDA Region IV-A, said the Regional Development Plan (DP) 2023-2028 was born out of a recognition that there remained certain gaps in earlier development plans for the region.

It was explained that the identification of developmental gaps led to the formulation of the Calabarzon RDP, put together through a series of consultative workshops with various stakeholders to ensure that the plan will be inclusive and responsive to the needs of the whole region.

"The Calabarzon RDP contains strategies and priority programs and projects to aid the region in attaining full economic recovery and sustaining its gains from the previous years," said Tolentino.

Batangas Governor Hermilando Mandanas, who sits as chairperson of RDC, urged stakeholders to support the implementation of the RDP.

"Together, let us embrace this opportunity to create a lasting legacy of progress, resilience and inclusive growth for our region. By working handin-hand, we can overcome any obstacle and build a secure future for the generations to come," the governor said in his speech.

Mandanas stressed the RDC's crucial role in guiding progress in Calabarzon through "coordinating efforts, developing strategies, allocating resources, monitoring, and evaluating progress and advocating for the RDP."

The provinces of Cavite, Laguna, Batangas, Rizal and Quezon make up the Calabarzon region.

"The RDC can ensure that the plan is communicated effectively to the stockholders, and the public building support for its effective implementation and ultimately contributing to the region's sustainable and inclusive development," said Mandanas.

"As the regional development forms the backbone of our country's progress, particularly in

addressing poverty, inequality, and promoting inclusive growth in all regions, we cannot overemphasize the important role played by RDCs in setting the direction for economic and social transformation," Balisacan said in his speech. Phivolcs: Prepare for up to magnitude 5.3 aftershocks

After the magnitude 6.3 earthquake that jolted Batangas on Thursday, the Philippine Institute of Volcanology and Seismology (Phivolcs) is urging the public to prepare for aftershocks that could reach up to magnitude 5.3.

"We remind them that we should prepare for aftershocks. In case of another strongly-felt earthquake, protect themselves by doing the duck, cover, and hold," Phivolcs officer in charge Teresito Bacolcol said in a public briefing.

The magnitude 6.3 quake, which was 119 km. deep, struck 15 km. southwest of Calatagan, Batangas at 10:19 a.m.

Bacolcol said usually, aftershocks would be one degree lower than the main shock, thus, they are expecting aftershocks to be magnitude 5.3 at the most.

The main shock was felt at Intensity V in Calatagan, Batangas, in Lubang, Look Paluan, and in Occidental Mindoro.



nearby provinces and Metro Manila felt the earthquake due to its depth.

"The deeper the earthquake, the wider the area where this would be felt," he said. Intensity IV was felt in Manila City; Mandaluyong City; Quezon City; Valenzuela City; City of Malolos in Bulacan; Batangas City, Ibaan, Lemery, Nasugbu, and Bacolcol explained that Talisay, all in Batangas; City of Dasmariñas and City of Tagaytay, in Cavite; and Tanay in Rizal.

Bacolcol said damage to infrastructure is also possible but they are not expecting it to be severe as the earthquake was deep.

He, however, cautioned the public not to enter their house or building if they see signs of damage or if the structure was visibly


weakened by the magnitude 6.3 quake. "It could further be damaged by succeeding earthquakes and would injure building occupants," he said. Bacolcol also advised the public to consult with engineers if they see signs of damage.

Meanwhile, he said there is no tsunami threat due to the earthquake's depth.

2 'high-value' drug suspects fall, P3.4M drugs seized in Cavite

ROSARIO, Cavite - Two suspected big-time drug dealers were arrested in this town and PHP3.4 million worth of shabu was seized by combined operatives of the Cavite Police Provincial Office (PPO) and the Philippine Drug Enforcement Agency (PDEA).

In a statement on Wednesday, the Police Regional Office-Calabarzon (PRO-4A) said suspects Basit Dimasira Mamacol alias "Mosib" and Sandy Jailani Rabalon



were apprehended in a buy-bust operation in Barangay Tejeros Convention on Tuesday.

Both were categorized by the Cavite PPO as "high-value drug personalities."

A plastic bag containing some 500 grams of suspected crystal methamphetamine or "shabu," with a street value of some PHP3,450,000, was confiscated from Mamacol and Rabalon.

Brig. Gen. Carlito Gaces, PRO-4A director, lauded the two law enforcement agencies, whose "remarkable partnership" led to the arrest of two notorious drug suspects and seizure of millions of peso worth of shabu.

"We have to sustain the gains we have already achieved in our campaign against illegal drug trade in our region," the police official said.

He attributed recent successes in the fight against the illegal drugs trade to "aggressive and honest law enforcement operations in collaboration with other law enforcement agencies such as the PDEA."

It was disclosed that Mamacol and Rabalon are now in PDEA's custody, and are facing charges of violating Section 5 and 11 of Article II of Republic Act 9165 or the Comprehensive Dangerous Drugs Act of 2002.

"This only shows that PRO-Calabarzon is committed to work closely with PDEA-4A in the conduct of an aggressive campaign against illegal drugs in the entire region," Gaces said.

He pointed out that on May 24, lawmen in Calabarzon confiscated over PHP190 million worth of shabu from two suspects in a similar sting operation in Calamba, Laguna. (PNA)
