PDIC begins deposit insurance payouts to Farmers Savings and Loan Bank, Inc. depositors.

The Philippine Deposit Insurance Corporation (PDIC) announced that it started paying deposit insurance through Postal Money Orders (PMOs) on June 10, 2022 to all depositors eligible for outright payment who maintained deposits with the closed Farmers Savings and Loan Bank, Inc.

Eligible for outright payment of deposit insurance are individual depositors with valid deposit balances of P100,000 and below who have no outstanding loans with the closed bank and have a complete mailing address in the bank records or updated this information through the PDIC Mailing Address Update Form (MAUF).

PMOs amounting to P15,000 and below may be encashed either with the local post office or with the nearest branch of the Land Bank of the Philippines. Meanwhile, PMOs above P15,000 may be deposited

the Vermosa development, a 725-hectare mixed-use property straddling Daang Hari road, had already begun.

"The substation will house three transformer banks, each capable of generating 83 megavolt amperes (MVA) of power, for a total capacity of 249 MVA," according to Meralco.

The power plant is expected to be fully operational by December of this year, and it was designed to support both new and extra load applications in the area.

Meralco's commitment is "to provide the energy infrastructure to meet the projected growth of new communities, not just for timely energization but to have the right facilities to meet their needs," according to Ronnie L. Aperocho, SVP and head of Networks of Meralco.



As of today, the segment has reached more than 95% completion. Also discussed during the inspection is the traffic management plan for

the area once the extension opens. This entails transferring of the Merville entry and exit ramp to in front of Shell C5 Southlink for better traffic flow. Traffic signalization and signages will be installed in coordination with the local authorities to help manage traffic for motorists bound to the expressway, and those that will use the service road. "We are pleased to see the progress of the CAVITEX C5 Link. We look forward to it serving an estimated 15,000 motorists, helping lessen their travel time from SLEX to Pasay, Taguig and Paranaque, thereby helping decongest some of our local roads" said TRB Executive Director Atty. Once the entire CAVITEX C5 Link project is completed in 2023, the 7.7km expressway will benefit more than 50,000 motorists. It will reduce travel time from CAVITEX to Makati, Taguig, and Pasay in under forty-five minutes while helping decongest EDSA, MIA Road., Roxas Boulevard and other major thoroughfares.
