Php18.8 Million worth of substandard steel bars destroyed

An estimated PHP18.8 Million worth of sub-standard steel bars were recently destroyed upon orders of Trade & Industry Secretary Fred Pascual.

A total of one hundred thirty-six (136) bundles of deformed steel bars were cut into pieces in the manufacturer's warehouse last 7 to 9 June 2023.

The sub-standard deformed steel bars were produced in the local steel mill located in Laguna and were found non-compliant with the requirements of the regulations when DTI, through its Bureau of Philippine Standards (BPS), conducted a surprise factory audit last 20 March 2023

Two barangay officials have been allowed to have a police escort after the threats to their lives have been validated, an official of the Philippine National Police (PNP) Police Security Protection Group (PSPG) said on Wednesday.

PSPG Director, Brig. Gen. Antonio Yarra, said the two officials are from Pangasinan and Batangas. Meanwhile, a request from a barangay official in Laguna is undergoing threat

"Based on our memorandum circular, we can provide one police security personnel and one protection agent or two protection agents ... but for the local officials appointed or elected we can provide two protective security personnel," Yarra told reporters during a press conference in Camp Crame. "We assess that and may sinasabi tayong emergency case. Ito yung may actual threat on their lives, ito yung may attempt na atrocities

call emergency cases. These are those with an actual threat on their lives, or attempted atrocities or ambush)." He said the PSPG has already deployed 257 personnel to provide security to 158 officials, from senators to local officials. "Protective security personnel - ito yung mga pulis na dinideploy natin (these are the police we deploy) mga PNP personnel and then the protection agents, these are security professionals licensed and authorized by law o ambush (We have what we to provide security services for

private individuals," he said.

"The maximum number is six, subject to the approval of the President yan. Ang allowed natin ay hanggang two protection agent (We allow up to two protection agents) or one police plus one protection agent and then for the local and national government officials appointed and elected, we can provide two PSP or PNP personnel." Yarra said they expect more people to ask for police escort as the election draws near and apart from the

threat to life, they also check the applicants' background "We are preparing for that and we are conducting it in coordination with the other police units and then that is part now of the preparations for the local elections to eliminate yung mga risk factors na present in the area para to prevent election-related violence this coming local elections. We are one with our police regional offices to check from the licensing, registration, permits to carry firearms outside of residence,

yan yung tinitingnan natin (that is what we are looking at)," he said. The PNP is the top law enforcement agency being tapped by the Commission and Elections to secure elections. Under Commission on Elections (Comelec) Resolution 10902, the 90-day election period for the 2023 Barangay and Sangguniang Kabataan Election will commence on Aug. 28, with the filing of certificates of candidacy. PNP chief Gen. Benjamin Acorda Jr. earlier said the PNP would strictly enforce all prohibited acts during the entire election

period as enumerated under the Omnibus Election Code and resolutions passed by the Comelec. "These prohibited acts include the bearing, carrying, or transporting firearms or other deadly weapons in public places, including any building, street, park, private vehicle, or public conveyance unless authorized in writing by the Comelec and also prohibited during this period is the use of security personnel or bodyguards by candidates," he said.

The COC filing period for the 2023 BSKE will be from Aug. 28 to Sept. 2. (PNA)

BIR said.

the warehouse of Vermirich Foods Corporation (Vermirich), manufacturer of various juices, located in Cavite Light Industrial Park on Thursday, according to an agency news release late Thursday evening.

The raid was part of the bureau's ramped-up campaign against tax evasion and illicit trade.

BIR said that based on its records, Vermirich failed to file excise tax returns and pay the excise taxes due on the sweetened beverages they manufactured from 2018 to the present.

"This is in violation of

Sections 130, 150-B, 254, and 263 of the National Internal Revenue Code (NIRC) of 1997, as amended, which pertains to the filing and payment of Excise Taxes," the Vermirich also failed to

secure the appropriate permit to operate as a manufacturer of sweetened beverage products subject to excise taxes, in violation of Section 154 of the same Code.

The BIR said the PHP800 million deficiencv excise taxes incurred by the firm include interests, surcharges, fines, and the 12 percent value-added tax

er the appropriate taxes had been paid by Vermirich on the sweetened beverages in question. Consequently, S&R can be held liable for violations of Section 4, Revenue Regulations No. 20-2018, and Sections 130, 150-B, and 263 of the NIRC," it added.

In a separate statement, the BIR said officials and employees of its Large Taxpayers Service also raided Supervalue, Inc. and Super Shopping Market, Inc., in SM City North Mall, Quezon City. The agency said the raid was prompted by the discovery of numerous boxes of SM Bonus Apple Juice Drink

Simultaneously. BIR representatives conducted a raid at S&R Membership Shopping located at 32nd Street and 5th Avenue, Bonifacio Global City, Taguig.

According to information on file with the Bureau, S&R, a distributor of S&R Lemon Tea and S&R Raspberry Tea, both of which are powdered juice beverages manufactured by Vermirich, possessed these untaxed goods, which were then seized by the Bureau during the raid.

"BIR records also show that S&R had been duly advised by the Bureau in a letter dated July 6, 2021 to comply with the regulatory requirements," said BIR.

"As the distributor of Vermirich's products, S&R failed to exercise due diligence in ascertaining whethand SM Bonus Orange Juice Drink in the warehouse of Vermirich Food Corporation that was raided by the BIR group in Cavite.

The BIR said Supervalue and Super Shopping Market, as distributors of SM Bonus Apple Juice Drink and SM Bonus Orange Juice Drink, were in possession of these untaxed goods, which were seized by the Bureau during the raid. "Since both enterprises possessed the said goods, they failed to exercise due diligence in ascertaining whether the appropriate taxes had been paid by Vermirich on the sweetened beverages in question," it said.

BIR said it will continue to look into other manufacturers of sweetened beverages, to determine whether they have secured the appropriate permits to produce such goods and paid the correct excise taxes. (PNA)



As we continue to promote a conducive business environment, we also expect that manufacturers, particularly of products covered by the DTI-BPS' mandatory certification, shall consistently adhere to regulations in order to produce and distribute only good quality and safe products for the benefit of Filipino consumers," Secretary Pascual emphasized. The substandard products were cut into pieces using the manufacturer's facility and was witnessed by representatives from the BPS. BIR warns public vs. illegal TIN card online sellers

The Bureau of Internal Revenue (BIR) on Monday urged the public not to patronize and obtain their taxpayer identification number (TIN) card from online sellers.

The BIR reiterated the warning after discovering that several individuals are offering TIN ID assistance via Facebook, Shopee, Lazada and other online selling platforms. "These offers of TIN ID assistance posted in online channels or selling platforms are not authorized by the BIR and are, therefore, considered illegal. Please do not be deceived or misled by such offers," Commissioner Romeo Lumagui Jr. said.

The BIR said its Client Support Service conducted a dialogue with representatives of Shopee and Lazada last month to call their attention on such illegal activities, and to request them to immediately remove all advertisements/postings offering TIN ID assistance.

"TIN cards are not for sale, and are only issued or released by the BIR through its authorized personnel. Do not get TIN or TIN cards from unauthorized BIR personnel, non-BIR personnel or through Facebook, Shopee, Lazada and other online selling platforms, because they are considered illegal, fraudulent and fake," Lumagui said.

The BIR reiterated that getting a TIN or TIN card is free of charge and does not require third-party services for it to be issued. To ensure the authenticity and legitimacy of the TIN and TIN card being issued, Lumagui advised the public to transact only with authorized revenue personnel at the Revenue District Office (RDO) having jurisdiction over their residence and to follow the established process for obtaining both.

He also reminded everyone to exercise caution when giving their personal information online to prevent identity theft and other cybercrimes.

"The BIR remains committed to protecting the integrity of the taxation system and ensuring compliance with tax regulations. We urge the public to cooperate and report any sellers of TIN or TIN ID to the BIR through our Hotline number (02) 8538-3200 or via email at contact_us@bir.gov.ph. By reporting such activities, you are helping the BIR put a stop to this unlawful practice," Lumagui said.

According to BIR, several entrapment operations and arrests of sellers of TIN ID assistance services were already made by the BIR regional and district offices since 2019 in Laoac, Pangasinan; Cebu City; Bukidnon; Gumaca, Quezon; Pila, Cabuyao and Sta. Rosa, Laguna; and Cordillera Administrative Region.

The offenders were apprehended, and legal proceedings were initiated to ensure that appropriate penalties were imposed. (PNA)
