### Ban on nursing programs << P1

Panel on Nursing has been working on the new policy, which may be released soon. "CHED is working with the DOLE (Department of Labor and Employment) and DOH (Department of Health) to determine the supply and demand for nursing graduates for a possible strategic selective lifting of the moratorium in key geographic areas and types of institutions and the Commission will issue the new policy soon," he told the Philippine News Agency.

He said it has been several years since they started the assessment, considering the demands brought by the coronavirus disease (Covid-19) pandemic.

"The Commission on Higher Education (CHED) has already recognized the need to review the 2011 moratorium on the opening of new nursing programs given the changing regional and global demand for health manpower over the past five years," he said.

However, De Vera argued that a "whole-of-system lifting" might be unfavorable, so there is a need for a strategic study before imposing a new policy.

'The lifting of the moratorium, however, must be based on a correct assessment of the supply and demand for nurses both locally and internationally... The unilateral lifting of the moratorium and allowing all higher education institutions (HEIs) to offer nursing will not address the problem," he added.

CHED, in Memorandum Order 32 dated September 30, 2010, stopped the opening of all undergraduate and graduate programs in business administration, nursing, teacher education, hotel and restaurant management and information technology education beginning school year 2011-2012.

The moratorium was issued on the ground that the proliferation of the programs would cause "the deterioration of the quality of graduates of these five higher education programs."


De Vera made the statement in response to Cavite 4th District Rep. Elpidio Barzaga Jr., after the lawmaker slammed the commission for its "stubbornness" against lifting the 11-year ban on the nursing program, warning of a possible "dramatic escalation" of national and global shortage of nurses.

"It's high time that CHED lifted the 11-year-old ban on nursing programs. We're still in a pandemic and we've seen how badly we need more nurses and health workers as we continue to battle Covid-19. The CHED's stubbornness is hurting the country; this is unthinkable," Barzaga earlier said.

It is built on the five-hectare land donated by the province of Cavite. Once operating, the facility will cater to illegal drug users mainly from South and Central Luzon and will be free of charge. To be managed by the DOH, its dormitories can accommodate a total of 400 male and 80 female drug dependents. The rehabilitation center aims to provide accessible and immediate interventions for drug dependents. It will be a fundamental part of the referral system with the DOH's Formula One Plus strategic pillar in the health service delivery network. (PR)

are the wrong motivation(s) for an entrepreneur," he said at the official launch of Supah, a business division of Cu's latest startup SariSuki.

Unicorns are startup companies whose value exceeds USD1 billion.

After founding his e-commerce startup SariSuki in May 2021, Cu started Supah last March.

While SariSuki adopts a community group buy model, Supah offers quick commerce by delivering groceries within 15 minutes. Customers may order grocery items via Supah mobile app. These items are sourced from Supah's "dark stores", wherein only Supah riders can enter and pick items for customers' grocery orders. SariSuki chief commercial officer Bam Mejia told the Philippine News Agency that more than half of the products in the dark stores are sourced locally, especially vegetables from local farmers.

Mejia said that with farmers throwing their harvests due to oversupply and "very cheap" farmgate prices, the startup is partnering with local farmers wherein they can supply agriculture products to both SariSuki and Supah. Supah has its central "dark warehouse" in Muntinlupa that delivers products to eight dark stores located in Metro Manila.

It aims to expand its dark stores slowly and grow outside the National Capital Region, like Cavite and Bulacan. From transport and fashion retail, Cu said his focus now is helping local farmers and those who lost their jobs in the past two years.

"Now I want to do it in agriculture, in helping certain sectors, of individuals who happened to be unemployed or underemployed during the pandemic," he said.

This mission has gotten some USD11-million funding support from both local and foreign sources, including magnate Lance Gokongwei, the president and chief executive officer of JG Summit, who also sits as a board director at SariSuki.

"Supah offers a great potential as it tries to address the consumers' evolving needs in

grocery shopping by finding the optimal balance among several critical factors like speed, assortment, value, and convenience. This innovative technology will help shape the future of grocery shopping in the country," Gokongwei said.

Cu said he measures a startup's success if it brings great impact to the improvement of the society and gives back good returns to the funders.

"I think when we do these things right and you focus on the mission, you may get your unicorn dream. If you don't, as long as you return a good, you made a good return for your early believers and investor partners you can sleep well at night," he added. (PNA)

# **DILG to thwart attempts to embarrass,** disrupt BBM inauguration

The Department of the Interior and Local Government (DILG) will not allow any plot by the Communist Party of the Philippines (CPP) and its allied and front organizations to embarrass or discredit the incoming administration.

DILG Undersecretary and National Task Force to End Local Communist Armed Conflict (NTF ELCAC) spokesperson Jonathan Malaya made the remark following the revelation by former cadres of the CPP-New People's Army-National Democratic Front (CPP-NPA-NDF) that the communist terrorist group is planning to disrupt the oathtaking of President-elect Ferdinand "Bongbong" Marcos Jr. on June 30. In a press briefing organized by the National Task Force to End Local Communist Armed Conflict (NTF ELCAC) on Monday, former rebels Orlando "Ka Warly" Baluyot, now chairman of Tinang Samahang Nayon Multi-Purpose Cooperative, and Ka Pong Sibayan, a farmer from Hacienda Tinang in Concepcion, Tarlac said the radical left has started mobilizing farmers in their province for this purpose.

They said aside from Hacienda Tinang, officials and members of CPP-NPA-NDF front organizations have also been meeting with farmers from nearby Hacienda Murcia and Barangay Central inside Hacienda Luisita.

"Ayaw talaga nilang maupo si Marcos. Iyon ang nakita natin na gagawin nila sa June 30 bago maupo si Pangulong Bongbong Marcos (They really don't want Marcos to assume office. That is what we have seen as their act on June 30 before President Bongbong Marcos takes oath)," Baluyot said.

"We are taking these in-

or discredit the forthcoming inauguration," Malava added.

He said the DILG and other security agencies have finalized all security preparation for the inauguration, including mobilizing around 6,200 police officers around the National Museum in the coming days.

He said it is not a surprise that the communist terrorist groups (CTGs) are planning something to embarrass the incoming administration.

"That's part of their playbook. Whoever sits in Malacanang is their enemy because ultimately, all they want is to overthrow the government through violent means to be followed by a socialist revolution," Malaya said. He said leftist organizers have been mobilizing in Tarlac, Cavite, Pampanga, Laguna in the past weeks to mobilize people for their nefarious ends.

"They are even misleading the youth to join them in their protest actions," he added.

He said the Philippine National Police (PNP) will have additional mobile forces on standby should radical leftist groups attempt to disrupt the inauguration.

"We respect the people's rights to free expression, peaceably assemble, and the exercise of their democratic rights but this has to be done within the bounds of the law. Therefore, we advise all protesters to hold their peaceful demonstrations in Manila's designated freedom parks such as Plaza Miranda, Plaza Dilao, Plaza Moriones, and Liwasang Bonifacio. There are so many to choose from," he said.

Incoming Chief Presidential Legal Counsel Juan Ponce Enrile earlier warned of a credible plot to embarrass the incoming administration.

"I just picked up what I

planning and preparing to cause serious embarrassment and trouble for our newly-elected President. Caution is the name of the game. You are just starting you[r] travel in troubled waters. Your adversaries have not stopped. To borrow a phrase from someone, right now 'they are hiding their brightness and biding their time," he said.

"I have humble unsolicited advice for the national security officials of the new regime. Instead of making soft and pacific statements seemingly intended to quiet and to gain the cooperation, trust, and confidence of the habitual troublemakers in this country, I suggest that they should sharpen their intelligence information," Enrile said.
