PrimeWater to boost water supply in two Cavite cities

PrimeWater Silang and PrimeWater Dasmariñas have inaugurated 11 water pumping stations in their respective service areas.

With strong support from the company's joint venture partners - the Silang Water District and Dasmariñas Water District - the projects were completed to improve water supply and water pressure among their concessionaires.

Six additional pumping stations were added to the existing ten by PrimeWater Silang to ensure 24/7 supply of potable water in the city's 14 barangays.

136,000 SSS members receive P1.71-B unemployment benefits in 2020

The Social Security System (SSS) released in 2020 more than P1.71 billion in unemployment benefits to 135,814 qualified members.

Preliminary data from the pension fund showed that the unemployment benefit releases last year increased nine-fold from P177.86 million in 2019. The number of claimants also increased by the same level from only 14,895 members recorded in the same year.

"The significant increase in the amount of benefit releases and the number of member-recipients in 2020 is largely attributed to the effects of COVID-19 crisis to the Philippine economy," Ignacio said.

Fast-track vaccines to provinces - Duterte

President Duterte has ordered government agencies to fast-track the deployment of vaccines to the provinces as the number of COVID-19 infections in Mindanao continues to rise.

During a meeting of the government's pandemic task force last Monday, Health Secretary Franciso Duque III reported that Mindanao is presently the highest contributor of COVID-19 cases in the country.

Duque cited the need to act on the rising number of persons being admitted to hospitals to address the pandemic surge in the Visayas and Mindanao.

Duterte then inquired

whether the local governments in areas with rising numbers of COVID-19 infections have received vac-

Duque told the President the government already has a vaccine allocation plan for every region, province, city and town.

Duterte ordered agencies to move faster in distributing the vaccines to areas with rising numbers of cases.

National Task Force against COVID-19 chief implementer Carlito Galvez Jr. said local governments have been scaling up their daily vaccination capacities as COVID-19 jabs are being consumed fast. He cited



Cagayan de Oro, Ormoc, Negros and Iloilo, which he said consume 5,000 to 8,000 doses per day.

"Different sectors are being mobilized and integrated so that they have an increased capacity in the vaccination," Galvez said.

effective March 5, 2019, or upon the approval of Republic Act 11199, also known as the Social Security Act of 2018, SSS started receiving unemployment benefit applications online last August 2019 upon deployment of the UB system." Among the seven benefit

programs of the SSS, the Unemployment Benefit is one of the landmark provisions of the 2018 SSS Law. It is a cash benefit granted to covered employees, including kasambahay (house helpers) and Overseas Filipino Workers (OFWs) who were involuntarily separated from employment due to economic downturn, calamity/disaster, installation of labor-saving devices; redundancy; retrenchment or downsizing; closure or cessation of operation; and disease or illness of the employee whose continued employment is prohibited by law or is prejudicial to his or her co-employees' health. "As more companies are retrenching and shutting down due to the pandemic, the number of affected employees is also increasing. Hence, to facilitate their applications for the said program, involuntarily separated workers should register online at the SSS website at www.sss.gov.ph to create their own My.SSS accounts for the mandatory online filing of their unemployment benefits. Almost all our processes are now online, allowing for an easier, faster, and simpler way to transact with us," Ignacio added. To qualify, members must not be more than 60 years old at the time of involseparation—except for underground and surface mineworkers, and racehorse jockeys whose age should not be more than 50 and 55 years old, respectively. They must have also paid at least

In a statement, Globe said that it is "taking the necessary steps in ensuring that its customers are well-protected from illegal activities concerning its products and devices" and that it is highly encouraging everyone to report any suspicious activities involving its modems.

In a previous statement, DITO Chief Administrative Officer Atty. Adel Tamano said that any "unauthorized use of the DITO branding in any form shall result in the possibility of prosecution for intellectual property infringement."

'There are no official DITO modems or pocket WIFI devices that have been launched at this time. DITO cannot and will not guarantee the performance and service should our SIM cards be used in these unauthorized devices in the market today."

Abigail Mojica, PrimeWater Silang branch manager, said the opening of new pumping stations was in response to the concerns of its concessionaires, including reports on scheduled water supply.

"We are listening to the requests of our customers. We added new sources for them to have better water supply. The vision is for water supply to be available 24 hours. The opening of additional pumping stations is the first step to achieve that vision here in Silang," she said amid complaints that water supply is sometimes limited to only three hours in certain areas.

In a Facebook post, Silang Mayor Corie Poblete applauded the efforts of Prime-Water Silang and Silang Water District to resolve the water issues in the city.

"We inaugurated these pumping stations with Prime Water Silang and Silang Water District taking the lead. I am pleased to know that in the near future, we will be free of our water-related problems," Poblete said.

Meanwhile, PrimeWater Dasmariñas launched five deep wells and pumping stations: Villa Elena Pumping Station, Cardinal Pumping Station, Malinta 3 Pumping Station, Victoria Reyes 2 Pumping Station, and Cornerstone Pumping Station.

Primewater Dasmariñas branch manager Roldan Panganiban said these projects aim to ensure their customers have sufficient water supply amid the pandemic.

"We at PrimeWater Dasmariñas will continue doing our best to stay true to our commitment to deliver better water supply and service to our customers," he said.

Niel Bautista, PrimeWater Cavite Head of Operations, said the projects were made possible by their joint ventures with local water districts.

"These collaborations will be one of the many projects and programs to ensure a better and more efficient service when it comes to water supply," he said.

leader that I respected. Despite our differences, I admired his courage and vision to serve our people. We set aside those differences in order to work together in 2013 so we can build a better nation for our people.

But personally, and more significantly, I admired him greatly when he came and visited the wake of my mother in 2015. At a time of profound sadness and grief, he offered kind words of comfort, perhaps drawing from his own experience when his mother, former President Corazon Aquino died.

It is the same words of comfort that we offer to his loved ones who are grieving and to a grateful nation mourning the loss of a Filipino who served his country well.

Fast-track vaccines to provinces << P1

units (LGUs) the needed vaccines to achieve population protection in every region.

Galvez made the statement in response to reports that some LGUs outside the National Capital Region, Metro Cebu, Metro Davao, Bulacan, Batangas, Cavite, Laguna, Pampanga and Rizal are complaining about the limited number of vaccine doses deployed in their areas.

He said the National Vaccination Operations Center maintains a dashboard to monitor vaccine deployment and usage of LGUs. Galvez said vaccine supplies are monitored on a daily basis to ensure that the LGUs that run out of vaccines would be given priority in the next batch of deployment.

"Our goal to contain the disease and protect the most vulnerable individuals and communities is still the same," he said.

Galvez said more than three million vaccine doses are arriving this June: 1.5 million doses of Sinovac, 250,000 doses of Moderna and more than two million

doses of AstraZeneca. He said these vaccines would be distributed to identified provinces and LGUs nationwide that are running low on

Meanwhile, the Department of the Interior and Local Government (DILG) ordered LGUs to prepare for the arrival of 40 million doses of Pfizer-BioNTech vaccines.

Interior Secretary Eduardo Año reminded local chief executives to undertake the necessary preparations given the vaccine's fragile nature, which needs to be secured in cold storage facilities with -80 to -60 degrees Centigrade to ensure the jabs would not spoil.

"I call on LGUs to start their preparations to be able to properly receive these vaccines," Año said. "Time is of the essence and we must do our duty to safely bring the vaccines to the people."

Año echoed the call of vaccine czar Galvez to LGUs to ensure the presence of third-party logistics and cold chain service providers.

Pfizer vaccines will be delivered in bulk starting
