The Social Security System (SSS) is now ready to accept online applications for the unemployment benefit from members who were involuntarily separated from work due to the huge impact of coronavirus disease 2019 (COVID-19) pandemic.

SSS President and Chief Executive Officer Aurora C. Ignacio said, "Job loss in times of global health crisis is one of the worst-case scenar-



ios that we wish would never happen. However, as a pension fund, we have to anticipate these kinds of contingencies by allocating funds and providing our members with safer, faster, and more convenient means of filing benefit claims and receiving their cash benefits."



# LGUs receive Php 140.1M ER 1-94 funds from **AboitizPower and DOE**

Brgy. San Pedro, Sto. Tomas City, one of the host communities of APRI-MakBan, utilizes their ER 1-94 funds for the decontamination of the supermarket and other public areas.

AboitizPower and the Department of Energy (DOE) recently turned over around Php 140.1 million worth of Energy Regulations 1-94 (ER 1-94) funds to some 36 host beneficiaries of AboitizPower business units AP Renewables, Inc. (APRI) and San Carlos Sun Power, Inc. (SacaSun).

The initial remittance is part of the total Php 351.6 million ER 1-94 funds generated by AboitizPower's geothermal and solar facilities. The remaining funds are still being processed and will likewise be turned over to the host beneficiaries as soon as available. The host beneficiaries of APRI and SacaSun include 24 barangays, three municipalities, and two cities in the provinces of Albay, Batangas, Laguna, and Negros Occidental. Regions IV-A, V, and VI, through the Regional Development Council (RDC), will also be given shares that they can allocate to their chosen non-host local government units (LGUs) of APRI and SacaSun within their respective re-

ER 1-94 is a program that gives benefit to host communities through the one centavo per kilowatt-hour (PHP 0.01/ kWh) share in the total electricity sales of a power generating facility located within their locality. The new DOE Circular No. DC2020-04-00080 mandates that the funds can now be utilized for COVID-19 response efforts, in support of the Bayanihan to Heal as One Act.

COVID-19 response initiatives that were so far implemented by the said LGUs include holding areas or distribution centers, medical and PPE supplies, facility decontamination, and relief goods to feed low-income households during this prolonged quarantine period.

The said funding can also be utilized for mass testing,



subsidy programs (non-food items), mobile market to ensure uninterrupted availability of essential goods, construction of quarantine centers, provision of cremation and burial services, electricity cost subsidies to newly constructed health facilities, and all other reasonable means or measure to mitigate, contain, and eliminate the transmission of COVID-19.

AboitizPower Geothermal and Solar Business Units Pres-

ident and Chief Operating Officer Dennis B. Jordan said, "We don't know how long this crisis will last. I see the accrued ER 1-94 fund as a blessing. This is God's provision that our host communities can tap and utilize at this very difficult moment in our nation's history. May they be able to use this resource to help contain, mitigate, and eventually eliminate the spread of COVID-19 in their respective areas."

bahays and overseas Filipino worker (OFW) members, must have paid at least 36 monthly SSS contributions, wherein 12 months of it should have been paid within the last 18 months before the month of involuntary separation. Reasons for involuntary separation should be due to retrenchment/downsizing, closure or cessation of business operations, and other reasons brought about by the coronavirus disease (CoVID-19) pandemic.

Furthermore, the member must not be more than 60 years old at the time of involuntary separation, except for underground and surface mineworkers, and racehorse jockeys whose age should not be more than 50 and 55 years old, respectively.

Before the online application of unemployment benefit, members should have their own My.SSS account through registration at the SSS Website. Contact details, especially the mobile number, should also be registered in My.SSS account in case the member opted to receive their benefits through remittance centers. Disbursement accounts should also be enrolled in the respective My.SSS accounts through Bank Enrollment Module (BEM).

To submit their benefit application online, members should log in to My.SSS account and click "apply for unemployment benefit claim" under the E-Services tab. Provide all the pertinent information such as the active savings account enrolled through the Bank Enrollment Module (BEM), employment category, date of involuntary separation, the reason for involuntary separation, and the employer's name where the member was separated.

Members should read the certification carefully before clicking the "Submit" box to agree and proceed with the application. SSS will send a notification through email.

Members should reply by attaching the scanned images of the certification issued by the Department of Labor and Employment (DOLE) or by the Philippine Overseas Labor Office (POLO), together with the Notice of Termination from the Employer or Affidavit of Termination from Employment, whichever is applicable. SSS will once again send a notice through email regarding their unemployment benefit application.

"We would like to remind our members to double-check the encoded details before submitting their application to avoid any inconvenience brought by any erroneous entry such as bank account number and contact details. Also, secure your email and text notifications for future reference," added Ignacio.

Unemployment benefit will be released through various SSS payment channels such as Unified Multi-purpose Identification (UMID) Card enrolled as ATM card, bank account in PESONet participating banks, electronic wallet (e.g., Paymaya), and remittance transfer companies/cash payout outlets (e.g., DBP Cash Padala thru MLhuiller).

Unemployment benefit can only be availed once every three years, starting from the date of involuntary separation from work. SSS

shall only pay the highest benefit from the recorded contingencies if two or more compensable contingencies occurred within the same period.

As of May 2020, more than 900 members already availed of the unemployment benefits during the community quarantine from March 16 to May 31, with total disbursement amounting to P11.76 million.

"This is part of the SSS' assistance package that intends to provide financial assistance to members and pensioners affected by the health crisis brought by COVID-19. We hope that our displaced members will immediately get a new job so that they can financially support themselves and their families," Ignacio concluded.

will potentially cause irreparable damage to the Las Pinas-Parañaque Wetland Park. The project will be building on the buffer zone of this protected area and will destroy the landscape in which the wetland now thrives," Villar said.

The senator said that under Republic Act 11038,the Expanded National Integrated Protected Areas System (E-NIPAS) Act, which she sponsored, the 175-hectare wetland park was a declared protected area.

It was also recognized as one of the seven areas in the country listed as a Wetland of International Importance by the Ramsar Convention "because of its critical role in the survival of threatened, restricted-range, and congregatory bird species," she said.

Villar also warned about "massive flooding" as she recalled the Department of Public Works and Highways saying that reclamation in this part of Manila Bay will cause flooding as high as eight meters in Las Piñas 13 agencies and private enti-City. She added that if the reclamation project pushes through, the flood-control projects in Bacoor and Imus worth P1.47 billion will be

Villar said flooding was one of the grounds that she, along with 315,000 residents of Las Piñas City, Parañaque City, and Cavite, cited when they petitioned for Writ of Kalikasan against the planned reclamation of Manila Bay in 2012.

In 2017, the DENR cancelled the ECC issued to a similar reclamation plan in Parañaque and Las Piñas coastal bay for its potential harm to the environment.

Villar said the DENR's approval of the Bacoor reclamation project also contradicts the government's P1.3-billion Manila Bay rehabilitation project.

In January, 2019, the "Battle for Manila Bay" was launched to reinforce the Supreme Court's December, 2008, mandamus directing ties to clean up, rehabilitate, preserve, restore, and maintain the waters of Manila Bay to a level that is fit for swimming, skin-diving, and other forms of contact-recreation.

This was the basis of the creation of the Manila Bay Task Force the following month.

"If we allow reclamation to proceed in Manila Bay, what happens now to our rehabilitation efforts? Our government has already poured precious resources into this campaign and many have already sacrificed to comply. Are we now losing the battle for Manila Bay?" Villar

The DENR recently granted the ECC to the Bacoor Reclamation and Development Project, after Bacoor City Mayor Lani Mercado-Revilla, the project's main proponent, satisfied the requirements of the DENR's Environmental Impact Assessment (EIS) Review Committee. With

the ECC, the proponents are given the go-signal to start dredging activity, filling the project area with reclamation materials and construction of road networks and drainage system.

"With the issuance of the ECC, you are expected to fully implement the measures presented in the EIS intended to protect and mitigate the project's predicted adverse impact on community health, welfare, and the environment. Environmental considerations shall be incorporated in all phases and aspects of the project," the ECC stated.

Militant fishers' group Pambansang Lakas ng Kilusang Mamamalakaya ng Pilipinas (PAMALAKAYA) also opposed the project, fearing that more than 700 fishing and coastal families will be ejected from their houses to give way to the project.

President Duterte has been consistent in his stance against any reclamation projects at the Manila Bay.

#### **Noveleta installs** free WiFi for all

NOVELETA, Cavite: Mayor Dino Reyes Chua has embarked on installing free Wi-Fi connection for the 16 villages of the town in preparation for the electronic learning of students of the municipality. Chua told The Manila Times that a dry run for the town's free Wi-Fi started at the Noveleta Town Plaza on Tuesday. He noted that the municipal government targets to install free internet connection at seven public elementary schools, as well as junior and senior high schools in Barangay San Rafael so that public and private schools could comply with the new digital learning method, ensuring safety from the coronavirus disease.

Meanwhile, some parents of public school students lamented their lack of electronic gadgets, personal computers and even smartphones to conform to this new educational shift to digital. Chua has not commented on what can be done regarding the lack of such electronic devices required in the conduct of digital learning. The Noveleta Central Elementary School in San Rafael 2, Ambrocio S. Robles Memorial Elementary School in San Juan 2. San Antonio Elementary School. General Luciano Sa Miguel Elementary School in Poblacion, Salcedo Elementary School, Pacifioc Q. Aquino Elementary School in San Rafael 3 San Juan Flementary School Noveleta National High School and Noveleta Senior High School are still accepting students through online enrollment. In addition to online learning, government radio and television will also be used to conduct classes in spite of the coronavirus pandemic.

The local chief executives officiated the civil wedding ceremony in their offices with the brides all dressed in white while everyone wearing face masks and observing physical distancing in compliance with health protocols.

"While there was a little bit of slowdown as clients assessed their requirements and approach during this uncertain time, we are now seeing positive indicators for strong growth in the balance of the year," he said.

Demand from e-commerce and online streaming industries has also been growing.

He said that the company is seeing growth in the shared services sector, which includes human resources, scheduling and planning, and accounts receivable and payable in finance and accounting. Analytics, he said, will also translate to opportunities in Philippine outsourcing in the next few years.

Industry stakeholders had said that Philippine outsourcing may lose contracts as larger global companies try to diversify their location strategies to reduce disrupted operations, especially as other outsourcing destinations may have stronger Internet connectivity for work-fromhome measures. But Mr. Lytle said that this option is limited to companies that can afford it. "There will certainly be some clients who look to diversify their approach to improve resiliency and business continuity by balancing their requirements across multiple countries. However the increased complexity and cost of operation will limit others," he said. "We expect this will not be a major impact to the Philippines overall IT-BPM (Information Technology and Business Process Management) outlook." In his post, the governor cited the prediction of Dr. Charles Yu, a member of the medical team at the De La Salle Medical-Health Science Institute (DLSM-HSI) that the number of COVID-19 cases in the province will blow after two weeks from June 1, 2020 when NCR was placed to GCQ status. Governor Remulla reminded it is okay to drink within the confines of their homes but once outside, the law is in effect. "You can have fun but don't be a danger to others," Gov. Jonvic said. #### **Mendez-Nuñez in Cavite** tighten security after 3 new COVID-19 cases

MENDEZ-NUÑEZ, Cavite - The municipal government is implementing stricter community quarantine measures after recording three new confirmed cases of coronavirus disease (COVID-19) over the weekend.

Starting today, June 23, checkpoints will be set up in every barangay and only quarantine pass holders and those reporting to work will be allowed to leave their homes.

Non-residents are likewise prohibited from entering the municipality except for work purposes or emergencies. Curfew hours starts at 8 p.m. to 5 a.m.

Over the weekend, the municipal government announced three new cases of COVID-19. All are asymptomatic and are currently in an isolation facility.

Patients 3 and 4 were tested by their respective companies. Patient 5, on the other hand, underwent a COVID-19 test as a requirement to return to his work as a seaman.

Contract tracing efforts are underway and their respective households have been placed on lockdown.

Prior to the three new cases, the municipality only had two previous cases of COVID-19, both of whom already recovered from the disease.
