



## PBBM OKs laws on new Bacoor schools, engineering offices in provinces

President Ferdinand R. Marcos Jr. has signed into law several measures seeking to establish new schools in Bacoor City, Cavite and district engineering offices of the Department of Public Works and Highways (DPWH) in various provinces.

Marcos signed Republic Act (RA) 12007 and 12008 on June 13, establishing a senior high school and an elementary school in Bacoor City, Cavite, the Presidential Communications Office (PCO) said in a news release Tuesday.

RA 12007 establishes the "Progressive Senior High School" in Progressive Village 3, Barangay Bayanan, while RA 12008 creates the "Progressive Elementary

School" in Barangay Molino

The PCO said Vice President and Education Secretary Sara Duterte was tasked to immediately include in the department's program the operationalization of the new senior high and elementary schools, as well as to formulate the implementing rules and regulations (IRR) of the two laws within 90 days from its approval.

In a separate new release, the PCO said the President signed RA 11998 on June 7, creating the Bukidnon 4th District Engineering Office to be located in the city of Valencia to serve the city and the municipalities of Pangantucan and Kalilangan.

Approved by Marcos on

June 13 was RA 12002, creating the Negros Occidental 5th District Engineering Office located in the City of San Carlos. It will serve the cities of Escalante and San Carlos, and the municipalities of Toboso, Calatrava, and Salvador Benedicto.

RA 12003 and 12004 were also signed on June 13, creating the Bataan 3rd District Engineering Office and the Bulacan 3rd District Engineering Office. The Bataan engineering office, to be located in Bagac, Bataan, will serve the towns of Bagac, Dinalupihan, Mariveles, and Morong. The Bulacan office, on the other hand, will be located in the municipality of San Rafael and will serve the municipalities of San Rafael,



Dona Remedios Trinidad, San Miguel, and San Ildefonso. Lastly, the President signed RA 12005, establishing the Iloilo 6th District towns of Badiangan, Cabat-Engineering Office, which will be located in the municipality of Pototan, serving the Pototan. (PNA)

### **DOJ** vows to intensify war against human trafficking

Department of Justice Secretary Jesus Crispin "Boying" Remulla on Monday vowed to intensify the department's fight against human traffickers, particularly those targeting minors.

DOJ has filed multiple criminal charges before the Calamba, Laguna Regional Trial Court (RTC) against a sex peddler offering young boys to foreigners through online platforms for live sex or explicit photos and videos in exchange for money.

In a news release, Remulla said the DOJ Task Force on Women and Children and Against Trafficking in Persons (TF-WCATIP) found probable cause to indict suspect Jhon Patrick Carmona for qualified trafficking in persons under Republic Act (RA) 9208 or the Anti-Trafficking in Persons Act of 2003, as further amended by RA No. 11862 or the Expanded Anti-Trafficking in Persons Act of 2022.

He said the National Bureau of Investigation-Human Trafficking Division (NBI-HTRAD) received a tip from the Feder-



al Bureau of Investigation (FBI) about the distribution of Child Sexual Abuse and Exploitation Materials (CSAEM) by Carmona.

The NBI-AHTRAD discovered an X account allegedly used by the suspect to market young boys to foreigners. Through undercover operations, a series of communications was established with Carmona, who solicited payment in exchange for lewd materials involving minors. Subsequently, Carmona offered to arrange a meeting with an undercover agent, during which, he offered three young boys for sexual services. A rescue operation was then prepared where the minors were rescued and led to the arrest of Carmona. He was charged with three counts of Qualified Trafficking under Sec 4(a) in relation to Sec 6(a) (minority of the victims); and one count of Qualified Trafficking under Sec 4(a) in relation to Sec 6(c) in large scale, considering that the crime was committed against three or more persons. Meanwhile, the complaint for violation of RA No. 11930 (Online Sexual Abuse or Exploitation for Children (OSAEC) and Child Sexual Abuse or Exploitation Materials (CSAEM) was referred for further preliminary investigation. The Task Force recommended no bail for each of the charges. "We will never stop nor slow down our campaign against human traffickers until every single one of them falls in the hands of justice," Remulla said. "The government is determined more than ever to eliminate elements who continue to prey on the vulnerable sector of society-children and women, the most. Let us build a safe and healthy environment where the young are protected," he added. (PNA)
