Bunduquin would be the second radio blocktimer killed since October 2022, with the death of Percival 'Percy Lapid' Mabasa. Absent of evidence to the contrary, his death is now deemed 'work-related' to facilitate the investigation. We commend the Philippine National Police under Director General Benjamin Acorda, the PRO4-B under RD P/ BGen. Joel Doria for the immediate operationalization of the existing mechanism agreed between the PTFoMS

and the PNP for such an incident thru the creation of SITG Bunduquin headed by Mindoro Oriental PD P/ Col. Samuel Delorino. We also commend the Presidential Anti-Organized Crime Commission under Executive Director Gilbert Cruz, for assuring full support to the PTFoMS in solving this dastardly act at the soonest time possible. While the driver of the motorcycle had already been neutralized, the actual gunman remains at large and is now the subject of a police manhunt. In this regard, thru the help of a civic-minded individual who declined to be named, the PTFoMS is offering a reward of P50,000 for any information leading to the suspect's immediate arrest. As this is an ongoing investigation, we urge our media colleagues not to engage in any speculation but to instead contribute to its immediate resolution by providing us with positive and verifiable information. unidentified suspects riding in tandem in Barangay Canubing I around 4:20 am. Bundoquin died on the spot.

"We express our profound sympathy and solidarity with the family, friends, and colleagues of Cresenciano Aldovino Bundoquin, a dedicated and professional journalist who was brutally murdered," the PAPER.Ph statement said.

PAPER.Ph National President Louie Angeles said that the killing of journalists should stop.

"We have lost a lot of respectable journalists through killings with impunity over the years and this has to stop," said Angeles, who is also a broadcast journalist.

The media group also urged journalists to join forces to uphold press freedom.

"We also encourage media professionals, journalist organizations, and the public to stand together in combating violence and violations against press freedom. We uphold a society that values and upholds freedom of the press and respects the truth-seekers."

According to UNESCO (United Nations Educational, Scientific and Cultural Organization) website, there are 20 journalists killed this year - Bundoquin now becomes the 21st. In 2022, 50% of slain journalists were targeted off-duty while they were at home or in public places.

The journalists were targeted while traveling, in their homes, and in public places. This reflects that media persons are not safe even in private spaces. "After several years of consecutive declines, the steep rise in the number of journalists killed in 2022 is alarming. Authorities must step up their efforts to stop these crimes and ensure their

perpetrators are punished because indifference is a major factor in this climate of violence," UNESCO Director-General Audrey Azoulay said. Among the 86 journos

killed last year, 23 were in conflict zones. Asia and the Pacific registered 16 killings while the deadliest countries were Mexico (19 killed), Ukraine (10), and Haiti (9).

that responders are vaccinated while observing Covid-19 health protocols like donning of gloves and face masks, frequent hand sanitation and distribution of face masks at evacuation centers to both vulnerable and general population. (DOH IV-A)

### CSC urges civil servants to respect the PH flag

In honor of the ongoing National Flag Days, which are observed from May 28 to June 12, Civil Service Commission (CSC) Chairperson Karlo Nograles has called upon civil servants to embrace patriotism by showing unwavering respect for the Philippine flag.

Chairperson Nograles reminded government officials and employees of their sworn oath to adhere to the eight norms of conduct mandated under Republic Act (R.A.) No. 6713, also known as the Code of Conduct and Ethical Standards for Public Officials and Employees. These norms include the principles of "nationalism and patriotism."

"Bilang mga kawani ng gobyerno, ugaliin po nating ipakita ang paggalang sa watawat hindi lang dahil sa ating sinumpaang tungkulin kundi dahil sa marubdob na pagmamahal sa bansa," Chair Nograles said.

Furthermore, Chair Nograles emphasized the importance of complying with the provisions of R.A. No. 8491, commonly referred to as the Flag and Heraldic Code of the Philippines. This law mandates that the flag, anthem, and other national symbols must be revered and respected at all times, as they embody the nation's ideals, traditions, and principles of sovereignty and national solidarity.

The legislation specifies that the flag should be appropriately displayed and raised. Additionally, it outlines the conduct of flag ceremonies during official or civic events, emphasizing the need for a simple and dignified approach. Attendees are expected to stand in attention when the first note of the national anthem is played, placing their right palms over their chests. The National Anthem should be sung correctly, followed by the recitation of the Panunumpa sa Watawat. Moreover, R.A. No. 8491 strictly prohibits mutilating, trampling, or engaging in any act that dishonors or ridicules the flag. It also forbids using the flag as drapery, tablecloth, or covering for various objects, as well as wearing it as a costume or uniform. The law prohibits adding any word, figure, mark, picture, design, drawing, advertisement, or imprint on the flag. It further explicitly forbids printing, painting, or attaching representations of the flag on items such as handkerchiefs, napkins, cushions, and merchandise. "May we always aspire to serve as examples for our stakeholders and fellow Filipinos in the way that we honor the flag not only during flag ceremonies but in and out of the office. Remember that patriotism is not just a requirement for civil servants. It is a virtue that leads to a common goal - national development," stated Chairperson Nograles. Former President Diosdado Macapagal, through Proclamation No. 374, designated May 28 as National Flag Day. This date commemorates the historic occasion in 1898 when the national flag was first raised in Alapan, Imus, Cavite, after the Philippine Revolutionary Army achieved victory in the Battle of Alapan, symbolizing the defeat of the Spanish forces. In 1998, Republic Act No. 6713 modified the previous law, expanding the observance of Flag Days from May 28 to June 12 of each year. During this period, all offices, agencies, and instrumentalities of government, business establishments, learning institutions, and private homes are encouraged to proudly display the Philippine flag. As National Flag Days continue, the CSC hopes that civil servants and citizens alike will demonstrate their deep love for the country by respecting and upholding the dignity of the Philippine flag, thus fostering (CSC / PIA-NCR)

#### ADB to grant US\$4 billion to PH for 2023

The Asian Development Bank (ADB) will grant the Philippines up to US\$4 billion to support the country's socio-economic agenda and other infrastructure development programs for 2023.

"This 2023 alone, we expect to provide up to US\$4 billion to support the government's Socio-Economic Agenda and the Build Better More infrastructure development program," said ADB President Masatsugu Asakawa during the ADB reception at its headquarters in Mandaluyong City on Monday.

This includes the preparation of several transformative projects such as the Bataan-Cavite Interlink Bridge Project, the Davao Public



Transport Modernization Project, and the Integrated Floor Resilience and Adaptation Project.

President Asakawa said the ADB has boosted its financing to the Philippines by fourfold reaching a total of US\$12.7 billion between 2018 and 2022.

In response, President Ferdinand R. Marcos Jr. made a commitment to the ADB saying that the Philippines will hold fast to its responsibilities to the regional financial institution like his father did.

"The Philippines stands to significantly gain from this mutually beneficial relationship with the ADB. We are aware of the responsibilities that this relationship carries with it. But I will re-echo my father's words during the ADB inauguration some 57 years ago: 'We will meet those responsibilities," President Marcos said.

The Chief Executive also promised to ensure that these plans and projects are strictly and timely executed and the loans and other technical assistance granted to the country are used judiciously.

ADB President said the development bank is also fully committed to helping the country in addressing climate change and "it will be a core priority of our assistance going forward."

ADB's annual loan financing for the Philippines averaged US\$1.4 billion from 2010 to 2022.

Within the first nine months of Marcos administration, three loans amounting to US\$1.10 billion were signed with the Bank.

Furthermore, the administration is waiting for the release of the Country Partnership Strategy for 2024-2029.

This clearly explains the Bank's recommended medium-term development agenda for the country, guided by the theme, "Investing in Climate, Filipinos and the Future." It is also consistent with the Philippine Development Plan. (ARB, PIA-CPSD)
