## Sangley International Airport to Break **Ground on 4Q2022**

After a few setbacks, construction on the Sangley International Airport could begin soon. According to Philstar, the groundbreaking will take place in the fourth quarter of 2022. SPIA Development Consortium, a consortium of local and foreign enterprises, presented an unsolicited proposal to develop the Cavite airport in November. The plan was accepted by the provincial government, which issued a certificate of acceptance on January 7.

## U.S. Peace Corps Holds Training to Strengthen Biodiversity Conservation in the Philippines

The U.S. Peace Corps recently held a biodiversity conservation training to help address biodiversity threats in Minalungao National Park in Nueva Ecija and Panaon Island in Southern Leyte. The training, held in Laguna from May 11 to 19, brought together nearly 50 participants from Nueva Ecija University of Science and Technology, Southern Leyte State University, Nueva Ecija's Protected Area Management Board, and Panaon Island local government. The training included specimen sampling and data collection at Taal Lake, Mt. Makiling, and Calatagan, and it also featured lectures from experts on state-of-the-art biodiversity assessment in terrestrial, marine, and inland aquatic environments and GIS mapping. "The aim of this critical workshop was to support academe and government partners in working together to reduce threats to biodiversity in Minalungao National Park and Panaon Island," said U.S. Peace Corps Country Director Jenner Edelman.

While the Philippines is one of the most biodiverse countries in the world, it risks losing its significant biodiversity resources without better conservation efforts to address the growing population, increasing pollution, and the impacts of climate change.

Through this training, participants developed new skills for conducting biodiversity conservation research and were able to craft management plans to address biodiversity threats.

Funded by the United States Agency for International Development, the training was conducted by the University of the Philippines-Los Baños' School of Environmental Science and Management, which is recognized by the Com-

ing the Light, Honoring our Rights, Radiating Pride", the activity served as a platform for unity of various groups to raise awareness on the different HIV programs of the government and civil society organizations geared towards the commitment to the advocacy of eliminating HIV and AIDS-related stigma and discrimination.

this is why I am urging you to complete your vaccine doses, and also ensure that your booster shots are also completed)," he added.

Go's outreach team mounted the relief activity at the Rosario Institute where it gave masks, vitamins and meals to the residents.

The team also gave cellphones, watches, shoes and bicycles to select individuals.

To further help the residents recover from the pandemic and sustain their daily needs, a team from the Department of Social Welfare and Development extended financial aid through its Assistance to Individuals in Crisis Situation program.

As chairman of the Senate Committee on Health and Demography, Go assured the public that medical assistance programs by the

government are conveniently accessible through the Malasakit Centers.

Go initiated the Malasakit Centers program in 2018 after personally witnessing the struggles of poor and indigent patients to get the medical attention they need because they cannot afford expensive medical services.

The Malasakit Centers in the province are located at Southern Tagalog Regional Hospital in Bacoor City and General Emilio Aguinaldo Memorial Hospital in Trece Martires City.

There are currently 151 Malasakit Centers nationwide.

Go is the principal author and sponsor of the Malasakit Centers Act.

As vice chairman of the Senate Committee on Fi-

nance and an adopted son of Calabarzon, he has also supported various road improvements in the cities of Cavite, Dasmariñas, General Trias, Imus and Tagaytay; rehabilitation of covered courts in various villages in General Trias City; acquisition of ambulances in Indang and Trece Martires City; rehabilitation and improvement of the municipal fire station in Noveleta; and improvement of a sports facility in Cavite State University in Indang.

In his message, the senator commended local officials of Rosario for intensifying their pandemic efforts in the town.

The senator's team provided similar assistance to 300 indigents in Dasmariñas City and Noveleta, Cavite, on May 1.

dent Leni Robredo, though the Cavite lawmaker had denied that was what he did. Red-tagging is the act of linking people to armed communist rebels, but there is no law against it.

"I always think that I would like to recommend an amnesty of sorts, that would put the left and right back to the groove, into the normal life, so they can resume their lives as normal filipinos," Remulla said in a Rappler Talk interview on Tuesday, May 31.

When asked about the potential conditions for the amnesty grant, Remulla said this will be subject to study.

"I don't know, we have to study that, but that is an idea that has come to me and it's very important, it's part of the unity statement of the President, left and right, everybody who's now in court, being charged, hiding, all can be covered by amnesty," Remulla said.

Edre Olalia, president of the National Union of Peoples' Lawyers (NUPL) which had served as counsel for the charged activists and as legal consultants for the peace talks, said any openness is welcome but that "the devil is in the details."

"Any openness to amnesty, in principle, is welcome, but the devil is in the details of course. The question is, what alleged acts are covered, what is the scope, what is the timeline, what is the procedure," Olalia told Rappler in a phone interview on Wednesday, June 1.

Olalia said that there's already a draft unconditional and omnibus amnesty that was raised during the peace talks with communist rebels. Peace talks with the National Democratic Front, the political wing of the Communist Party of the Philippines, under President Rodrigo Duterte ended in November 2017 after a brief honeymoon period

An ideal amnesty, at least according to that draft, would cover all political prisoners and all their crimes and alleged charges, including common crimes. This would be tricky, and would again test the political offense doctring

One example is former communist leader Rodolfo Salas who already struck an agreement with the government to be cleared of a rebellion case, but was arrested in 2020 over an old murder case. The discussion in the Supreme Court was: Does the political offense doctrine mean the agreement for rebellion also covers murder since the latter was allegedly committed in furtherance of the political cause?

Olalia also took note that even with Remulla's openness to grant amnesty, the incoming justice chief's view on red-tagging remained the same.

"It seems incompatible but I think with his openness, we can pursue amnesty without viewing his stance on red-tagging as [an] insurmountable obstacle," said Olalia, adding that they hope Remulla "doesn't dangle amnesty." When Rappler asked if the condition to the amnesty grant would be to stop expressing dissent, Remulla said: "Hindi naman (Not really). There's nothing criminal about dissent, so what's the point?"

Remulla's predecessor, outgoing Justice Secretary Menardo Guevarra, backed the passage of a law that would criminalize red-tagging.

Asked about the proposed law, Remulla said: "I don't know, I have to study that, I cannot commit to that, nor will I oppose it immediately. I will have to study the provisions of that law, and I will not call it red-tagging."

"Red-tagging favors one party, it goes against [the] Philippine government, I will not allow that," said Remulla.

The Duterte government launched a full-scale crackdown on activists, rearresting those freed during the peace talks, and arresting dozens on the powers of search warrants which were later voided by courts. There were

red-tagged activists who had been killed.

Reminded of the seven activists killed in the Bloody Sunday massacre in Calabarzon in 2021 while state agents were executing search warrants, Remulla said: "Hindi siya dapat pinatay, dapat dinala siya sa korte, 'yun ang akin eh. 'Yun ang maling-maling style. If you have the evidence, present them in court. 'Wag natin isho-shortcut. I don't believe in that"

(They shouldn't have been killed, they should have been taken to court, that's what I think. That's a very wrong style. If you have evidence, present them in court. Let's not do shortcuts. I don't believe in that.)

The DOJ under Guevarra filed murder charges against the state agents involved in the killing of one of the Bloody Sunday victims, Cavite labor leader Manny Asuncion. Others are pending in the Administrative Order 35 panel, a special committee focused on extrajudicial killings and other politically-motivated harassments. (READ: 'Deliberate intent to kill': 17 cops face murder for 2 Bloody Sunday killings) Remulla said he would continue the AO 35 panel. "Tuloy, eh siyempre kailangan 'yung nasimulan. Ang tawag diyan institutional continuity," said Remulla.

allowing them to directly negotiate the joint venture's final terms and conditions with the local government. The OPS also allows them to match other groups' bids and win the project through a Swiss challenge, which is a necessary competitive bidding process.

SPIA will be developed in three phases by the consortium: Phase 1A will cost \$2.3 billion, Phase 1B will cost \$2 billion, and Phase 2 will cost \$6.6 billion. The group will begin construction of the 4.6-kilometer connecting road from CAVITEX's Kawit Interchange to Sangley after the planning, design, and financial close are completed. The highway is expected to take two years to complete.

The Yuchengco Group of Corporations, Cavitex Holdings Inc., managed by tycoon Luis Virata, and Lucio Tan's MacroAsia Corp. are among the local companies collaborating in the SPIA Development Consortium. The final one will be in charge of the venture's aviation assistance and logistics. Samsung C&T Corp. of South Korea, Munich Airport Multinational GmbH, and Arup Group, a London-based design and engineering business, are among the international companies collaborating in the partner-

The Petronas Twin Towers in Kuala Lumpur, the Burj Khalifa in Dubai, Terminal 1 of Incheon International Airport, and the Changi International Airport extension are all examples of Samsung C&T's engineering and construction work. Munich Airport International GmbH is the management services branch of Munich Airport, Europe's only five-star airport. MacroAsia Corp. and China Communications Co., a Filipino-Chinese collaboration, formed in 2019, The SPIA project has already been awarded to CCCC. However, due to criteria issues, the transaction was canceled in January 2021. After that, the local government went on the hunt for a new joint partner.

The province declared failure of bidding in October after receiving no proposals for the project. The SPIA Development Consortium filed a proposal in November 2021.

and social justice should be achieved to end the disease.

The risk and cases of HIV and AIDS are continuously increasing and the stigma and discrimination to the infected ones are continuously circulating. Human Immunodeficiency Virus is an infection that has no cure and can lead to the condition of AIDS or acquired immunodeficiency syndrome. Acquiring this can be a threat to one's life hence spreading awareness about the virus can save lives.

As HIV affects proportion of LGBTQIA community, stigma and discrimination are developing and growing which leads to the vulnerability of the group. This is one of the reasons why most of the infected individuals, not just from LGBTQIA community, are having a hard time seeking help and accessing services for HIV and AIDS. Mr. Penabella mentioned "undetectable equals untransmittable" which means that if a person living with HIV is on a regular treatment and therapy and has reached the undetectable levels, HIV cannot be transmitted to their partners. Therefore, every HIV patient should be encouraged and supported in getting HIV treatments, care, and services.

This year's theme is not only about remembering the people who have lost their battle against HIV and AIDS but also honoring those who committed their lives to help the people affected by the disease and giving awareness to the public about it to create an intricate response and have

a non-discriminatory environment.

Dr. Ana Maureen Villamar, HIV/AIDS Core Team (HACT) Physician said, "Aside from commemorating our loved ones, friend or someone who are acquainted to us who died because of HIV and AIDS, the ones who are survivors should also keep the light and guide other Filipinos that they would be able to survive AIDS and HIV as well. We should honor our rights because it is our right to live healthy and always radiate with pride, that we are always proud of ourselves, we keep our values and practice our responsibility as citizens and HIV advocates and enlighten everybody with the disease".

Mr. Terrenze Angam, Case Manager of SAIL Clinic, pointed out the preventions and treatments for HIV and AIDS including abstinence or no sexual intercourse, being faithful to your partner, using condoms, drug avoidance, having enough knowledge about the disease, and the pre-exposure prophylaxis. Subsequently, a testimony of a HIV survivor and advocate was shared.

Thereafter, Mr. Gerry Obibe and Ms. Tracy Suarez led the prayer for candle lighting ceremony with a red ribbon that symbolizes the battle against HIV and

In closing, HIV Program Coordinator Haydelisa Maderaso expressed gratitude to the attendees and mentioned the upcoming World AIDS day to be held on December 2022.---PICAD
