#### SSS adopts a flexible work arrangement in its Main, Makati offices

The Social Security System (SSS) announced that all its branch offices nationwide will remain open and operate on regular business hours to accommodate its members, pensioners, and claimants as the SSS implements a flexible work arrangement starting on Monday, June 3, 2024, to help mitigate traffic congestions especially in Metro Manila.

# SSS adopts a flexible work << P1

City will be working from home on Mondays and will be working in the office very Tuesdays to Fridays.

"Meanwhile, SSS employees reporting in our corporate office in Makati will be working in the office every Mondays to Thursdays and will be working from home on Fridays," Macasaet said.

However, Macasaet emphasized that the business operations of our 254 SSS branch offices nationwide will not be hampered by the modified work schedule.

"We want to notify everyone that SSS branch offices nationwide including our SSS Diliman Branch in Quezon City will continue to be open everyday and they will follow their normal operations, ensuring the seamless delivery of services to our members, pensioners and their beneficiaries," Macasaet said.

SSS Executive Vice President Voltaire P. Agas said all branch offices will be open from 8:00 a.m. until 5:00 p.m. from Monday to Friday, while selected SSS offices in the malls will start their operations from 9:00 a.m. until 6:00 p.m. from Monday to Saturday.

"All our branch offices will continue to accept various SSS transactions, including tellering services in SSS offices with tellering facility," Agas said.

Further, Agas said that SSS members and claimants are encouraged to take advantage of our 24/7 online transaction services through the My.SSS Portal, such as filing of benefit claim and loan applications.

"Members conveniently pay their monthly contributions and loan amortizations the counter and online through SSS-accredited bank and non-bank collecting partners. These alternative methods ensure that our services remain accessible

and uninterrupted," he noted.

Earlier, Finance Secretary Ralph G. Recto, who is also the Chairperson of the Social Security Commission, announced that the Department of Finance (DOF) adopted a four-day workweek schedule starting this May to lessen the burden of DOF employees

from going through the heavy traffic congestion in the National Capital Region.

Also, to help ease the intense traffic flow, the local government units (LGUs) in Metro Manila adjusted the work schedule of its employees to 7 a.m. to 4 p.m. from the usual 8 a.m. to 5 p.m. schedule.

# MWSS-RO investigates Maynilad's poor water quality

The Metropolitan Waterworks and Sewerage System-Regulatory Office (MWSS-RO) on Monday said it is investigating the undrinkable water quality from Maynilad.

The investigation followed Maynilad's water service interruptions and advice to customers in the southern areas of its concessionaire that the quality of water being treated from Laguna Lake is temporarily non-potable due to the transition from summer to the rainy season.

In a Zoom interview, MWSS RO chief regulator Atty. Patrick Ty said Maynilad should have been ready considering that the shift in weather was seasonal.

"This happens every year. So, they should have been prepared for this. So, we want to know why they are not able to provide the proper service to their customers," he said.

"That's part of the service obligations of Maynilad that they should provide potable water 24/7. They are not just required to provide water, they are required to provide potable water," he stressed.

Maynilad spokesperson Jen Rufo, meanwhile, explained the water quality in Laguna Lake exceeded the parameters of their treatment capabilities due to higher salinity or salt content. This caused longer water service interruptions prompting Maynilad to request for more relaxed parameters, including the relaxation of reverse osmosis that removes salt content

"Pinayagan lang namin na lumagpas for now para lang ma-increase natin iyong water production. Kasi baka mas kailangan din ng customers na kahit papaano may tubig sila, kaysa wala talaga (We just allowed it for now to increase our water production. Because maybe the customers need to at least have access to water, instead of having none at all)," Rufo

"Nabawasan iyong produksyon para mapanatili iyong (The production declined just to maintain the) drinking water qualities ng water. But if we keep doing that, strict compliance, sobrang kaunti iyong nailalabas ng planta na supply, kaya humahaba iyong (the supply released by the plant is very minimal that's why) service interruptions (are prolonged),"

Except for drinking and cooking, Rufo said the water quality is safe for general sanitation since it is "not far from the accepted standard."

"Safe for hygiene purposes. So, pwede siyang ipanglinis, pwede siyang ipangligo maliban na lang siguro kung sensitive ang balat mo o may sakit ka sa balat (it can be used for cleaning, for bathing, except for those with sensitive skin or with

skin diseases)," she said. The MWSS, meanwhile assured the public they are on top of the situation and they are in close coordination with Maynilad to ensure speedy repair and normalization of their operations.

"Maynilad is required to fix the problem within three days. Beyond three days we can impose financial penalties already... We are warning to fast track it. That's why it was converted to, it was shortened to three days. So, they are required to fix things as soon as possible in order not to affect public health," Ty said. Based on the revised concessionaire agreements, Maynilad needs to resolve the matter within three days instead of the previous 15-day period.

To date, deployed water tankers are distributing potable water in affected areas including Las Piñas, Muntinlupa, and Parañaque in Metro Manila, and Bacoor, and Imus in Cavite.

4PH project in Barangay Malagasang 1-G last May 28.

The project is composed of mid-rise condominium buildings and will be developed by PH1 World Developers (PH1WD) – Megawide's real estate arm.

A five-tower mid-rise residential community with 1,100 units is set to rise inside a 1.7-hectare property. It will be located at the center of one of Cavite's districts, 400 meters from the New Imus City Hall.
