As the country celebrates National Women's Month, Deputy Speaker and Las Piñas City Rep. Camille Villar called anew for the passage of a measure that seeks to improve maternal and newborn care and provide maximum safeguards to Filipino mothers at the time of their child-births.

Villar's House Bill 5684 or An Act Safeguarding the Health of Filipino Mothers at the Time of Their Childbirth aims to reduce maternal deaths by providing birthing facilities for every barangay in the country. "It

is only imperative that the government give priority to pregnant mothers and their newborn, especially the underprivileged women, to help reduce their risk and somewhat ease the difficulty of their childbirth," Villar said in a statement Wednesday.

"We have an important duty to protect the lives of mothers and the unborn and we seek to provide comprehensive childbirth services to them to address maternal or neonatal problems," she

In pushing for the passage of the measure, Villar pointed out that reducing maternal deaths forms part of the Sustainable Development Goals, but available data indicated that the number of women dying from childbirth is actually increas-

Records from the Philippine Statistics Authority showed that maternal deaths increased to 1,616 in 2018 compared with 1,484 in 2017.

Region 4-A composed of Cavite, Laguna, Batangas, Rizal and Quezon or Calabarzon recorded the highest number of maternal deaths with 245 cases, or a 10.36-percent increase from 222 cases in 2017.

Region 7 (Central Visayas composed of Cebu, Bohol, Negros Oriental and Siquijor provinces) registered 230 maternal deaths while National Capital Region or Metro Manila had 195 deaths for the same period. If enacted into law, HB 5684 mandates that "no maternity hospital, clinic, health center, lying-in, midwifery facilities or similar center, public or private, shall deny or refuse to assist, admit or entry of a mother at the time of childbirth."

These facilities or centers shall also ensure the highest safety mechanism to prevent child switching, child trafficking or the commission of any crime that may lead to the endangering of the lives of both mother and child.

The measure also requires local government units (LGUs) to upgrade and improve devolved health services and medical facilities to provide adequate and quality emergency obstetric care.

It likewise provides that every barangay in the country should have a birthing facility to help reduce the risk of maternal and infant

Local health clinics, health offices and satellite offices of the Department of Health (DOH) are "encouraged" to provide 24-hour assistance to Filipino mothers.

The measure further empowers LGUs to formulate programs that would promote the increase in salaries and incentives of health

The DOH, in coordination with the Professional Regulation Commission and the relevant organization of midwives shall further professionalize the practice of

midwifery in the country Pinning of Advocacy Button and empower them to be key health care professionals in providing care to mothers and newborns.

PA spokesperson Col. Xerxes Trinidad, in a statement Wednesday, said the virtual kick-off activity took place at Army headquarters in Fort Bonifacio, Metro Ma-

"Offices from different Army units nationwide participated in the activity and conducted a simultaneous led by the OAGAD chief Col. Lourdes O. Guevarra," he added.

Trinidad said the OAG-AD chief also gave updates on the upcoming Women's Month Celebration activities which will empower the female Army personnel to be agents of change to promote gender equality and empowerment in the organization.

"The event's keynote speaker Maj. Gen. Potenciano C. Camba, Chief of Staff, PA highlighted the role of female Army personnel in the transformation and mission accomplishment of the Philippine Army.

VP Sara pushes Filipinas digital << P1

"As we narrow the gender gap to digital accessibility, let us not forget to strengthen our protection mechanisms for Filipinas, including girls, from all kinds of violence committed against them at home, in their workplaces, and online communities," she said in her speech before the Philippine Commission on Women (PCW).

Duterte made the statement amid threats of domestic violence and digital exploitation that prevent women and girls from enjoying online opportunities and

Duterte said the Department of Education (DepEd) has already moved to reduce the existing digital threats.

"The Department of Education is committed to protecting the rights of children in basic education. We have strengthened our child protection mechanism and launched the Learner Telesafe Contact Center national hotline where our learners can report cases of abuse, including online child sexual exploitation," she added.

Duterte also recognized the support of civil society in helping victims of such online dangers.

"Allow me to acknowledge the support of our civil society partners who stead-

fastly provide psychosocial and legal support for victims of child abuse and human trafficking," she said.

Duterte's push for digital inclusivity is in line with the international goal with the United Nations' (UN) theme DigitALL: Innovation and technology for gender

This year, the UN called for global leaders to help realize four digital targets for women and girls which include the removal of all barriers to access the digital world; the education and training of girls in STEM (science, technology, engineering and mathematics); the provision of opportunity for women to create technology that meets their needs; and the elimination of online gender-based violence.

"Today, a persistent gender gap in digital access keeps women from unlocking technology's full potential," the UN said.

"Their underrepresentation in STEM education and careers remains a major barrier to their participation in tech design and governance. And the pervasive threat of online gender-based violence --coupled with a lack of legal recourse-- too often forces them out of the digital spaces they do occupy," it added.

UN data further shows there is a gender gap in internet usage between men and women, reaching as much as 259

Meanwhile, Duterte said that like digital inclusivity, it is also important for teenage mothers to continue their ed-

"DepEd is also making sure that teenage mothers who have dropped out of formal school to take care of their children are provided with a second chance to finish basic education and pursue their dreams through the Alternative Learning System (ALS) or pursue technical skills training through our TESDA (Technical Education and Skills Development Authority) programs," she

Duterte said the DepEd allows teenage mothers to enjoy access to continued education through ALS, open university and even through alternative delivery modes like online classes or mod-

Innovative livelihood Besides the implementation of safety measures for learners against digital exploitation, Duterte also underscored the significance of innovation to the livelihood of women. "I am glad that we have started implementing programs, such as the Innovations for Women Enterprises or iWomen Project which provides technical assistance to women micro-entrepreneurs," she said.

The operation of the Women-Helping-Women: Innovating Social Enterprises (WHWise) Program also equips women groups to improve stability and growth for their chosen social enter-

Moreover, the OVP also launched Wednesday an entrepreneur program for women and members of the lesbian, gay, bisexual, transgender, queer, asexual, intersex, plus (LGBTQAI+) Community in San Pedro,

Duterte, when she served mayor of Davao City, first implemented the "Mag Negosyo 'Ta, Day" in 2016 and eventually institutionalized the program in July

The OVP is preparing for its nationwide launch.It earlier said qualified beneficiaries will be entitled to a grant of PHP20,000 capital.

Beneficiaries shall also undergo business management training for livestock, sari-sari stores, goat dispersal, native chicken and minimeat processing ventures. (PNA)

the commuting public. The PCO said the government prepositioned buses in Pasay City, Marikina City, Caloocan City and Quezon City as early as 4 a.m. Citing reports from the various agencies, PCO said there is "no disruption" except in a handful of routes in Metro Manila.

As of 10 a.m., the PCO said the EDSA Busway Carousel has not been impacted by any transport strike activity, with operations running smoothly with a low passenger volume observed at all stations.

Philippine National Police (PNP) personnel have also facilitated the ferrying of affected passengers from Almar Subdivision in Caloocan going to Quezon City.

Vehicles are likewise being deployed to cater to passengers from Manila to Baclaran, Parañaque City.

As of 7:15 a.m., the EDSA Busway was operating normally with a moderate to a heavy volume of passengers at the southbound from north sector stations, Manila Central University in Caloocan and Roosevelt Avenue, Quezon City.

Authorities guaranteed there are sufficient buses to transport stranded passengers.

100 buses for free rides Ferdinand Speaker Martin Romualdez said the House of Representatives and Malacañang took the joint initiative in providing 100 buses for the free rides to ensure stranded commuters will have available rides going to their work or on the way back home.

"Through the joint effort of the House of Representatives and Malacañang, we have fielded 100 buses to augment the number of vehicles provided by local governments and other government agencies that would provide free rides to affected commuters," he said.

If necessary, he said additional vehicles will be provided to augment free rides for the duration of the transport strike.

Romualdez said despite President Ferdinand R. Marcos Jr.'s call for the Department of Transportation (DOTr) to revisit the program's timetable and implementation, the transport groups still proceeded with the planned strike.

Romualdez said some 1,380 commuters were already served by the first 46 buses deployed by Metro Manila Development Authority (MMDA) to service various routes between 8:35 a.m. to 11:01 a.m. Monday.

As per MMDA's report, Romualdez said the first batch of 46 buses were deployed in the following routes: Baclaran-Sucat, Baclaran-Dapitan, SM Sangandaan-Divisoria, Buendia-Guadalupe, Zobel-Roxas-Dulo (Sta. Ana), DOST Bicutan-Sucat, Alabang-San

"President Marcos has shown that he is sympathetic to the issues raised by certain transport groups over the jeepney modernization program. I appeal to those concerned to engage the government in a sincere dialogue to resolve this issue," Romual-

Meanwhile, Assistant Minority Leader and Gabriela Party-List Representative Arlene Brosas called for the junking of the jeepney modernization program, which was approved during the previous administration.

Brosas said she is not against the modernization but franchise should not be given to big businessmen.

She said public utility vehicles operators and drivers would only be buried in debt due to the high cost of modern public utility vehicles that will replace traditional ieepnevs.

Daily commuters between Novaliches, Quezon City and Valenzuela City and vice versa have not been affected by the transport strike, according to reports.

At least 84 air-conditioned mini-buses or modern jeepneys belonging to two transport cooperatives continue to operate along the nine-kilometer Gen. Luis St. (formerly Novaliches-Polo Road) route from the former Novaliches town proper to MacArthur Highway in Malinta, Valenzuela City.

Fifty of the units are operated by the Novaliches-Malinta Jeepney Transport Service Cooperative and 32 units by the Novaliches Development Cooperative

In addition, about a dozen airconditioned buses under the Quezon City Government's Bus Service Program serve the local commuters from Gen. Luis St. to Quezon City Hall in Diliman.
