DPWH, stakeholders meet for Cavite-Bataan bridge project



Cavite (PIA) - The Department of Public Works and Highways (DPWH) met with local leaders and stakeholders from Bataan and Cavite in the first inter-agency steering committee meeting for the Detailed Engineering Design (D.E.D) of the Bataan-Cavite Interlink Bridge (BCIB) project on March 2, 2022.

During the meeting, participants were given the opportunity to raise their issues and concerns for DPWH and the Consultants' team can anticipate potential challenges prior to the completion of the D.E.D.

According to DPWH Undersecretary Emil Sadain, the D.E.D work which is expected to be completed in early 2023 is now at 34% based on the February 2022

CTA cancels BIR's seizure warrant vs Cavite hospital

The Court of Tax Appeals (CTA) cancelled the seizure warrant issued by the Bureau of Internal Revenue (BIR) against a Cavite hospital for alleged non-payment of taxes amounting to more than P13 million.

The court's First Division said the tax liabilities of St. Dominic Medical Center of Bacoor City were extinguished when its application for tax amnesty on delinquencies was accepted and approved by the revenue district office in Cavite.

BIR said the hospital was still liable to pay the 2013 tax debts because the assessment for deficiency taxes had become final and executory.

Necessary health protocols were observed and strictly implemented as validated by the joint inspection personnel composed of local Department of Education officials and the local government's inspection team. The school personnel and the students have been vaccinated against Covid-19.

The Robredo People's Council-Cavite released a statement following Lacson and Remulla's accusations.

Escudero said the government should spend its entire 2022 budget to fuel economic activity, which will in turn create jobs. "Bilang miyembro ng Senado dati man o kung bibigyan ng pagkakataon, ang pinapasa namin ay batas. Kung pwede ko lang isabatas na lahat ng naghahanap ng trabaho ay mabibigyan ng trabaho, matagal na sana isinabatas iyan," Escudero said.

"Pero ang trabaho ng Senado ay magpasa ng batas na magbibigay-daan dito gamit ang taunang budget at appropriation. Iyan ang magsisilbing tulay para muling bumangon ang ekonomiya at malagyan ng karampatang pondo ang mga sektor. Dapat magsilbing recovery budget ang 2022 GAA para manumbalik ang trabaho, magbukas muli ang mga negosyo, at gumulong uli ang ating ekonomiya," he said.

Unemployment rate in the country was at 6.6% or 3.27 million jobless Filipinos as of December 2021, according to the latest Labor Force Survey of the Philippine Statistics Authority (PSA). The labor force participation rate—or the proportion of the working-age population that is working or looking for work—increased to 65.1% in December 2021, the highest last year.

The veteran lawmaker reiterated his call for the national government to extend its economic and employment programs to underdeveloped regions, saying the jobless are not limited Manila,

Escudero, who has been pushing for greater private sector participation in economic recovery, said the Build, Build program is one way to generate jobs. With continued infrastructo urban centers in Metro ture development, especially CALABARZON in rural areas, the govern-

ment can spread employment opportunities across the country. According to a 2021 UN Philippines report titled Diversification, Jobs and the COVID-19 Recovery, the Philippines remains a service-oriented economy, with 6 out of 10 workers employed in the service industry. A third of them, however, are in low- paying jobs, the UN report said.

The UN report said the manufacturing sector could be a potential springboard for unskilled workers but the sector's share in total employment has been stagnant at around 10% for over 50 years. "With renewed economic activity, the manufacturing sector can hopefully begin to expand and the government can contribute to its growth," Escudero said.

a rallying cry: 800,000 minus one, in reference to Cavite Gov. Jonvic Remulla's commitment to deliver a victory for former Sen. Ferdinand "Bongbong" Marcos Jr. in the second most vote-rich province by 800,000 votes.

"That won't happen," small business owner Terry Madlangao, 56, told Philstar.com in Filipino in Dasmariñas City. "There are a lot of Leni supporters here and volunteers."

For 35-year-old broadcast traffic manager Bill Kevin del Rosario, Cavite is not a Marcos country, even if Robredo lost the province in the 2016 vice-presidential race to him by over 150,000 votes.

"Caviteños have a different kind of awareness now. We are seeing that our ranks are slowly increasing," Del Rosario told Philstar. com in Filipino. Robredo told reporters that the 2016 race where she emerged victorious by a slim margin was "more difficult" as she started from the bottom in pre-election surveys, unlike now that she ranks second, albeit still far behind frontrunner Marcos Jr. This is despite the fact that Robredo was an ad-

ministration candidate when she ran for vice president, which she said gave her the leverage of enjoying the support of local officials. Now an independent opposition candidate with hardly any political machinery to speak of, Robredo relies largely on campaign volunteers, whom she described as all "fired up."

"Back in 2016, we did not have volunteers which is why we're very hopeful that we would have a better showing here in Cavite compared to 2016," she said partly in Filipino. "This is very different from 2016. The people did not have this kind of fervor, so hopefully by end March or early April, surveys would capture what we're seeing on the ground," she added. On the ground, Robredo's supporters — her Kakampinks — showed up in the tens of thousands, filling up the General Trias Sports Plaza for her grand rally to prove that "Cavite is pink."

"If this strength that you are showing tonight will be the same strength that we will show until May 9, we will win," Robredo told the feverish crowd, which organizers said reached around 47,000.

"While there has been an improvement in the labor force participation of women at 46.9% from January 2021, our employment recovery strategy should have particular concern for employment of women. Natatangi po ang karanasan ng ating mga kababaihan sa pandemyang ito, kaya dapat isaalang-alang natin ito sa polisiya ng trabaho" sabi ni Villanueva.

Gayunpaman, sinabi ni Villanueva na mas marami na ang paraan para sa women empowerment sa trabaho, pati na in ang pagkakapantay-pantay sa oportunidad at seguridad sa trabaho.

Sinabi ng senador na pinapayagan ang alternative working arrangements para sa mga negosyo sa ilalim ng Republic Act 11165 o Telecommuting Act, kung saan maaaring magtrabaho mula sa kanilang tahanan ang mga manggagawa, babae man o lalaki.

"Telecommuting breaks barriers that prevent women from participating because of domestic responsibilities, especially in our culture. Recognizing alternative modalities for delivering work promotes both inclusion and diversity in society," he said.

DOST-FPRDI develops cheaper moisture meter for bamboo and other non-timber forest products

The moisture meter for bamboo developed by the Forest Products Research and Development Institute of the Department of Science and Technology (DOST-FPRDI) is now out in the market.

The development of the device was made in collaboration with DOST- Advanced Science and Technology Institute and YONGDEN Technology, and was funded by the Philippine Council for Industry, Energy, and Emerging Technology Research and Development (DOST-PCIEERD).

The FPRDI moisture meter is a handheld device that reads the amount of water present in non-timber products. It is specially calibrated for several bamboo species that are extensively planted in the country and are used for engineered bamboo. These include kawayan tinik (Bambusa blumeana J. A. & J. H. Schultes.); giant bamboo (Dendrocalamus asper (Schultes f.) Backer ex Heyne); and botong (Dendrocalamus latiflorus Munro). It is also calibrated to read the moisture content (MC) of bakbak (or the out-

ermost covering of leaf sheath of abaca stalk) and vines. "Knowing the moisture content is crucial in maintaining the quality of bamboo products. Raw materials must have the same moisture content prior to gluing and finishing to ensure that the final product will not crack or split," explained project leader Dr. Marina A. Alipon.

Stressing the importance of determining the right MC to lessen the chances of insect or fungus attack, Alipon also underscored the need to maintain the moisture level of products bound for export.

"For exported local bamboo products to perform well, their MC must approximate those prevailing in the country of destination, otherwise the material will distort, shrink, or crack while in service. The fastest and most convenient way to determine the MC is thru the use of a moisture meter," she added.

The DOST-FPRDI moisture meter for bamboo was built using local spare parts and is cheaper than its imported counterparts as it only costs Php 6,500 per unit. The first in the Philippines, it was designed following the Institute's digital wood moisture meter.

Lacson insists communist infiltration in Robredo's Cavite sortie, VP's camp debunks allegation

Parañaque City (CNN Philippines, March 10, 2022) — Presidential candidate Sen. Panfilo Lacson insisted Thursday that Vice President Leni Robredo's campaign rally in Cavite last week was infiltrated by communists, citing intelligence information that he had received.

Lacson said that the information was corroborated by the statement of self-proclaimed former communist party member and supposed surrenderer Jeffrey "Ka Eric" Celiz.

The senator added that he is still verifying reports that supposed communists front organization members were also present during Robredo's sorties in Iloilo and Bulacan.

"Hindi lang sa Cavite nainfiltrate. Possible din na, bina-validate din ito, sa ibang lugar: Iloilo, Cavite, and Bulacan. Kasi worrisome talaga ito. Kasi ang intention naman is not to red tag," Lacson said in a press conference.

[Translation: It's not just in Cavite. It is also possible, though we are still validating, that the infiltration also happened in Iloilo and Bulacan. This is worrisome. And our intention is not to redtag.] But the Partido Reporma standard bearer said he is not sure if the vice president is aware of the alleged "alliance" with the Communist Party of the Philippines-New Peoples Army-National Democratic Front of the Philippines (CPP-NPA-NDFP) through its supposed front organizations. Lacson mentioned the urban poor group Kadamay as among the alleged communist-front organizations.

"Kung alam, mas masama 'yun doon sa hindi alam. Kung hindi alam, that's bad enough. Pero kung alam mo, conscious ka na may alliance na nangyayari. Anong mangyayari in case they win the election? Coalition 'yan. Baka lumakas na naman ang CPP NPA," Lacson said.

[Translation: If she doesn't know, that's bad enough. It's worse if she knows that there's an alliance (with the communists). What will happen in case they win? It's a coalition. The CPP-NPA may regain its strength.] But Robredo's ally, senatorial candidate Sonny Trillanes denied Lacson's allegations saying that Lacson's intel is wrong.

Trillanes, who is a former soldier, said in a tweet there are no communists in Robredo's campaign team.

"Sir, your intel sources are wrong, and that Ka Eric you cited is a fraud. I am inside the campaign team of VP Leni at wala akong nakikitang komunista doon [and I haven"t seen a communist there]. Hindi papayag si VP nyan at kami rin [We will not allow it]. Her military advisers could attest to this too," the former senator said.

Robredo's spokesperson Barry Gutierrez also tweeted: "Over the course of this campaign, we have seen more than our fair share of attacks and fake news against VP Leni. But this blatant and persistent red-tagging, masked as "concern' is a new low." "Let us not be be intimidated. Call out the lies,"
