devices used by Bacoor's and other city officials signed Jr.'s program of digitalizing the agreement on behalf of Bacoor, while Assistant Secretary Atty. Vigor D. Mendiza II – Regional Director Atty. Noreen Bernadette San Luis-Lutey represented LTO.

Asec. Mendiza delivered the message on behalf of Transportation Secretary Jaime Bautista, where the secretary noted that the digitization of government processes is in line with the mandate of President Ferdinand R. Marcos Jr., under the Bagong Pilipinas brand of governance.

"The Department of Transportation, through the Land Transportation Office, intends to streamline traffic violations and fines throughout the country by institutionalizing this system. This is also a part of President Ferdinand Marcos government systems and processes to establish better interconnectivity among agencies," the statement

LTO believes that the single-ticket system will bring convenience improve compliance for motorists, and will lessen the corrupt practices of some traffic enforcers.

"We can see that the single-ticketing system will bear many benefits, not just for the local governments but for motorists as well.

In this way, we can fight corruption and the wrongdoings of motorists who test our traffic enforcers, and the traffic enforcers who don't have integrity," Mendiza added.

Meanwhile, Revilla said that the program will expedite the process of

delivery services to motorists in the city and will establish a more efficient system for paying fines and other trafficrelated transactions which promotes transparency and efficiency.

"The LTO-LGU Interconnectivity program not only streamlines the ticketing process but also introduces a more accessible approach for violators to pay fines online, thereby reducing the inconvenience of physical transactions," the local chief executive said.

Once implemented, the DOTr and LTO said that the local single-ticketing system of Bacoor may become the model of observation for the future implementation of the same traffic system to other cities and municipalities nationwide. (RF/PIA-Cavite; with reports from Bacoor City Information Office)

## **DOH certifies over 100 << P1**

Regional Outcome Manager for the Substance Abuse Prevention Program of DOH IV-A said during a meeting of the Inter-Agency Committee on Anti-Illegal Drugs (ICAD) Advocacy Cluster that out of the total of 142 LGUs in the region, the province of Cavite with 23 CBDRPs has 100 percent certification rate after the rigorous validation process by the agency.

CBDRP is an integrated model for drug users with moderate risk for drug dependence and/or mild substance use disorder. Individuals who are under the program were provided with care from outreach and low-threshold services through coordination with health, social, and other nonspecialist services needed to meet their needs.

governments Local were given the mandate to implement CBDRPs, depending on available resources and the number of clients they accept.

The health department, however, sets guidelines to which LGUs must adhere to have an effective CBDRP, such as adequate promotion of anti-drug use; and establishing prevention guidelines by having a health service provider and screening tools for drug screening tests.

DOH also requires setting up treatment centers, forming a referral system between local governments and health service providers that will conduct drug dependence examinations, having functional recovery clinics, psychosocial and spiritual services, and specialty providers.

According to the latest DOH IV-A data dated Feb. 20, 2024, only 31 LGUs remain uncertified in the region. The majority are from the province of Quezon with 15 uncertified CDRPs, 10 from

service Batangas, and 3 in Laguna and Rizal, respectively. They target certifying all CDRPs by the end of March.

Malubag assured that they will continue to assist barangays in the region to attain a drug-cleared and drug-free declaration

"The fact of the matter is that as legislators and law enforcers, we have work hand-in-hand. Whatever instruments we wield, whether it be guns or pens, our goal is the same: to protect and uplift our communities and the whole nation," said Zubiri.

"To this end, the Senate has endeavored to develop legislation in support of the evolving needs of the police force," the Senate chief added. Zubiri started quantifying this legislative support by mentioning the passage in 2021 of Republic Act No. 11549 or the "Height Equality Act" that reduced the height requirement for not only police recruits but also officers of firefighters and jail and corrections officers.

"We know that a good cop is not defined by their height - what counts is their courage, their commitment, and their integrity. And so this law opened the doors for many more Filipinos to enter the police force and dedicate themselves to the service of our people," the senator from Bukidnon said.

Zubiri added that just last month, the Senate passed on third and final reading

the PNP Organizational Reforms Act that aims to update the old structures of the PNP and strengthen and streamline leadership, organization and management. "We will be institutionalizing offices such as the Directorial Staff and the Area Police Command across the country, to fortify their roles and integrate them better into the police force," Zubiri said.

The Jail Integration Act, which will transfer provincial and sub-provincial jails from the supervision of LGUs to the supervision of the BJMP, was also passed on third and final reading last week in the

"Under the expert management of the BJMP, we hope to create a more efficient and standardized system of management for all Persons Deprived of Liberty, no matter where they are serving their time," Zubiri explained.

The bill, he continued, will also complement the Heinous Crimes Facility Act that was passed in the 18th Congress and has obtained funding this year.

"With that supermax facility in Mindoro, we hope to decongest our jails, and we hope to establish a better managed penitentiary system that will help lowlevel offenders have a truly rehabilitative time in prison, away from the influence of high-level offenders," Zubiri noted.
