NBI cracks down on human traffickers in Pasay, Cavite



The National Bureau of Investigation (NBI) on Tuesday announced recent arrests in Pasay City and Cavite province following concerns over rising incidents of human trafficking in the past two months.

In a statement to the media, the NBI said female Chinese national Wen Fangfang was nabbed for human trafficking by operatives of the NBI - International Operations Division (NBI-IOD) in Pasay. Wen allegedly ran her operations in several condominium units using the

Bataan-Cavite bridge construction to start late this year - DPWH The construction of

the PHP175.7-billion Bataan-Cavite Interlink Bridge Project will start towards the latter part of the year, the Department of Public Works and Highways (DPWH) said Tuesday.

In a Palace press briefing, DPWH Secretary Manuel Bonoan said the 32-kilometer project, which was initially expected to begin construction in the first quarter of 2024, will break ground earlier than expected.

"Detailed engineering [design] is now ongoing—it's about 70 percent complete and we told the President

A separate operation of the NBI's Cybercrime Division in General Mariano Alvarez, Cavite resulted in the arrest of two male suspects who offered female sex workers, including minors, through social media.

Rodel Miranda, alias Gigzo, and Jesus Manuel Genio, alias Buboy, who were nabbed in an apartelle, operated under the Facebook account name Gigzo Anap Reyes. Nine women were rescued and have been transferred under the supervision of the Department of Social Welfare and Development.

On Monday, an inter-agency meeting in Malacañang was held to discuss the reported 2,000 cases of human trafficking in January and February, which is nearly the total for 2022.

Justice Secretary Jesus Crispin Remulla said most of the victims, predominantly women, were spirited away to Myanmar via Thailand. (PNA)

The good weather on a Tuesday morning (March 7) provided the impetus for the active participation of the local community in barangay Población 1A in Ternate, Cavite. After a brief orientation by the Department of Environment and Natural Resources (DENR) representative, the PNP Maritime Group initiated the mangrove planting on the nearby riverbank.

By sustaining the planting of mangroves, we are not only protecting the environment, but also sustaining the community's livelihood and providing opportunities for future generations."

Bonoan said the project is expected to significantly improve economic development not only in Luzon but the entire country.

"No less than the Asian Development Bank (ADB) has indicated that the economic rate of return of this bridge is more than 25 percent and that's big," he said.

The Bataan-Cavite Interlink Bridge Project is a cable-stayed bridge to be built over Manila Bay to reduce the travel time between the provinces of Bataan and Cavite from five hours to 20 to 30 minutes.

From July to December It is being developed last year, the DPWH implemented, maintained, constructed and improved about 1,500 kms of national roads and local roads all over the country. The DPWH has also undertaken the construction of 161 bridges along national and local roads as well as 851 flood control projects during the past six months.

In a Facebook post, Marcos welcomed the DPWH report that more roads and bridges are being constructed across the country.

Payapa at tahimik na buhay. Ito dapat ang ating ninanais na makamtan para sa ating buhay, ng ating pamilya at lalong-lalo na sa komunidad na ating kinabibilangan. Marami na tayong narinig at natunghayan na kwento ng mga dating miyembro ng Communist Party of the Philippines o CPP at New People's Army o NPA na nagbalilk-loob sa panig ng pamahalaan upang magkaroon ng mas maayos at payapa na pamumuhay.
