# Claims of Reds infiltrating poll campaign 'worrisome': Lacson



Partido Reporma standard-bearer, Senator Panfilo "Ping" Lacson, described as "really worrisome" information coming from a former New People's Army (NPA) cadre indicating that operatives of the Communist Party of the Philippines (CPP)'s legal fronts may have "infiltrated" the campaign of Vice President Ma. Leonor "Leni" Robredo.

He added these pieces of information disclosed by ex-NPA cadre Jeffrey "Ka Eric" Celiz appeared to jibe with those provided by his own intelligence sources.

"Now, this is really worrisome - my intel sources being validated by Ka Eric, himself a top-ranking NPA surrenderor. Bad if their

# French Navy eyes stronger cooperation with PH counterparts

The French Navy has expressed willingness to work with its Philippine counterparts at sea.

"We are ready to work

with your forces at sea. We need to protect, we need to defend the freedom of navigation including (on) the West Philippine Sea," said

Rear Adm. Jean-Mathieu Rey, Joint Commander of the French Armed Forces in the Asia-Pacific (ALPACI), during his courtesy call on

Philippine Navy (PN) chief, Vice Admiral Adeluis Bordado, on Monday.

PN spokesperson Commander Benjo Negranza, in a statement, said Rey's visit is in line with the scheduled March 8 to 11 port call of French surveillance frigate Vendémiaire (F-734) to the country.

After a turnout of 47,000 at the Kakampink rally in Cavite on March 4, Google Trends had Vice President Leni Robredo as the most searched presidential candidate for the May 9 elections.

43 percent of the searches were about Robredo, around 26 percent were about former senator Bongbong Marcos, Sen. Manny Pacquiao, and Manila Mayor Isko Moreno were tied at 13%; while Sen. Panfilo Lacson only got 5 percent share of the searches. The number one related search to Robre-

# CPP-NPA front groups have no place in Isko admin

A government under Francisco "Isko Moreno" Domagoso will never allow a coalition with the Communist Party of the Philippines-New People's Army-National Democratic Front (CPP-NPA-NDF).

The Aksyon Demokratiko standard-bearer, reacting to a reported infiltration of communist terrorist group (CTG) members in the campaign of a rival candidate, said they have no place in his administration in case he wins in the May 9 polls.

"No, I am not in favor of a coalition governance with the CPP-NPA. I am for peace," Domagoso said during a press conference in Cabanatuan City on Friday with running mate Dr. Willie Ong and senatorial bets Carl Balita and Samira Gutoc, and adopted candidate John Castriciones.

Lawyer Jopet Sison is the third Aksyon bet for the

Domagoso stressed he is sure that nobody from his team is involved with the CTGs.

He said Gutoc's focus is on her fellow Muslims, Balita is an educator, and former Agrarian Reform secretary Castriciones helped distribute lands to farmers and former NPA members.

campaign is infiltrated. Worse if they are a willing partner. I'm more concerned about those who voluntarily joined their rallies but were not aware," Lacson said in a post on his Twitter account late Wednesday.

He was referring to information cited by Celiz indicating that members of the CPP and its supposed legal fronts were at the rally of Robredo in Cavite last March 4.

Celiz, in a video posted on social media, cited a text message from a former colleague in the CPP-NPA who is now based in Cavite, indicating members of the group's reported legal fronts were brought in from parts of Cavite and even Rizal prov-

Also, Celiz alleged there was a budget of PHP500 per head, of which PHP200 was spent for transportation and

During a hearing on red-tagging which Lacson presided over in November 2020, Celiz said CPP founding chairperson Jose Maria "Joma" Sison had named several groups as his legal "fronts," which have infiltrated several sectors.

Celiz also said the legal fronts lay the ground for recruiting members to the

With the information cited by Celiz, Lacson reiterated his warning to those concerned to watch out against being part of a possible coalition government with the CPP, NPA, and NDF.

"If those in the campaign were not aware of this, they should consider themselves warned and take appropriate action. If they are a willing partner, they should consider the consequences of their actions - we simply cannot afford to have a coalition government with a movement whose sole objective is to seize power," Lacson said.

The CPP-NPA is listed as a terrorist organization by the United States, European Union, the United Kingdom, Australia, Canada, New Zealand, and the Philippines.

While the Anti-Terrorism Council also formally designated the NDF as a terrorist organization on June 23, 2021, citing it as "an intethe CPP-NPA that was created in April 1973.

"Since 1969, our country has suffered from the longest-running insurgency in the world which has caused more than 2,000 deaths and billions of pesos in revolutionary taxes paid to the CPP-NPA, not to mention the destruction of properties of those who refused to 'cooperate.' Insurgency, like corruption, must end if we want peace and prosperity," the Partido Reporma standard-bearer added.

As this developed, Partido Reporma senatorial candidate and former Philippine National Police (PNP) chief, Guillermo Eleazar, said the national government should seriously consider declaring a state of economic emergency, explaining that it could empower the local government units (LGUs) to act on their own to assist their constituents that are now suffering the brunt of the series of big-time oil price hikes in the past months.

He added the state of economic emergency also

last week when parent conglomerate Metro Pacific Investments Corp. announced its 2021 financial results.

With the completion of the viaduct, LRMC is now starting the electromechanical upgrade of the railway and the installation of new rails. Civil works on the Cavite extension program broke ground in September

"We hope that we will be done sooner than later. We're pushing for a 2024 start [of operations] and we look forward to that," Alfonso said. One of the recent accomplishments of LRMC was the upgrading of the sig-

fonso said at a press briefing naling system of the railway, a P7-billion undertaking to replace the 30-year-old signaling system of the country's oldest elevated railway, Alfonso said.

"The new Alstom system allows for trains to be safer and also the headways to be reduced from three and a half minutes to two and a half minutes, so [it will allow] faster and safer journeys," he

LRMC has received a total of 16 new generation train sets to date, each with a total capacity of around 1,400 passengers. The new fleet will still need to undergo complete safety checks, inspections and required test

runs before deployment in mid-2022.

The railway operator also expects the Roosevelt station in the old alignment to be reopened between the third and fourth quarters of this year. It was closed to pave the way for signaling upgrade.

LRT-1 is being extended starting from its existing Baclaran station to the future Niyog Station in Bacoor, Cavite. The project will stretch the integrated LRT-1 system to a total of 32.4 km and will be operated and maintained by the private sector proponent.

The LRT-1 extension and upgrade program is estimated to cost P64.91 billion, inclusive of the P19.83-billion official development assistance component.

LRMC has also proposed to implement more contactless payment options for the railway system. A proposal has been submitted to the Department of Transportation to put in place a quick response code payment system for consumers.

Meanwhile, Alfonso said the common station, a transportation hub at the tip of Trinoma mall complex in Quezon City that will connect Metro Manila's existing railway systems, may be completed by next year. INQ

# Metro Manila stays under Alert Level 1

# NTF-ELCAC to Robredo: Stop lying about alliance with CPP

The National Task Force to End Local Communist Armed Conflict (NTF-ELCAC) on Monday criticized presidential candidate and Vice President Leni Robredo for lying about a deal with members of the Communist Party of the Philippines-New People's Army-National Democratic Front (CPP-NPA-NDF).

NTF-ELCAC Spokesperson for Sectoral Concerns and Communications Undersecretary Lorraine Marie Badoy made this remark after Robredo on Sunday denied rumors linking her and her volunteers to the CPP-NPA-NDF.

Badoy said Robredo's camp should stop denying the deal, noting that CPP founder, Jose Maria "Joma" Sison even tweeted his official endorsement of her candidacy.

"VP Leni Robredo's camp should stop insulting the intelligence of the Filipino people by pretending they have not made a pact with the devil, the communist terrorist CPP-NPA-NDF," she said in a statement.

She said the Makabayan Bloc, which she described as "urban operatives of the CPP-NPA-NDF", also endorsed Robredo.

"This endorsement of Leni Robredo is an endorsement of the Central Committee of the CPP-NPA-NDF, an organization that has been designated a terrorist organization by the Anti-Terrorism Council and that has also been declared a terrorist organization by the Philippines, US, UK, New Zealand, EU, Australia and Canada," she added.

Robredo's spokesperson, Barry Gutierrez, earlier said the "blatant" and "persistent" red-tagging of their camp is a "new low", noting that rival candidates were trying to dampen the energy of the Vice President's campaign.

CPP spokesperson Marco Valbuena also denied talking with Robredo or other presidential candidates about the formation of a coalition government. The CPP-NPA is listed as a terrorist organization by the United States, European Union, the United Kingdom, Australia, Canada, New Zealand, and the Philippines.

The Anti-Terrorism Council also formally designated the National Democratic Front as a terrorist organization on June 23, 2021, citing it as "an integral and inseparable part" of the CPP-NPA that was created in April 1973. (With reports from Lade Kabagani/PNA)

good during the initial months of the quarantine. It's hard because they cannot go home or see their family, so they had to stay at the camp and some of them did not have a good mobile reception," she explained.

"There was total isolation. They worried about the spread of the virus and who in their families could be affected," she added.

The program which started in the divisions under the Eastmincom would soon expand as more soldiers expressed the need for mental health interventions.

Ramos said even soldiers from as far as Jolo, Sulu, and Cavite would contact their social media channels for help. A number of civilians as far as Dubai also inquired if they could join the program.

"Soon, we will open it for the civilians as well. Many were really affected by the situation emotionally. With no accessible support, we have presented ourselves as options. So their heavy thoughts could at least be lightened," Ramos said, adding that their hotlines are open 24 hours.

In a separate interview, Philippine Army's 10th Infantry Division (ID) commander, Maj. General Nolasco Mempin, said the program is proof of the command's focus on the soldiers' well-being.

"That includes keeping them in shape and having good mental health," Mempin said.

Apart from the "Musta Ka Tropa Program," Mempin said the 10ID also conducts regular forum, workshops, neurological tests and distressing activities to prevent stigma on mental health issues.

These mental health interventions, he said, are open "especially for those who are experiencing post-traumatic stress disorder, and any other form of emotional and physical stress that may affect their mental health."

"The command detects patients discreetly or at the tactical level to identify who needs medical attention, in collaboration with our professionals, experts inside and outside of the camp including their families," Mempin added.

Mental health programs, he said, enable soldiers to continue performing their sworn duty of serving the people and securing the land with the mental resilience that will help them find inner peace."

Ahead of the Philippine Army's 125th anniversary on March 22, the 10ID gathered personalities to share their experiences in Mindanao on March 12.

In his speech during the event, Mempin said he believes the government can find the solution to insurgency problems through good governance, unity, and transpar-

"We can now see the advantage of having a collective effort in addressing the problem of insurgency through the whole-of-nation approach under the National Task Force to End Local Communist Armed Conflict," he said. (PNA)

# Lacson, Sotto vow more support for MSMEs

Partido Reporma standard bearer Senator Panfilo "Ping" Lacson on Monday said there would be more success stories for micro, small and medium enterprises (MSMEs) if he and running mate Senate President Vicente "Tito" Sotto III win in the May 9 elections.

The presidential aspirant made this pronouncement after meeting with Josh Mojica, a 17-year-old entrepreneur behind the "kangkong" (water spinach) chip business at the Alfredo's Grill & Restaurant in Mendez last March 5.

Lacson added that if the government, whether local or national, heard stories of rising entrepreneurs like Mojica and gave MSMEs the proper support, success stories like these would greatly climb.

"You can just imagine how we can replicate a success story like this," he said.

The Partido Reporma standard-bearer, who hails from Imus, Cavite, promised that under his and Sotto's administration, they would empower small businesses or the MSME sector across the country with correct government interventions, not with more regulations.

Lacson likewise called on government agencies such as the Food and Drugs Administration (FDA), the Department of Trade and Industry (DTI), and the Department of Science and Technology (DOST) to support more young entrepreneurs like Mojica thrive in this kind of business.

Mojica lost his grandfather whom he was very close with just when his kangkong chips business was taking off.

The death of his grandfather compounded the daily struggles he was dealing with at the time, which nearly made him give up until he connected with Lacson on Twitter.

"Dahil po doon sa tweet po niya (Lacson), dahil lang po doon, sa isang tweet nagkaroon po ako ng opportunity na makatulong po ako sa family ko, maiahon ko po 'yung family ko sa kahirapan. Tapos, lahat po ng pangarap ng daddy (Just because of his (Lacson's) tweet, a single tweet, I was given an opportunity to help my family, lift my family out of poverty. And then, I also get to live out the dreams of my daddy (grandfather)," Mojica said.

Lacson said he came to know Mojica through one of his

At the time, they were thinking about what kind of gifts they could give away to their friends for the holidays.

The senator got curious about kangkong chips and instantly loved the idea as soon as he learned that a young Caviteño was behind it.

"Ang istorya niya (Mojica) nag-backyard siya, parang homemade lang ng kangkong chips. Napanood ng aking staff na naggagawa siya ng ganoon. So, sabi ko, pakuha ka ng sample. Eh nasarapan 'yung mga staff ko kasi lahat, parang FGD (focus group discussion), sabi ko, order tayo (His (Mojica's) story is that he started a backyard (business), making homemade kangkong chips. One of my staff watched him online, so I told him to get a sample. My staff tasted it and it was delicious, as they acted like an FGD, a focus group discussion, so I said 'Let's order)," Lacson added.

Lacson first tweeted about it on November 21 last year.

"I don't know him (Josh) but I'm so proud of him. Hats off!" part of his tweet read.

His office ordered 400 packs of kangkong chips as one of the items for their Christmas gift baskets, which gave Mojica the biggest break for his fledgling snack business.

Lacson said Mojica's story proves that the Filipino youth can counter whatever feelings of despair and hopelessness they had over their status in life or the state of affairs in the country by focusing their mind, heart, and soul on their cho-

Apart from Mojica and his kangkong chips crew, Lacson also visited the workers of the Café Amadeo Development Cooperative, which became famous for its 'Pahimis' blend of coffee and other products and delicacies. (PNA)
