sectors. "We are engaging more and more economically in the India-Pacific region, but the Philippines is special," Raimondo said, noting the 72 years of "ironclad and rock solid" bilateral ties between the two countries.

Raimondo will proceed to Bangkok, Thailand, but tagged just the Philippined as a trade and investment mission initiated by President Joe Biden, a first for the Phil-

"This is the only place I'm leading this Presidential mission because we are choosing to prioritize the Philippines," Raimondo said.

Raimondo announced on Monday over USD1 billion worth of investment commitments from US companies in the sectors of renewable energy, artificial intelligence, digitalization, and infrastructure, among

These sectors are key priorities of the Marcos administration.

On Tuesday, the White House executive said US Secretary of State Antony Blinken will be visiting Manila "in a week or so" -- the second official trip of Blinken to the Philippines.

Raimondo led the Presidential Trade and Investment Mission to Manila on Monday and Tuesday, bringing the highest caliber of US business leaders.

Some of the companies shared their future plans in the Philippines, which include the following:

UltraPass ID co-founder and chief executive officer (CEO) Eric Starr signed an agreement with the Department of Budget and Management and information and communications technology firm Now Corp. for the use of its decentralized identity solutions and rolling out of secured data sharing;

Sol-Go chair of the board and CEO Scott McHugo shared the company's plan to triple Sol-Go's headcount and capacity of its lightweight solar panel factory in Batangas;

Microsoft Corp. Office of the President Global Strategic Initiatives vice president Mary Snapp announced its partnership with Unconnected.org to bring in additional one million individuals online and the tie-up with the Department of Labor and Employment and the Technical Education and Skills Development Authority to equip Filipinos with digital and artificial intelligence

Mastercard Center for Inclusive Growth founder and president and EVP for Sustainability Shamina Singh intends to expand the 10,000 small business beneficiaries in the Philippines that can tap Mastercard's capital, know-how, and lending services for their innovation investments:

InnovationForce founder and CEO Kimberly Getgen mentioned the company's partnership with Aboitiz Power Corp. for the former to provide its digital solutions to the Filipino pow-

er firm; and KKR head of Asia Pacific Infrastructure David Luboff said the company will continue to invest in the Philippines on top of the USD1.7-billion capital it had already poured into the

Moreover, Department of Trade and Industry Secretary Alfredo Pascual said they signed a partnership with search engine Google.

Filipino-American rapper and singer Apl.de.Ap, through his foundation, also sealed a deal with the Asian Development Bank and US firm Legacy EV to put up a center for excellence for e-mobility advancement of the country.

Raimondo left Manila on Tuesday afternoon to lead the President's Export Council trip to Bangkok. (PNA)



German wind, solar developer << P1

Garafil said in a statement issued Wednesday night. "The wpd GmbH plans to invest PHP392.4 billion in the Philippines to set up offshore wind farms in Cavite, Negros Occidental, and Guimaras, the biggest undertaking registered with the Board of Investments (BOI) in February last year," Garafil said.

"The President met the wpd GmbH officials in Berlin to discuss status updates on the BOI-registered OSW (offshore wind) projects Cavite and Negros (1 & 2) Projects with a combined capacity of 3,260 MW (megawatts) valued at PHP400 billion," she added.

Garafil said wpd GmbH officials also updated Marcos on the new solar, onshore, and PHP137 billion worth of offshore wind projects with a combined rated capacity of [of] these new technologies

1,662 MW in Aklan, Ilocos Norte, Ilocos Sur, Abra, Iloilo, Bulacan, Mindoro, and Antique.

During the meeting, Marcos expressed optimism that the German firm would bring modern technology to the Philippines with its plans to set up offshore wind farms in the country.

"Thank you for coming in and to continue having an interest in the Philippines. I think that it is a very fertile investment especially for your industry, and business. And we are of course, like everybody else, working very hard to move the share of energy production and fossil fuels to renewable and wind, solar, hydro, and nuclear," Marcos said, as quoted by the

"So, I hope we can avail

now because all our wind farms now are land-based, we haven't done anything offshore. So, we have much to learn from organizations like yours on how to handle it. What would be the capital requirements? What would be technical requirements?" he added.

Marcos said investments in the energy sector are important because of the administration's industrialization thrust, with sufficient supply of energy becoming a critical part of its plans in the future.

Earlier, Marcos set up the commercially-operated wind farm in his hometown in Ilocos Norte, the first in Southeast Asia, when he was governor of the province.

Marcos said while the Philippines already has a good number of wind farms, it needs more expertise to determine the potential and suitable areas for new ones.

He also hoped that the Philippines could take advantage of the new technologies in wind power.

The wpd GmbH develops and operates onshore wind and solar photovoltaic (PV) projects in Europe, Asia, and the American Headquartered continent. in Bremen, Germany, wpd GmbH is actively engaged in 29 countries worldwide.

To date, the German wind and solar developer is in the process of establishing five onshore projects in various regions of the country, estimated to have an investment value of PHP56 million. These projects are projected to be completed between 2027 and 2030. (PNA)

Former 4Ps child beneficiary << P1

"We are proud of Angeline and we congratulate her for this achievement. She is the latest addition to the list of former 4Ps monitored children who have topped various board examinations," DSWD Assistant Secretary for Strategic Communications Romel Lopez said in a news release on Tuesday.

As of the latest count by the 4Ps National Program Management Office under Director Gemma Gabuya, the government's anti-poverty flagship program has already produced 41 topnotchers in different fields across the country.

Since 2016 up to the present, the 4Ps now have 32,000 college graduates. Of this number, 82 graduated

Magna Cum Laude, 1,135 Cum Laude, and 132 finished their collegiate course with Special Distinctions.

Angeline, together with her twin sister, Angelica, has been a 4Ps monitored child since Grade 5. She said that 4Ps has helped her and Angelica, meet their school needs until their senior year.

Aside from Angeline, 28 other 4Ps monitored children from various regions passed the CLE. One of them is Precious Anne Aguyen who graduated Cum Laude from the F.L. Vargas College, Inc.

in Abulug Campus, Cagayan province. The board passers are now part of the 4Ps roster of board examination passers numbering to 4,142, as of March. "We also extend our congratulations to these board passers," Lopez said.

He added that the achievement of these former monitored children of 4Ps is a testament that the program is on track with its objective to break the inter-generational cycle of poverty through education.

Joicel Sopeña-Bote, the focal person for Gender and Development at Napolcom, there are only a few female police officers who have reached third-level positions in the Philippine National Police and the disparity is reflected by the reality that there is only one star-ranked female officer in the entire PNP.

"Actually, we only have one female police general in Camp Crame, but in Calabarzon there is none. Because for them, if you are a woman, you cannot fight," Sopeña said as she referred to Brig. Gen. Portia Manalad, director of the Women and Children Protection Center, who is the first female graduate of the Philippine National Police Academy to have reached the rank of police general. Manalad has broken barriers and paved the way for other women to pursue high-ranking positions within the police force, Sopeña said.

As the Napolcom celebrates the annual National Women's Month, it has formed a Women's Desk, with independently designated officials from the agency, where the wives, partners, and female Non-Commissioned Officers (PNCO) can independently voice out their grievances on the lack of equal opportunities for promotion, physical and emotional distress, and other professional concerns.

"We decided to organize [a Women's Desk], and with that organization they will be more encouraged to express concern or any issues concerning PNCOs. They will have a voice to form or unify what are the solutions for all their concerns for improvement, aggressive complaints, grievances, and because of this organization, we can act faster to address those con-

PAREX is only one of SMC's large infrastructure projects. These cause a chain of negative impacts on the environment and the communities around them, including displacement, loss of livelihood, and environmental degradation.

Regardless of SMC's intentions, these large infrastructure projects have far-reaching impacts that will worsen the climate crisis. Displaced communities are the first to suffer its

In line with this, SMC should formally withdraw its operations and plans for PAREX, rather than engage in public relations stunts. We see it as the first step in acknowledging their impact on people and the environment. Beyond PAREX, we urge SMC to halt its destructive, profit-driven infrastruc-

DA hopes to normalize NFA ops

The Department of Agriculture (DA) on Monday hoped for additional lifting of more preventive suspension orders against National Food Authority (NFA) employees to ensure unhampered operations in the agency.

"Kung merong madagdag pa, welcome iyon sa DA para bumilis iyong pagbalik sa normal na operation ng NFA. Bagamat naaayos naman iyon, pero syempre mas maganda kung makabalik din sila iyong mga walang kasalanan (If there will be additional [lifting], the DA welcomes that to bring NFA operations back to normal. Though it [operation] is kept adequate, it's still better to have the innocent employees back," DA Assistant Secretary Arnel de Mesa said in an interview.

Earlier, the Office of the Ombudsman lifted the preventive suspension order against 24 NFA officials and employees after it found the list erroneous.

The 24, which included an assistant branch manager of a warehouse in Batangas province, are among the 141 NFA officials and employees suspended amid the probe



on the alleged questionable sale of rice buffer stock.

De Mesa said the reinstated employees are now back at work.

"The moment na na-receive nila iyong lifting ng suspension, balik sila sa trabaho. And then iyong mga back wages nila, iyong that time na na-suspend sila, babalik din sila (The moment they received the lifting of the suspension, they are back to work. And their back wages during the time of their suspension will be given back to them)," he said.

De Mesa said the NFA will also conduct its council meeting Monday to ensure unhampered operations amid the peak harvest sea-

Meanwhile, Agriculture Secretary Francisco Tiu Laurel Jr. clarified that the "erroneous" list has been immediately submitted to the Ombudsman without the chance of audit.

"The list was given to us by NFA and we just forwarded it to the Ombudsman, believing that [it] is current and up-to-date. We had no chance to audit the list because of the urgency of the Ombudsman's request," he said in a statement.

"Had we verified the list with NFA management, it might have stirred suspicion as to why we are asking too much details," he added.

The Office of the Ombudsman and the DA's parallel investigating panel are looking into the sale of NFA buffer stock rice which was allegedly disadvantageous to the government and was without bidding.

The preventive suspension will allow the Ombudsman to secure all the documents and other evidence relating to the issue. (PNA)
