## Comelec to form task force vs. vote-buying



The Commission on Elections (Comelec) on Tuesday said it will form a task force that will investigate allegations of vote-buying.

"The Commission will be creating a Task Force that will handle reports, complaints. Definitely, the Comelec can motu proprio (on its own) investigate. The Comelec can always direct its field personnel to submit a report to us. We will have a task force for us to immediately take action," Commissioner George Erwin Garcia said in a press conference at the conclusion of the end-to-end demonstration of the Election Day Automated Election System (AES) at the Diamond Hotel in Manila.

Garcia, however, reminded the people to be very careful in making reports of vote-buying.

"As you know, politicians can always invoke the Peñera doctrine. Technically it's not yet the start campaign period for local candidates. We will not hesitate to prosecute those who may be involved in vote-buying. We are so serious that for this election it is necessary to equalize everything. We will punish those who will be violating the Omnibus Election Code," he added.

The Peñera doctrine refers to a landmark Supreme Court ruling in 2009 where it voided the prohibition on premature campaigning.

This means that the expenses of candidates before the start of the campaign period are not covered by campaign guidelines.

Garcia, meanwhile, urged those who witnessed such an activity to file a complaint.

"Definitely regardless of the personalities involved so long as there is substantial evidence, substantial in character, we will push through with the prosecution of offenders of those who will be guilty of vote-buying," he said.

Reports said reelectionist Cavite Governor Jonvic Remulla was caught on video giving away cash prizes to participants of a talent show at the UniTeam campaign rally in Dasmariñas City.

Remulla, shrugged off vote-buying allegations, saying the campaign period for local candidates has not yet started. (PNA)

of SSS contributions, and non-reporting or under reporting of employees.

SSS Acting Head of Luzon South 1 Division Edwin S. Igharas said that non-compliant employers who received the notice shall be given 15 days to settle their legal obligation to SSS by availing the SSS Pandemic Relief and Restructuring Program: Enhanced Installment Payment Program (PRRP 3).

"Employers are accountable for the security protection of their workers. We are giving them a chance to comply by visiting the nearest SSS branch who has the jurisdiction of their business. For employers who have no financial capacity to immediately settle their contribution

delinquencies, we strongly recommend the availment of the installment program with payment terms ranging from nine to 60 months," Igharas said. Under PRRP 3, employers may select from the following payment options: (a) pay in full the principal obligation first and the corresponding penalties to be paid on installment; (b) apply the monthly installment/s to the principal ahead of the penalty/ies; or (c) pay in full the remaining delinquency at any time during the term of Installment Payment Agreement (IPA), subject to re-assessment of the penalty/ies, if applicable.

Aside from promoting the Pandemic Relief and Restructuring Program, Igharas also reminded all employers to register their business with the SSS by submitting the duly accomplished Employer Registration Form (SS Form R-1) and report their employees for SSS coverage using the Employment Report Form (SS Form R-1A) within 30 days from actual employment date. "They are also responsible for the remittance of their workers' contribution to the SSS. The employee's share in the monthly contribution should be deducted from their monthly salary and remit these together with the employer's share in SSS contribution, as well as the Employee's Compensation (EC) contribution. These payments should be reported to SSS thru submission of

electronic collection list or E-R3." Igharas explained.

Interested applicants may avail of the Pandemic Relief and Restructuring Program 3 (PRRP 3) until November 22, 2022. Further information on the documentary requirements and other terms and conditions can be accessed through this link https://bit.ly/3JwpmAa.

"Employers should take advantage of this final offer before it ends because this will ease their financial burden during this pandemic. What we want from business owners is for them to follow the law, regain their good SSS standing, and prioritize the welfare of their employees through active SSS membership," Igharas concluded.

## Chiz placed 2nd in PNU-North << P1

university in Manila, North Luzon, South Luzon, Visayas and Mindanao for the "Tindig PNUANS: 2022 PNY System-Wide Mock Elections".

In the PNU North Luzon campus, which is located in Alicia, Isabela, 55 percent of the respondents chose Escudero among the pre-listed candidates, based on the survey conducted from February 26 to March 11, 2022.

Over all, Escudero placed third with 1,720 votes, or 51.22 percent of the total student participants. On a campus basis, Mindanao gave Escudero the number No. 1 spot, while the veteran lawmaker was number two in PNU Visayas, number three in South Luzon, and

sixth in Manila. Escudero has been a consistent favorite among college students and school personnel as indicated by surveys conducted by various schools. Last month, the governor emerged as the number one choice for senator among respondents in the survey conducted by the Catholic Educational Association of the Philippines (CEAP).

A former senator for two terms, Escudero said he would focus on giving more autonomy to local government units, ensure the judicious and wise utilization of the annual budget, and help transition the pandemic-weary economy to recovery, among others, if elected again. President Duterte has endorsed Escudero's senatorial bid, saying the governor will play a big role in crafting key pieces of legislation and reforms at a time when the country is besieged with challenges brought about by the COVID-19 pandemic.

Duterte's daughter, Davao City Mayor and vice-presidential candidate Sara Duterte-Carpio is personally backing Escudero's Senate comeback bid.

The tandems of Senator Ping Lacson and Senate President Tito Sotto; Vice President Leni Robredo and Senator Kiko Pangilinan; and Senator Manny Pacquiao and Rep. Lito Atienza have adopted Escudero in their sen-

atorial slates. Mayors from CALABARZON (Cavite, Laguna, Batangas, Rizal and Quezon) and Eastern Samar, who belong to the League of Municipalities of the Philippines (LMP), have likewise endorsed Escudero.

Several party-list groups are also supporting his Senate return bid, namely Ang Probinsyano, Ang Kabuhayan, Agimat, An Waray, ARISE, BHW, BTS, Kusog Bikolano, KAPUSO-PM, and Magdalo.

He first conducted a motorcade across GMA then paid a courtesy call on local officials, including Mayor Maricel Torres, in the municipal hall.

During his meeting with the local executives, Pacquiao said he is intentionally not holding grand rallies, unlike other presidential bets, because he wants to reach out directly to the communities to disclose his plans and programs if he wins the presidential race.

"Ang kampanya ni Manny Pacquiao, hindi naglalagay ng stage na malaki at papuntahin mga tao, medyo abala na sa mga tao 'yun. Ako mismo bumababa sa mga maliit at mahihirap na lugar," he said. (We are not setting up big stages and calling people to attend because that's too much trouble for them. I am personally going to small and poor areas.)

"Yun ang pinupuntahan natin kasi hindi napupuntahan ang maliliit na bayanbayan. Mahihirap ang inuuna natin kasi gusto ko ipanalo ang mahihirap sa panahon ni Manny Pacquiao," he added.

(That's where we're going because they are not often visited. We are prioritizing the poor communities. I want to champion the poor.)

In response, Mayor Torres said they are glad that Pacquiao visited their town and she wished for the success of the boxer-turned-politician in his latest political fight.

"Kami ay masaya dahil kami ay nabigyan ng importansya. Kami ay mananalangin na ang ating laban na darating ay maging matagumpay at matiwasay," she said.

(We are happy that we are given importance. We are praying that our upcoming fight would be successful.)

GMA has about 92,000 registered voters.

From GMA, Pacquiao held a motorcade across Dasmariñas and then proceeded to the new municipal hall of Silang town where he spoke before residents. There are about 136,000 registered voters in Silang.

Pacquiao then visited the Mahogany Market in Tagaytay City where he was met with a crowd. From Tagaytay, which has more than 91,000 registered voters Pacquiao graced the program of the Philippine Councilors League-Quezon Chapter.

In his speech, Pacquiao said he is pushing for local autonomy.

"Ang funding ay ida-download na sa local government para ang local government na ang mag-implement ng mga proyekto. I-empower ang Sangguniang Bayan," he said.

(The funding will be downloaded to the local government so that it would be the local government who will implement the projects. We will also empower the Sangguniang Bayan.)

Extending the integrated LRT-1 line to a total of 32.4-km, the expanded LRT-1 will start from the existing Baclaran station to the Niyog Station in Bacoor, Cavite. It will be operated and managed by the private sector proponent.

The approximate cost of the extension and upgrade initiative is around P64.91 billion, which includes the P19.83-billion official development assistance component.

As of writing, LRMC has already accrued 16 new generation train sets, each accommodating a total capacity of about 1,400 passengers. They will undergo safety inspections and test runs before they're deployed sometime in the middle of 2022.

The construction of the LRT-1 Cavite extension project began in May 2019, per Railway Technology, after almost five years since the project was awarded to LRMC.

Once completed, it will boast eight stations and reduce travel time between Baclaran and Bacoor from 70 minutes to 25 minutes.

It will bring the total number of stations of the LRT-1 to 28 stations, which can serve almost 800,000 commuters every day, almost double its current ridership capacity of 458,000 per day. Included in its stations are three intermodal road-rail facilities which will allow for easy transfer between the LRT-1 to road-based public transportation vehicles.

The LRT extension project was supposed to begin in 2017, but was delayed due to right-of-way issues, as noted in an article by CNN Philippines. Authorities had to acquire land and transfer homes where the train tracks,

## Dasmariñas, inaugurates **Athletes' Quarters**

DASMARIÑAS, Cavite - The city government inaugurated its new Athletes' Quarters on Monday, March 21.

In a Facebook post, Mayor Jenny Austria-Barzaga said that the project is the local government unit's way of supporting athletes who give honor to the city.

### **Remulla vows Marcos** to win with 800K lead over rivals in Cavite

TAGAYTAY, Cavite: Reelectionist Cavite Gov. Jonvic Remulla assured survey frontrunner Ferdinand "Bongbong" Marcos Jr. of a win come May 2022 presidential polls.

In his remarks during an assembly of community leaders in the city on Tuesday, Remulla doubled down on his promise to deliver a big number of votes to Marcos in the upcoming presidential elections.

"Mr. President, noong ako ay nagpayabang nang konti, sinabi ko makakakuha ka ng 800,000 na boto dito sa Cavite, katakot takot na ibang kulay ang nagalit sakin, ang yabang ko raw (When I was boasting before, I said that you will get 800,000 votes here and a lot of people from various other political colors got mad at me and said I was boastful)," Remulla told Marcos.

"Sasagarin ko na ang yabang ko Mr. President, yung 800,000 pong yon ay hindi niyo boto, ayan lang po ang lamang na makukuha niyo dito sa Cavite (Let me boast some more Mr. President. The 800,000 that I'm talking about is not just votes, that will be your margin of victory here in Cavite)," he added.

Remulla made this promise as he pointed out that the Marcos family-during the time that it was in Malacañang-did a lot for Cavite in terms of expansion and progress.

"Lumaki ang Cavite dahil sa mga Marcos. Noong 1975 programa ni Madame Imelda na dalhin ang resettlement, lumaki ang Dasmariñas, nagkaroon ng GMA, lumaki ang General Trias, lumaki ang Bacoor. Ito ay dahil sa mga Marcos (Cavite was able to expand because of the Marcoses. Madame Imelda had a resettlement project in 1975, Dasmariñas became larger, GMA [General Mariano Alvarez] came into being, and General Trias and Bacoor became larger as well)," Remulla said, referring to former first lady Imelda, Bongbong's mother.

The governor also said that Cavite experienced progress when Mrs. Marcos opened its coastal road with the support of the late strongman president Ferdinand Marcos Sr.

"Imus, Bacoor, General Trias, and Dasamariñas, lahat ngayon naging lungsod dahil noong senador si Bongbong Marcos, sa kanyang committee, approved yung apat na city na dati munisipyo lang (Imus, Bacoor, General Trias, and Dasamariñas all became cities during Bongbong Marcos's stint as senator because it was his committee that approved their conversion from a municipality to a city)," he added.

The tandem of Marcos and Davao City Mayor Sara Duterte-Carpio, which continued to lead in the presidential and vice presidential race based on the latest Pulse Asia survey, visited the vote-rich Cavite the second time.

Cavite is among the most vote-rich provinces in the Philippines, with 2.35 million registered voters.
