100% on-site workforce in gov't offices under Level 1 ordered

Malacañang has issued a memorandum circular requiring all government agencies and instrumentalities to remain operational regardless of the Covid-19 alert level of the area where they are located.

Under Memorandum Circular No. 96 issued by the Office of the President, Cabinet Secretary Karlo Nograles said all agencies and instrumentalities of the government under Alert Level 1 "shall adhere to 100 percent on-site workforce."

CHIZ: LET LGUS MANAGE COVID ALERT LEVEL CLASSIFICATION

Senatorial candidate and Sorsogon Gov. Chiz Escudero said the national government should leave to local government units (LGUs) the management of alert level classification in their areas of jurisdiction since they are in a better position to assess the situation on the ground.

In an interview on CNN Philippines on Tuesday, Escudero said this function should have been devolved long time ago by the Department of Health (DOH) to LGUs instead of the current practice in which the Inter-Agency Task Force (IATF) solely determines the COVID-19 national alert level.

Minimum Health Protocols << P1

Cabinet Secretary Karlo Nograles, also acting presidential spokesperson, said in a briefing on Monday that workplaces should ensure a safe environment now that 100-percent capacity is allowed.

"Para magkaroon ng malusog at ligtas na workplace, kailangan maging aktibo ang health officers (To have healthy and safe workplaces, health officers must be active)," he said.

Face masks may be removed only when eating and drinking, participating in team and individual sports in venues where ventilation standards can be maintained, and when doing outdoor sports or exercise activities where physical distance can be maintained.

There should be a contingency plan in workplaces and proper air exchange, according to the set guidelines of the Department of Labor and Employment, as well sanitation facilities, Nograles stressed.

Flexible and alternative work arrangements will be allowed, as deemed appropriate based on function or individual risk.

The use of foot baths, disinfection tents, misting chambers, and sanitation booths for preventing and controlling Covid-19 transmission, and temperature checking prior to entry are no longer recommended.

The use of plastics or acrylic barriers and posting of safety seals are optional and as appropriate, he added.

"Dahil sa ating pakikipagtulungan maari na nating luwagan ang mga

The Inter-Agency Task Force announced Sunday that the National Capital Region and 38 other areas nationwide will be placed under the most lenient Alert Level 1 classification for the first half of March. The 38 others are Abra, Apayao, Baguio City, and Kalinga in the Cordillera Administrative Region; Dagupan City, Ilocos Norte, Ilocos Sur, La Union, and Pangasinan in Region 1 (Ilocos); Batanes, Cagayan, City of Santiago, Isabela, and Quirino in Region 2 (Cagayan Valley); Angeles City, Aurora, Bataan, Bulacan, Olongapo City, Pampanga, and Tarlac in Region 3 (Central Luzon); Cavite and Laguna in Region 4-A (Calabarzon); Marinduque, Puerto Princesa City, and Romblon in Region 4-B (Mimaropa); and Naga City and Catanduanes in Region 5 (Bicol).

In the Visayas, under Alert Level 1 are Aklan, Bacolod City, Capiz, and Guimaras in Region 6 (Western Visayas); Siquijor in Region 7 (Central Visayas); and Biliran in Region 8 (Eastern Visayas).

In Mindanao, the areas under Alert Level 1 are Zamboanga City in Region 9 (Zamboanga Peninsula); Cagayan de Oro City and Camiguin in Region 10 (Northern Mindanao); and Davao City in Region 11 (Davao).

Public transportation can also operate at full capacity under Alert Level 1 while proof of full vaccination of

those aged 18 and above must be presented when attending mass gatherings or going to indoor establishments such as food preparation establishments, personal care establishments, fitness studios, gyms, venues for exercise and sports, hotels and accommodation, and election-related events. Meanwhile, the Department of Labor and Employment (DOLE) said the wearing of face masks is still mandatory both indoors and outdoors for employees despite Metro Manila's shift to Alert Level 1. "Again I would like to remind everyone that because Covid-19 is still here although Alert Level 1, what is required for all indoor and outdoor is the use of mask. The mask should be worn because this is a primary protection tool and second that there should be good ventilation in all office spaces," Labor Assistant Secretary Ma. Teresita Cucueco said in a virtual forum on Monday.

She added that the full vaccination requirement for onsite workers will also stay.

"It was released by the IATF last year, the IATF Resolution 148-B. So until there...you know this has also been challenged in the courts so we are not also...we are also very careful discussing this and unless the courts decide or unless national government will have an issuance, then it will continue to be implemented," she added.

Cucueco, also head of the agency's Bureau of Working Conditions (BWC) also said vaccines remain effective in preventing the spread of Covid-19 in the workplace.

"You know that the vaccine still provides protection and even if we say even if one is vaccinated, it does not guarantee that you will not get infected. We will pay more attention to those who have not been vaccinated because they are the ones

who can be in severe, critical condition that's why we keep an eye on the test. If there is a positive test, manage the (spread of the) disease immediately," she said. She added that they will continue to come up with mechanisms and strategies to respond to the circumstances posed by the Covid-19 situation. At the same time, she reported that the majority of workers in the manufacturing sector are vaccinated. "We know there are many, especially in the manufacturing sector, almost 95 percent of their workers," Cucueco added. (with Ferdinand Patinio/ PNA)

ber of people who can enter the venues. It maxes at 70 percent. We want to keep, still don't want to do 100 percent. Obviously, there is still a pandemic, only Level 1," Comelec spokesperson James Jimenez said in a virtual media briefing.

On Sunday, the Inter-Agency Task Force for the Management of Emerging Infectious Diseases (IATF) said 39 areas, including the National Capital Region, will be placed under the most lenient Alert Level 1 classification for the first half of March.

Under Alert Level 1, the IATF said there are no restrictions in terms of indoor and outdoor capacities. Everyone can undertake intrazonal and interzonal travel without regard to age and even comorbidities.

All establishments, persons, or activities are likewise allowed to operate, work, or be undertaken at total onsite or venue seating capacity, provided these are consistent with minimum public health standards.

"Biggest news Comelec is the use of face shield. It is only voluntary. Under IATF-EID rules, Level 1 still includes the voluntary use of face shields. As far as everything else is concerned in the campaign, we are already at minimum health protocols, we are doing the barest minimum necessary to keep everyone safe,"

Jimenez said.

He said the Comelec has yet to receive a request to relax their guidelines from the candidates even in areas under Alert Level 1.

"In the meantime, we are still not in receipt of any formal requests to relax our guidelines so we will continue with our guidelines as they are," Jimenez said. "Our guidelines are calibrated. They are responsive to changes of alert level by IATF."

Other areas under Alert Level 1 are: Abra, Aklan, Angeles City, Apayao, Aurora, Bacolod City, Baguio City, Bataan, Batanes, Biliran, Bulacan, Cagayan, Cagayan de Oro City, Camiguin, Capiz, Catanduanes, Cavite, Dagupan City, City of Santiago, Davao City, Guimaras, Ilocos

Norte, Ilocos Sur, Isabela, Kalinga, Laguna, La Union, Marinduque, Naga City, Olongapo City, Pampanga, Pangasinan, Puerto Princesa City, Quirino, Romblon, Siquijor, Tarlac, and Zamboanga City.

provided these are consistent with minimum public health standards. The MC 96 further provides that under Alert Level 2, Nograles said all agencies and instrumentalities must adhere to at least 80 percent on-site workforce, 60 percent under Alert Level 3, and at least 40 percent onsite workforce under Alert Level 4. Under Alert Level 5, skeleton workforce on-site and the remainder under alternative work arrangements as approved by the head of the agency unless a greater on-site capacity is required in agencies providing health and emergency frontline services, laboratory and testing services, border control, or other critical services. "The aforesaid issuance is intended to balance health considerations and the continuous delivery of public services, consistent with the updated Alert Level System," Nograles said. (PNA)

The staff and volunteers of PRC also provided psychosocial aid to 57 individuals besides preparing hot meals to 464 affected individuals, serving them hot chicken congee with egg.

Gordon reminded the public of fire safety in observation of the fire prevention month in March.

PRC said that it is continuously distributing relief items to the affected residents and will coordinate with the local government unit for additional aid and monitoring the status in the evacuation center.

Red Cross quickly responds to Cavite fire victims

THE Philippine Red Cross (PRC) deployed its Hot Meals on Wheels, providing ready-to-eat meals and first aid to 464 individuals after a fire broke out in Barangay 10-A Santa Cruz, Cavite City on Sunday, February 27.

PRC Chairman and Chief Executive Officer Richard Gordon said every time there were fire incidents, immediate and urgent help should be rendered to the fire victims and that had been the mandate of the Red Cross team. For that fire incident, the PRC immediately provided 15 staff members and volunteers to set up a first aid station and a welfare desk at the Santa Cruz Elementary School Evacuation Center.

According to reports, an estimated 200 families were affected by the fire incident. The staff and volunteers of

the PRC also provided psychosocial aid to 57 individuals besides preparing hot meals for affected individuals, serving them hot chicken congee with egg.

Gordon reminded the public of fire safety in observation of Fire Prevention Month in March.

VP Leni Wins Over Manileños, Banters with Youth

Thousands of Manileños representing women, the youth, LGBTQIA+, and other sectors marched from España Boulevard to Plaza Noli in Sampaloc, Manila on Wednesday March 2, to declare their support for Vice President Leni Robredo's presidential bid.

The march, called the Pink Magic of Hope, was organized in celebration of International Women's Month by Robredo People's Council Manila, in coordination with former Manila 6th District Rep. Rosenda Ann "Sandy" Ocampo, Manila 1st District Rep. Benjamin "Atong" Asilo, Team Leni Robredo (TLR) Manila, Distrito KwatRobredo, and Ina ng Bayan Organization in line with 1 Billion Rising, a global strike to demand an end to violence experienced by more than one billion women around the world. "Natutuwa ako dahil hindi lang lahat kababaihan nandito, marami ding mga lalaki, maraming mga LGBTQIA+. Pagpapakita lang na ano man 'yung pinanggalingan natin, anuman kasarian natin, iisa lang naman ang pinaglalaban natin. Nandito tayo lahat para ipaglaban ang magandang kinabukasan para sa ating lahat," said Robredo. The presence of so many young people in the crowd fostered a more informal atmosphere, with Robredo taking the time to read handwritten placards held up by supporters and to react to interjections from the audience. "Sumakit ang paa dahil sa debate... three hours nakatayo... iluklok sa puwesto para makaupo," she read one. "Mga takas sa bahay for Leni" she read, to laughter from the audience. "Oy! Hindi tayo kumukunsinti niyan ah!" "[R]amdam na ramdam namin na kasama namin kayo sa laban na ito. Alam niyo po, kahit saan kami pumunta, ang pagmamahal niyo, ang suporta niyo, pero higit sa lahat, 'yung realization na nandito kayo hindi lang para ipanalo ako, pero nandito kayo para ipanalo 'yung bayan natin na minamahal natin lahat," said Robredo. Even as Robredo asked for the commitment of the volunteers to exert greater effort in the remaining days of the presidential campaign, she pledged that her supporters would see a government that listens, puts the interests of the people above all, and will be free from corruption.
