## Kuwaresma 2020, Pagtitika, Posible pa Ba Bayan?

Taun-taon na lang ay ginugunita ang Mahal na Araw. Ganun lang, di naman pinahahalagahan at isinasabuhay. Dapat dama ang mensahe ng Kuwaresma maging sa ating palagiang pagsisimba. Ang pangangilin, datna't panawan ng panahon at mga taon. Ganap bang sa pangangarap na lang ng magandang maaring maganap sa awa ng Panginoon tayo tutuon at di na kikilos para ang tunay na Diwa ng Semana ay matunton? Hindi naman siguro bago sa ating pandinig ang salitang "Kuwaresma" diba? Taon-taon ito ipinagdiriwang ng lahat ng mga Kristiyano ngunit hindi lahat ay binibigyan ito ng imporsansa. Dapat malaman ng mga tao ang ibig sabihin nito upang matutunan nilang magnilay-nilay at mabigyan ito ng tunay na pagpapalaga. Ang kuwaresma o Lent sa salitang Ingles ay nangangahulugan na "tagsibol". ## Microbial Omics for Environmental Protection and Sustainability Development

Conduct this policy forum. Academician Rhodora V. Azanza, NAST presideng said that this forum has been conducted for faculty members from higher educational institutions in the Phils to be updated with the new and current technologies involving metagenomics and other "omics".

Academician Concepcion's topic on "Genomics and Metagenomics of Shipwreck-Associated Bacterial Communities" clarified that those kind of microbes largely live and survive among logging areas found in Sultan Kudarat. In the case of Dr. Leopold Ilag, a Los Banos grown scientist but based in Sweden, the audience were clearly informed on the Environmental Monitoring and Proteomics of Natural Toxins. Were clearly informed... and Proteomics.. On the other hand, NAST Executive Dir. Lunynging Sanarita Domingo summarized the objectives of this science policy forum. And these are informing the public on the role of microbes and the use of new technologies for sustainability and protection of the environment. Dr. Doralyn S. Dalisay, who is with me in foto discussed the "Genomics and Metabolomics of Antibiotic-Producing Microorganisms from Marine Sediments. She is a professor of the Institute of Biological Chemistry from the University of San Agustin in Iloilo. In the Closing remarks Acd. Virginia C. Cuevas lauded the contribution of all those who have been instrumental to the success of the Science Policy Forum. All were contented with the various discussions per important roles of microorganisms in environment sustainability and conservation. The identification and expound on Omics that can be utilized on microbes associated with the environment was also taken. ## Lifting of travel ban for HK, Macau OFWs 'right thing to do'—Recto

The decision of the government to allow Filipinos to return to their work in Hong Kong and Macau is a step in the right direction.

This will save the jobs of thousands of Filipinos who were vacationing in their home country when their government imposed a travel ban to those two places.

The lifting of the ban, in effect, rescues these stranded workers from unemployment and their families from penury.

In their appeal to be allowed to travel back to their waiting employers who value their services, they warned that injury from certain loss of income is greater than the possibility of being infected by the virus.

As to the latter, the SARS-tested health system of Hong Kong is in a better position to treat coronavirus patients than our hospitals here, and the HK government has assured us that they will take good care of our people.

Our compatriots in Hong Kong and Macau form one powerhouse when it comes to sending money to their loved ones back home.

About a quarter million of them remitted close to P100 billion from 2018 to 2019.

This economic contribution is so great that the government could either subsidize or shoulder the plane fare of the stranded OFWs, because the cost is a small fraction of their remittances of about 1 billion pesos every 10 days.

# CIVIC, PRIVATE GROUPS JOIN CAVITE GOV'T IN HEALTHCARE SERVICE DELIVERY EVENT

*The Caviteños UK Association, an organization of Cavite natives based in the United Kingdom, joined the Provincial Government of Cavite, led by Governor Jonvic Remulla, the City Government of General Trias and the City Government of Trece Martires in delivering healthcare services to a total of 2,469 residents in the province held at Trece Martires City Hall on February 7, 2020.*

The team of physicians, dentists, and other medical professionals from General Emilio Aguinaldo Memorial Hospital (GEAMH), City Health Offices of General Trias and Trece Martires, Philippine Coast Guard Auxiliary 125th Squadron, Philippine Guardians Brotherhood, Incorporated-Taytay, Rizal Chapter and Cavite Medical Society provided free pediatric checkups to 1,002 patients and dental services, including tooth extraction and oral prophylaxis to 105 individuals.

Multilab Diagnostic and Health Services also joined the event, providing free ECG, X-Ray, and blood sugar testing, while United Labo-

ratories (Unilab) conducted anemia screening. Acupuncture and ear candling services were also available for the participants, courtesy of teachers and students from the New Generation International School. Wart removal services were also provided by AR Skin Med Spa.

Meanwhile, the medical personnel from Provincial Health Office conducted vaccination, deworming and skin care checkup, distributed soaps, ointments and contraceptives and other family planning supplies and also gave lectures on good nutrition, while personnel from the Provincial Population Office provided family planning counseling.



The Obstetrics and Gynecology Department of GEAMH also provided a lecture and counseling prior to the conduct of cervical cancer screening to 50 adult women.

Participants in the mission were also able to avail free vitamins and prescription medicines, hygiene and emergency kits as well as insect repellent lotions from the Office of the Provincial

Governor and the Provincial Disaster Risk Reduction and Management Office.

The Caviteños UK Association also offered dental care kits and reading glasses.

Caviteños UK Association, who helped organized the program, was represented during the event by Ms. Arlene Oxida-Cañada and Mr. Lito Famy.

Their group has previously organized medical mis-

sions in the province, including those conducted for the 900 residents of Poblacion, Indang, Cavite on February 8, 2019 and for the 1,573 residents of Alfonso, Cavite on February 4, 2020.

Several local officials were present during the event to affirm their support for the Provincial Government's health programs, including Vice-Governor Jolo Revilla, Sixth District Board Member
