

Calabarzon sees employment growth as economy recovers

CALAMBA CITY, Laguna (PIA) — More than two years into on and off economic activities, Calabarzon is finally seeing consistent improvement in the labor and employment sector, which has been greatly affected by the COVID-19 pandemic.

The National Economic and Development Authority (NEDA) Region IV-A reported Thursday, April 21, that the region's labor and employment situation has improved during the first quarter of this year.

Economic Development Specialist Jennylyn Jucutan, during the Regional Task Force Inter-Cluster Meeting, said the labor participation rate is at 62.2 percent, at least 2 percent higher than the national rate of 60.5 percent. This figure manifests the Calabarzon's

President Duterte to lead PNPA graduation rites

SILANG, Cavite (PIA) — President Rodrigo Roa Duterte will lead the 43rd commencement exercises for the 2022 ALAB-KALIS Class of the Philippine National Police Academy (PNPA) today at the Camp General Mariano Castañeda in Silang Cavite.

It will be the first time since 2019 that President Duterte will be physically present at the PNPA's graduation rites after pandemic protocols prevented the chief executive from joining the graduating cadets on site. The President only addressed the graduates virtually in 2020 and 2021.

Expected to join the President are PNP Chief General Dionardo Carlos and Department of the Interior and Local Government (DILG) Secretary Eduardo

DOH Calabarzon to rollout second COVID-19 booster shot

CALAMBA CITY (PIA) – Individuals eligible for the second dose of Covid-19 booster vaccines have the option to choose the type of vaccine they will receive, according to the Department of Health Center for Health Development Calabarzon.

Citing the Department Memorandum No. 2022-0154 signed by Undersecretary Myrna Cabotaje, the Calabarzon Regional Vaccine Operation Center (RVOC), on Monday, April 25, has greenlit the rollout of additional booster doses to fully vaccinated individuals at least three months after getting their first booster dose.

The administration of the fourth Covid-19 vaccine dose in the Calabarzon region will start on April 28.

CALAX Silang (Aguinaldo) << P1

President and General Manager Roberto V. Bontia told BusinessWorld in a recent interview.

"Yan 'yung segment na that we are expecting na magkakaroon ng malaking traffic kasi (We expect huge traffic on this segment because) it will be an interchange directly coming from Aguinaldo Highway," he added.

The company holds the concession for CALAX with a 35-year concession period. The project connects Manila-Cavite Expressway (CAVITEX) and South Luzon Expressway (SLEX).

"The Subsection 4, we are expecting to complete that by the third quarter or early fourth quarter of this year. That's expected to open," Mr. Bontia noted.

The CALAX project has eight subsections: Kawit to

Open Canal (subsection 1), Open Canal to Governor's Drive (subsection 2), Governor's Drive to Silang (subsection 3), Silang to Silang East (subsection 4), Silang East to Santa Rosa (subsection 5), and Santa Rosa to Mamplasan (subsections 6, 7, & 8).

Subsections 6 to 8 started operations in 2019 and CALAX Laguna segment interchanges, which are part of the subsections 6 to 8, opened the following year. These interchanges are the Laguna Boulevard Interchange and the Laguna Technopark Interchange.

"Yung Cavite portion, 'yung Subsections 1 to 3, ongoing pa rin 'yung right-ofway acquisition (The rightof-way acquisition process for the Cavite portion is still ongoing)," Mr. Bontia said.

"But as we speak, there

are about six areas where construction is already in progress." Last year, CA-LAX Subsection 5, which connects Silang East to Sta. Rosa-Tagaytay Road Interchange, was inaugurated, extending the expressway's operating sections from 10 to 14.24 kilometers.

Full completion of the 45-kilometer CALAX project is expected in 2023.

According to the Department of Public Works and Highways, the project is expected to provide efficient transport facilities for the ecozones in Cavite and La-

It is also seen to reduce traffic congestion, particularly in Governor's Drive, Aguinaldo Highway and Sta. Rosa-Tagaytay Road, and boost the competitiveness of Region IV-A or CALABAR-

ZON (Cavite, Laguna, Batangas, Rizal, and Quezon) as an investment destination.

Once fully operational, the project is expected to cut travel time between the CAVITEX and SLEX to 45 minutes from the current 2.5

MPCALA Holdings is a subsidiary of Metro Pacific Tollways Corp., the tollways unit of Metro Pacific Investments Corp., which is one of three key Philippine units of Hong Kong-based First Pacific Co. Ltd., the others being Philex Mining Corp. and PLDT, Inc.

Hastings Holdings, Inc., a unit of PLDT Beneficial Trust Fund subsidiary MediaQuest Holdings, Inc., has a majority stake in Business-World through the Philippine Star Group, which it controls. — Arjay L. Balinbin

A report read during CICC's briefing by agency executive director Undersecretary Cezar Mancao II and Philippine National Police Anti-Cybercrime Group (PNP-ACG) head Brig. Gen. Robert Rodriguez said that the operation was conducted on April 23, with CICC and PNP-ACG agents posing as clients to buy the stolen data.

Aside from interfering with Comelec, the hackers also claimed that they can change the election results by accessing the system of

"On 23 April 2022, at around 2 p.m., cybercrime investigation and coordinating center together with the PNP Anti Cybercrime Group, conducted an entrapment operation in Imus Cavite and Sta. Rosa Laguna against notorious hackers named 'XSOS group' who are claiming to have illegally accessed the Smartmatic system, and can influence the result of the coming national

elections on May 9," a CICC hacking of local commercial officer read.

"The entrapment operations resulted in the apprehensions of these personalities namely Joel Adajar Ilagan a.k.a 'Borger', Adrian de Jesus Martinez a.k.a. 'AdminX', and Jeffrey Cruz Limpiado a.k.a. 'Brake/ Vanguard/ Universal/ LLR," it added.

Initial findings, according to CICC, revealed that the group was also responsible for the previous hacking incidents trageting Comelec, along with other reports of websites.

"Initial findings reveal that the above-mentioned group violated the Cybercrime Prevention Act of 2012 [...] specifically by hacking the Smartmatic system; number two, disrupting the Comelec website; number three, hacking the Napocor website; number four, hacking the credit cards and other online transactions; number five ransomware committed against local commercial website," CICC noted.

Bacoor learners receive ICT devices from DICT

BACOOR CITY, Cavite (PIA) — Students from various schools in this city will now be able to keep up with their online learning with the help of the Digital Education Program and Cybersafe Learning for Education Project of the Department of Information and Communications Technology (DICT).

The DICT recently donated information and communications technology devices such as laptops to Bacoor schools as part of its efforts to support the digitalization of education in the country

The TUCP said that the impact of the last minimum wage increases in the region, in 2018, "has long dissipat-

"How can workers and their families cope with skyrocketing prices of food and commodities with such ridiculously low wages?" it added.

The TUCP said the takehome pay of a minimum wage earner in the region is currently between P279 and P371 per day after deductions. "Minimum wages have been below poverty thresholds in Calabarzon, and the gaps have been widening."

It said current take home pay levels imply that families of minimum wage workers can spend P11-P14 per meal. "Clearly, the amounts cannot provide for the recommended nutritional requirements for a family of five, not by any stretch of the imagination."

Calabarzon is a key industrial region, "hosting the highest concentration of manufacturing activity with automotive assemblers predominantly located in Laguna, semiconductors, high-tech industries and electronics in Cavite and Batangas, and garments manufacturers in Rizal," according to a study published by Oxford Business Group.

The region accounted for 14.5% of the country's economic output in 2020.

The TUCP on April 5 refiled its petition for a P470 increase in the minimum wage for Metro Manila, after the wage board dismissed an earlier filing due to jurisdic-

The TUCP also filed a P440 minimum wage hike petition in the Bicol region.

The organization noted that Bicol's last wage board decision was in August 2018. Wage boards typically start hearing new petitions on the anniversary of the last board

labor sector recovery despite the continued retrenchments and shutdowns among establishments in the region, as recorded by the Department of Labor and Employment (DOLE) Region IV-A.

The employment rate also improved to 92.6 percent compared to 89.7 percent in the previous quarter and 86.8 percent in the first quarter of 2021.

Jucuatan also reported that the percentage of unemployed Filipinos in the region plummeted to 7.4 while the underemployment rate dropped to 13.7. It can be recalled that Socioeconomic Planning Secretary Karl Kendrick T. Chua attributed the significant employment outcomes to increased mobility as the government eased restrictions in more areas in the country.

Imus City New Government Center officially opens



Clean-up drives sa Calabarzon, napigilan ang 800 toneladang basura na maanod sa Manila Bay



CALAMBA CITY, Laguna (PIA) — Higit 800 tonelada ng mga basura mula sa Cavite, Laguna, Batangas, at Rizal ang napigilang maanod sa Manila Bay dahil sa mga inilagay na trash traps at regular na clean-up activities ng Manila Bay Site Coordinating and Management Office (MBSCMO)-4 at ng Department of Environment and Natural Resources (DENR) CALABARZON.

Nahakot ang halos 600 toneladang basura mula sa mga clean-up activities ng mga itinilagang 465 river rangers, at ang natitirang 200 tonelada naman ay napigilan ng 82 trash traps. Karamihan sa mga basurang nakolekta ay mula sa Cavite na may 634 tonelada, 120 tonelada mula sa Rizal, 68 tonelada sa Batangas, at 56 tonelada sa Laguna.

Ayon sa DENR CALABARZON, ang mga nakolektang basura ay dinala sa mga sanitary landfills at materials recovery facilities (MRF) ng mga lokal na pamahalaan.

IMUS CITY, Cavite (PIA) - Imus City residents can expect a much better service from the city government now that its 72 offices are housed under one roof with the opening of the new Imus City Government Center. City Mayor Emmanuel Maliksi, who led the inauguration of the new government center on Monday, April 25, said, "while the fight against the Covid-19 crisis is the city government's top priority, this should not hinder the administration's desire to accomplish other programs and projects aimed at providing for the welfare of the citizens.."

The building, which is

part of the legacy projects of Mayor Maliksi's administration, is designed to be an 'Eco-Friendly Green Building' because of the green architectural principles, such as the solar panels installed to power its lighting and other electrical fixtures. A rainwater harvesting system stored in tanks can supply the building occupants for at least four days.

Also, a sewage treatment plant ensures water wastes are safe and treated before it is released into the sewerage, while a material recovery facility contributes to the solid waste management and recycling as well. All these features aim to lessen its carbon footprint from its daily operations. The government building is also considered a "Smart Building" because of its computer-based building management and maintenance system. The system could control all lighting, the alarm system, its elevator system, 500 CCTV surveillance

cameras, and other facilities to give access to persons with disabilities. The 53,761 sqm lot is located at Pedro Reyes St. in Barangay Malagasang I-G, while the Executive Building sits on the 32,871 sqm area near the Ospital ng Imus and Imus Grandstand. - RBE PIA Cavite
