He particularly noted that the ongoing development in Clark City, which is a vital part of the Luzon Economic Corridor, has become an attractive destination for foreign investments due to the establishment of the Clark Freeport and Special Economic Zone.

"I expect it to be mostly companies," American President Marcos said. "They have come in, and I like to think that the reason for that is because we have set up the system that's attractive for

their investment. And so, we'll continue to [do] that and will be able to do even better if the [Luzon Economic] corridor is completed, and the travel times and the cost of travel of transport will be brought down."

He pointed out that the ecozones offer one common tax code and incentive scheme locator companies do not have to deal with every local government unit.

The President said the ecozones are open to all investors looking for special incentives and special tax breaks. "We have right now economic zones where

anyone can participate," Marcos said. "It's not specifically only for Korea, only for one industry... but it's open for everyone and what it provides. It provides a place where there are special incentives, special tax breaks specially tariffs on importation, sales tax because they don't sell into the country."

President Marcos noted that Philippine special zones have been successful, adding that the government is counting on them to bring more success in the country.

The Bases Conversion and Development Authority earlier said the Subic-Clark Railway Project, expansion of the Clark International Airport, and the Clark National Food Hub are pitched to American and Japanese investors under the USD600-billion Partnership for Global Infrastructure and Investment of the G7 countries.

BCDA said the three projects are being endorsed for the proposed Luzon Economic Corridor.

PEATC demands turnover of Cavitex: It's gov't property

Public Estates The Authority Tollways Corp. (PEATC) on Friday demanded the turnover of the operations and maintenance (O&M) of the Manila-Cavite Expressway (Cavitex) from the Cavitex Infrastructure Co. (CIC).

In a press conference in Quezon City, PEATC President and Officer in Charge (OIC) Steve Esteban said the operations and maintenance agreement (OMA) that gave CIC the O&M responsibility of Cavitex ended on Aug. 25, 2021, based on Philippine Reclamation Authority (PRA) Board Resolution

Esteban said the O&M of Cavitex should have been turned over to PEATC - a government-owned -controlled corporation created by the PRA for tollways management - beginning Jan. 1, 2022.

"Patuloy ang pag-uusap ng PRA at CIC, pero ang kagustuhan ng CIC ay sila ang masusunod (The PRA continues to discuss this with the CIC, but the latter insists that they should be the one in charge)," he said.

From the current 90 percent to 10 percent revenue-sharing in favor of CIC, he said Cavitex revenue-sharing would change to 60 percent to 40 percent in favor of the government once the O&M returns to PEATC.

He noted that a toll decrease on Cavitex is possible once the O&M of Cavitex is returned to the government.

"A writ of mandamus is the first step towards that direction. We need that to calculate how much we should be charging for," Esteban said.

In February, a writ of mandamus was filed before the Court of Appeals (CA) due to the CIC's refusal to turn over Cavitex.

Esteban emphasized that the case is not a dispute, but is a request for help from the CA for the proper turnover of the project, and thereby not part of any arbitration agreement.

"Bakit sinasabing walang dispute? Kasi ang mandamus, it means ministerial duty. Meron duty itong taong ito na hindi niya ginagawa (Why are we saying there is no dispute? Because

mandamus is about ministerial duty. This person has a duty that they're neglecting). They should comply," he said.

He added that the Commission on Audit (COA) has sent the PEATC multiple audit observation memos due to their failure to take control of Cavitex, noting that the CIC is immune from the same government oversight as a private company.

"Walang kontrol ang gobyerno sa budget nila. So hindi sila pwede i-audit ng COA (The government has no control over CIC's budget. That's why COA can't audit them)," Esteban pointed out.

In addition to CIC's refusal to turn over Cavitex, Esteban alleged that he witnessed "rampant corruption" in CIC's operations through the existence of tollbooths with no point-of-sale (POS) machines.

These toll booths, he said, still receive payment from expressway users despite not recording these transactions in their system, and thus are untaxed reve-

During the press conference, representatives of the Cavitex security workers union and the PEA Tollways Union (PEATEU) - workers who provide security and manpower on Cavitex tollbooths - also alleged that the CIC has disallowed wage increases for the past decade and refused to provide adequate equipment.

These union representatives said that computer sys-

tems used in toll collection have been left with broken air conditioners (AC), resulting in system failures and hassle to toll users, in addition to letting employees use old and dilapidated vehicles and other equipment.

Ex-CA Justice Sadang named new PCGG chief

President Ferdinand R. Marcos Jr. has named retired Court of Appeals (CA) Justice Melchor Sadang as the new chairman of the Presidential Commission on Good Government (PCGG).

The Presidential Communications Office (PCO) announced Sadang's new designation in a Facebook post on Monday, along with the latest batch of appointments made by Marcos in at least 13 government agencies.

Under the supervision of the Department of Justice, the PCGG serves as an anti-corruption agency tasked to investigate graft and corruption cases of public officials and institute measures to prevent unlawful practices in government.

Sadang served as a CA magistrate from 2011 to 2017 and a presiding judge of the Cavite City Regional Trial Court from 2000 to 2011.

Sadang was one of the five-man committee that led the government's massive investigation into the alleged drug links of third-level police officers last year.

Aside from Sadang, Marcos also appointed Charlito Martin Mendoza and Domini Velasquez as Undersecretaries of the Department of Finance (DOF); Asis Perez as Undersecretary of the Department of Agriculture (DA); and Jesus Nathanial Martin Gonzales as Undersecretary of the Department of Transportation.

Noah Dimaporo and Alexandra Lumontad were appointed Collector of Customs VI under the DOF's Bureau of Customs, while Gilbert Sosa was named acting chair and member of the Board of Directors of the Development Bank of the Philippines (DBP) Data Center Inc.

Also included in the list of latest presidential appointees were Arlexandria Louise Cariño, Director IV of the Office of the President under the Office of the Special Assistant to the President for Investment and Economic Affairs; and Manuel Barrios, regular member of the Supreme Court's Legal Education Board (LEB) representing the Philippine Association of Law Professors, while Voltaire San Pedro will serve as LEB's regular member representing the Philippine Association of Law Schools.

Marcos also designated Eduardo Saguil as member of the Board of Directors of the DBP; Martin John Yasay as Deputy Commissioner of the Insurance Commission; Eva Arcos as member of the Social Security System Board representing the Workers' Group of the Social Security Commission.

Salma Angkaya-Kuhutan, Mohamad Dimaporo, Analiza Flores, Catherine Magana, Ma. Cristina Malab, and Ronaldo Tepora were named members of the Board of Directors of the Al-Amanah Islamic Investment Bank of the Philippines.

Based on the new set of presidential appointees, Ethel Valenzuela was tapped as Commission on Higher Education Commissioner; Rose Marie J. Arenas as a member of the Board of Directors of the Manila Economic and Cultural Office; and Dahlialyn Dait-Cawed as Director IV of the National Commission on Indigenous Peoples.
