4 data centers eye to sign up with PEZA

The Philippine Economic Zone Authority (PEZA) said at least four hyperscalers are looking into investing in the country through the investment promotion agency.

In an interview Tuesday, PEZA deputy director general Tereso Panga said the capacity of these data center operators ranges from 30 to 100 megawatts.

Panga said the companies are still waiting for the developments of the May 9 polls before proceeding to their investment decision.

"These are big players aggressively looking for a site already," he said, adding that these firms are eyeing the provinces of Bulacan, Cavite, and Laguna. Hyperscalers are providers of scalable data storage services.

This campaign led her to the Cavite Provincial Capitol, where she is expected to support policies that will protect women and their children and create economic opportunities for them. Further south, five female district representatives from Laguna promised to raise women's issues to the national level and usher in policies that will benefit Filipino women and girls. Despite being newcomers, Ann Matibag, Cha Hernandez, and Jam Agarao said they were ready to enter Batasang Pambansa armed with their experiences in the local legislature.

Known for her 'Lagu-Nanay' campaign, Matibag championed women's causes and pushed for breastfeeding as a healthy method of nurturing infants and toddlers.

Meanwhile, Hernandez ushered ordinances that pushed for the welfare of the youth sector, while Agarao vowed to bring more health and social services to the province's fourth district.

They are expected to join second district representative Ruth Mariano-Hernandez who authored bills promoting the rights of abandoned children, expanding prohibited acts of gender-based discrimination, and protecting women's rights in the labor force, among others.

In the next three years, the electorate expects to see a new brand of leadership from these women, launching programs and passing legislation that will bring inclusive and development sustainable even to the farthest corners of this region. — Bermudez, PIA 4A

Sara eyes 'patriotic, disciplined' grads with DepEd role

With presumptive Vice President Sara Duterte-Carpio set to be appointed as education secretary, her camp said she intends to produce peace-loving and patriotic graduates who can contribute to their communities. "Our country needs a future generation of patriotic Filipinos that advocate peace and discipline in their respective communities," Duterte-Carpio said in a statement Thursday.

This came as the College Editors Guild of the Philippines (CEGP) expressed apprehension that Sara will be "an education predator with her history of violence, abuse, and impunity."

"We cannot afford to be under a Duterte learning system that killed lives and dreams again," CEGP Secretary-General Regina Tolentino said in a Facebook post, in an apparent response to Duterte's impending appointment. Tolentino did not offer any evidence to any

Her group, however, is opposed to the implementation of the Reserve Officers Training Corps (ROTC) in universities, which the CEGP has repeatedly slammed in the past as it "only legitimizes abuses."

The National Task Force to End Local Communist Armed Conflict has identified CEGP as among the leftist organizations that have recruited college students to become armed combatants of the communist New People's Army.

Meanwhile, Department of Education (DepEd) outgoing Secretary Leonor Briones welcomed the announcement of Duterte-Carpio's running mate, presumptive President Ferdinand Marcos Jr. to install Duterte-Carpio in her place.

Cerezo, Lucena City Director Danilo A. Nonance annual assessment bleza, Mr. Don Ayer A. and on-site validation on Abrazaldo, Chief-Local Government Monitoring and Evaluation Division and other DILG employees. The assessment team validated and assessed the documents submitted in the ten governance areas which include Environmental Management,

POPCOM holds a three-day workshop on Population and Development



in strengthening population development, the Provincial Population Office ia cilitated a three-day Planning Workshop on the Localization of PPDP and Establishment of Database thru PopDev Mentoring among Cavite Local Population Officers and Local Planning Team from May 4-6, 2022. The activity aimed to orient participants on Philippine Population and Development Program (PPDP) Thrust and Directions, and level up knowledge and skills in developing and enhancing local plans and programs through PopDev integration. It also sought to deepen the technical competency of the local planning team and provide mentorship to improve local programs on population development. The presenters and facilitators on the planning workshop were POPCOM IV Assistant Regional Director Marilyn F. Ogaya, Ms. Josephine L. Santos - Information Officer III, and Ms. Michelle Plezas - Project Evaluation Officer I. The event was in a hybrid mode with attendees joining face-to-face and via Zoom teleconferencing. Population Offices' employees attended the first day. During the preliminaries, Mr. Alvin S. Mojica, Provincial Administrator for Community Affairs, gave a welcoming message while Ms. Lorena R. Cron, Provincial Population Officer, acknowledged the attendees.

The meeting proper was divided into three sessions: the discussion of PPDP Thrust for 2022-2028; the overview of the PopDev Integration Program and PopDev Mentoring Approach; and the talk on Basic Demographic Concepts and Measures.

On the second day, PopDev Integration Concepts and the PopDev Mentoring: An Overview of the Key Strategies and activities in the Pilot Sites were tackled. This was attended by employees of select Provincial Government offices. Afterwards, two workshops were conducted to assess the learning of the participants.

The last day of the event also attended by the second day participants was the facilitation of two planning workshop activities - setting of plan, goals, objectives and target and setting of effective policy and program interventions where participants applied the knowledge and skills gained from the activity. Thereafter, a draft Memorandum of Agreement on Localization was presented.

Congress urged to probe 'defective' vote counting machines



Deputy Speaker Rufus Rodriguez on Tuesday urged the House of Representatives to look into the reported malfunctioning of several vote-counting machines (VCMs) across the country. Rodriguez said defective VCMs and secure digital (SD) or memory cards resulted in the disenfranchisement of thousands of voters. "We owe it to our voters to investigate these reports and recommend remedial measures, either via legislation or administrative sanctions or penalties to be imposed by the Commission on Elections on responsible personnel and/or its automation service provider, Smartmatic," he said in a statement.

Rodriguez urged the poll body to report to the

public how many VCMs failed, the polling areas where the defective equipment was deployed, actions taken together with timeline, and number of voters

"The Comelec and its automation contractor have not resolved these issues. There has to be a solution," he stressed.

Although May 9's balloting process was generally orderly, Rodriguez said he could not understand why many vote-counting machines and their SD cards failed, since the devices were supposed to have been tested for defects a few days

He cited complaints that in some areas in Quezon City, some VCMs did not function as early as

the first hour of voting. He further noted that it took Comelec personnel six hours to replace them, but when the replacement machines arrived at the voting centers shortly after lunch on Monday, poll workers found out that their memory cards were "corrupted".

Rodriguez pointed out that Comelec employees had to get new SD cards from the poll body's warehouse in Laguna, taking them at least 12 hours up to early this morning and forcing affected voters to spend the night in their polling centers to be able to cast their votes.

"Our voters should not go through this sad, unfortunate and totally avoidable experience again in future elections," he said. (PNA)
