

Cops rescue 17 Malaysians from poor working conditions

Policemen rescued 17 Malaysian nationals from their poor working conditions at Klaire One Corp. in Kawit, Cavite, the Philippine National Police (PNP) said Saturday.

In a statement, PNP Chief General Benjamin Acorda Jr. said the joint operation was conducted at 10:30 p.m. Friday by the Police Regional Intelligence Division 4-A (Calabarzon), and the Royal Malaysian Police, with the assistance of the Provincial Intelligence Unit, Cavite Police, and Kawit Municipal Police, in coordination with the Directorate for Intelligence.

The rescued Malaysian workers sought assistance from authorities due to their poor working conditions at the job site and have expressed the desire to resign from the company.

They were identified as Steve Sim Vui Leong, Kong Seeing Hock, Lai Yen Fan, Tiu Yong Yong, Tommy Wong Chiong Ming, Jane Liong Siew Jiun, Chua Wei Tung, Ang Kian Long, Antonio Alex Samuel, Stephen Pang Ying Kwong, Simon Chee Yung Fock, Stephanie Sim Do Do, William Law Hing Liong, Bong Ju Fong, Algyen David, Yaw You Ming, and Jalan Rambai Paya Terubong. The rescued Malaysian nationals were turned over to Supt. Norazman Hassan Basari, Police Attache of the Malaysian Police, on Saturday morning.

Acorda said the PNP's successful joint operation with the Royal Malaysian Police is a testament to the importance of cross-border cooperation in addressing issues related to human rights and the protection of vulnerable individuals.

He emphasized the PNP's commitment to upholding human rights and promoting the welfare of all individuals within the Philippine jurisdiction, regardless of nationality.

"The PNP remains steadfast in our duty to uphold the rule of law and protect the rights of every individual within our jurisdiction, including foreign nationals," Acorda said. "We will continue to work closely with our foreign counterparts to ensure the safety and well-being of everyone within our borders." (PNA)

were labelled "coincidental 4,118,013 with 15,229 active Covid", meaning patients cases. were admitted for different health issues but turn out seen rising in certain areas positive for Covid-19 when including Cavite, Laguna, screened.

In a media forum Tuesday, Department of Health officer-in-charge Maria Rosario Vergeire confirmed the increase of cases in Aklan as its positivity rate had reached 59.7 percent for the week of May 8 to 14.

The percentage should not be a cause of panic for

the public, she said, because they have monitored that the numbers are low with only 37 individuals turning out positive for Covid-19 out of the 62 who took the test.

Aklan's utilization rate for Covid-19 beds is 17 percent while its utilization rate for ICU beds is 5 percent. Both are considered low risk for the healthcare utilization rate, she said.

Despite the rise of Covid-19 cases and admissions, de Grano assured everyone that it is safe to go to private hospitals for their healthcare needs and have medical consultations.

He said Covid and non-Covid areas in hospitals are separated and self-protection like wearing face masks is still required.

"Some private hospitals still do not allow family members, relatives or friends to look after patients who are confined for any disease," he added. (PNA)

Masungi 'perpetual trust' stands on shaky legal ground

The Department of Justice (DOJ) has ruled that the government's "perpetual land trust for conservation" agreement with the Masungi Georeserve Foundation, Inc. (MGFI) in 2017 runs afoul with the limitations set by the Constitution.

The legal opinion, through DOJ Undersecretary Raul Vasquez, explained that Article XII, Section 2 of the 1987 Constitution provides that agreements over all lands, waters, and minerals of the public domain shall be for a period not exceeding 25 years and renewable for another 25 years.

The Bureau of Corrections (BuCor), an agency under the DOJ, earlier announced it is deferring plans to develop and use a portion of the area amid opposition that it would ruin the conservation site.

According to the legal opinion shared to the media on Tuesday, the constitutional provision is "emphatic that agreements for the development and utilization of natural resources may be for a period not exceeding 25 years, renewable for not more than 25 years, and under such terms and conditions as may be provided by law."

"Any such agreement involving natural resources should thus comply with this constitutional requirement. In light of this, it appears that the perpetual trust conferred to the MGFI runs counter to Sec. 2, Art. XII of the 1987 Constitution," the DOJ said. The department also said Masungi forest rangers reported committing "harassment" would face prosecution.

"It is the responsibility of the Protected Area Management Office's Protected Area Superintendent (PASU) to enforce laws, rules, and regulations relevant to the protected area, commence and institute administrative and legal actions in collaboration with other government agencies or organizations," it said.

Should there be any reported violations committed within the Masungi Georeserve that would warrant the filing of criminal actions, the DOJ special prosecutors shall coordinate with the Protected Areas Management Board and the PASU.

The DOJ opinion was furnished to Cavite 4th District Rep. Elpidio Barzaga Jr., chairperson of the House of Representatives Committee on Natural Resources.


