67% of election returns, COCs already transmitted to Senate

The Senate is on standby Sunday for 56 more Election Returns (ERs) and Certificates of Canvass (COCs) expected to arrive anytime, out of the 173 that the joint session of Congress will canvass starting May 24 to determine the next President and Vice President.

On the sixth day after the May 9 elections, the Senate Information and Public Relations Bureau reported that it received COCs from Romblon, Pampanga, Samar, Davao Occidental, Zamboanga Sibugay, Camarines Sur, Northern Samar, Cebu City, Zamboanga del Norte, Negros Oriental, Davao del Sur, Davao de Oro, Davao Oriental, Maguindanao, Misamis Occidental, Bulacan, Basilan, South Cotabato, Iloilo, Caloocan

5 mayors win tight races in Cavite

SILANG, Cavite: Five new mayors in Cavite's upland towns won their mandates after tight races, getting slight margins against their opponents. Bailen town Mayor-elect Dennis Glean recorded higher votes against former Mayor Danny Bencito by 86 votes. Glean scored 6,769 votes while Bencito got 6,683 votes.

Outgoing Mendez Vice Mayor Francisco "Cocoy" Mendoza Jr. beat Macy Vida by 2,367 votes. Mendoza got 11,179 votes while Vida got 8,812 votes from the 24 villages here.

In Maragondon town, Lawrence "Umbe" Arca got 10,403 votes while Noel Rillo had 9,751 votes in the mayoral race.

Cavite Fifth District Board Member lawyer Kevin Anarna defeated longtime mayor of Silang town Mayor Omuil Poblete. Anarna had 62,478 votes while Poblete got 52,071 votes.

In his post on his social media account, Anarna thanked all his supporters.

No politicians paid extortion << P1

Mr. President na sa mga permit to campaign na inilabas ng NPA ay wala tayong namonitor na mga politicians na pumatol dito, nagbigay ng pera o resources sa CPP-NPA (We report Mr. President that we have not monitored any politician giving money or resources as permit to campaign against the CPP-NPA)," Año told President Rodrigo Duterte in a pre-recorded Talk to the People on Thursday.

He said the DILG will file the appropriate charges against personalities violating Republic Act 10168, otherwise known as the "Terrorism Financing Prevention and Suppression Act of 2012", which is also a violation of Section 261 of the Omnibus Election Code and Article 137 of the Revised Penal Code or the Disloyalty of Public Officers.

Section 4 of Republic Act 10168 states that any person who finances terrorist groups to carry out or facilitate the commission of any terrorist act, by a terrorist organization, association or group, or by an individual terrorist, shall be guilty of the crime of financing

Meanwhile, Año maintained that the conduct of the May 9, 2022 polls was generally peaceful in comparison with the 2010 and 2016 national and local elections.

In the chart presented to the President, it showed that there were 166 validated election-related incidents (ERIs) in 2010, 133 (ERIs) in 2016, and only 16 ERIs in 2022.

To sum it up from Jan. 9 to May 9, 2022, Año said the reported ERIs happened in Regions 1 (Ilocos Region), 5 (Bicol region), 3 (Central Luzon), 9 (Zamboanga Peninsula), 10 (Northern Mindanao) and the Cordillera Administrative Region (CAR).

As of May 9, Año reported seven deaths and 33 injured persons in 27 violent election-related incidents.

He added that on the day of the election, authorities registered 27 incidents including 11 shooting/mauling incidents, three explosions, two ballot snatchings, four commotions, three assaults, two strafings, and two destructions of vote-counting machines.

The DILG chief noted that the shooting incidents occurred in Albay, Negros Oriental, Basilan, Zamboanga del Norte and Cotabato City, Maguindanao, and in Lanao del Sur. Grenade explosions also happened twice in Maguindanao and once in Cotabato, while ballot snatching incidents occurred in Lanao del Sur and Basilan, according to Año. He also disclosed that instances of commotion transpired in Maguindanao, Camarines Sur, Lanao and Tawi-Tawi, while physical assault inside the polling precincts Maguindanao and Abra with strafing incidents occurring twice in Basilan.

Año also noted that the destruction of vote counting machines were reported in Lanao del Sur. However, he maintained

that only six of these violent incidents were election-related after validation. In the same briefing, Año

also reported that a total of 41 violators were involved in vote-buying incidents recorded from Jan. 1 to May 9, 2022.

He said cases of the four vote-buying suspects were referred to the Prosecutors' Office while one was subjected to direct filing.

Short of saying that no violators are off-the-hook with the conclusion of the elections, Año warned that the DILG, together with other authorities, will continue to run after the vote-buying suspects with 20 other similar election violation complaints are currently being thoroughly investigated.

Among those allegedly involved in the vote-buying incidents include 32 civilians, one government employee, one barangay kagawad, three barangay captains, one political candidate, and three unidentified violators.

He noted that 28 vote-buying violators were nabbed while 13 others remain at large. Meanwhile,

were reported in Batangas, Año reminded the public that enforcement of the gun ban is still in effect until June 8.

He said authorities arrested 3,191 violators in the recorded 3,004 gun ban violations while 2,475 firearms and 1,151 deadly weapons were confiscated.

With regards to the community health protocols, the DILG chief said a 5.52 percent increase in the number of face mask violators with the number reaching 31,819, while 2,098 physical distancing offenders were recorded for a 24.21 percent rise from Jan. 1 to May 9.

There were no recorded mass gathering incident during the period.

On the other hand, Año said that even during the election campaign period, authorities continue its anti-illegal drug campaign with 795 suspects arrested in 566 conducted drug operations, 397 of which were buy-busts from May 1 to 9.

During the said period, the Philippine Drug Enforcement Agency (PDEA), the Philippine National Police (PNP), and other anti-narcotics authorities confiscated some 10.52 kilograms of shabu and 43.74 kilograms of marijuana worth PHP76,830,836.40. There were also 14 drug suspects who surrendered while one fatality was recorded. (PNA)

(PFRS) 4. "This increase in net loss from the previous year is due to the recognition of the Margin for Adverse Deviation (MfAD) in our policy reserves. It was earlier reported on May 14 that the Inter-Agency Task Force (IATF), as announced by Presidential Communication Operations Office (PCOO) Secretary and Acting Presidential Spokesperson Martin Andanar, that Cavite, Laguna, Rizal, Bulacan, and the National Capital Region will be under the

Alert Level 1 status from May 16, 2022, until May 31, 2022.

DOH urges the public to check official sources on the internet and social media for verified reports and information regarding the pandemic.

The department has also reminded the public to observe minimum health standards, such as the proper wearing of face masks, isolation when feeling sick, getting vaccinated and boosted, and always ensuring good airflow. - Christopher Hedreyda, PIA 4A

Duterte signs laws creating LTO, LTFRB district offices

President Rodrigo Roa Duterte has signed 14 laws establishing district offices of the Land Transportation Office (LTO) and the Land Transportation Franchising Regulatory Board (LTFRB) in around 13 provinces in the country.

Duterte inked Republic Acts (RA) 11737, 11738, 11739, 11740, 11741, 11742, 11743, 11744, 11745, 11746, 11747, 11748, 11749, and 11750 on April 27 and copy of the laws were released by the Palace only on Thursday.

RA 11737 creates a regular LTO district office in Alicia, Isabela, while RA 11738 establishes an LTO district office in Manolo Fortich, Bukidnon.

Under RA 11739, a regular district office of the LTFRB is created in Bacoor, Cavite.

An LTO district office is also established in Balingasag, Misamis Oriental and Liloan, Cebu, according to RAs 11740 and 11741.

RA 11742 converts the LTO extension office in Sigma, Capiz into a regular district office. The converted LTO office

will now be located in Dumalag, Capiz. RA 11743 creates a regular LTO district office is created in Alcoy, Cebu, while RA 11744 establishes an LTO office in Laoang, Northern Samar.

Another LTO district office is also established each in San Jose, Dinagat Islands and Laoang town through RAs 11745 and 11746. Under RA 11747, the LTO's extension office in Mabalacat City, Pampanga is converted into a regular LTO district office and renamed as the Mabalacat City LTO District Office. A regular LTO district is also established in Ibajay, Aklan, which will be known as the Western Aklan LTO Center, according to RA 11748.

RAs 11749 and 11750 also create a district office each in the municipality of Enrique B. Magalona in Negros Occidental province and the municipality of Pagsanjan in Laguna province. The laws mandate the Secretary of the Department of Transportation to include in the department's program the operationalization of the LTO and LTFRB district offices.

The funding for the operations of LTO offices will be

included in the annual General Appropriations Act. Senator Grace Poe, sponsor of the bills in the Senate, said the new laws will improve transportation services and create more jobs in the communities. "With the upgrading or setting up of new Land Transportation Offices, our people will no longer have to travel far and bear long lines to get a license or have their vehicles registered," she said in a statement. "Kamakailan lang ay muli na namang itinaas ang sahod ng mga manggagawa sa NCR, kaya naman panawagan namin sa Cavite ay itaas na din sahod kapareho nang sa NCR (There has been a wage hike in the National Capital Region recently, and we are calling for a wage hike in Cavite to match that in NCR)," Revilla said in a statement. The vice governor said Cavite is just beside Metro Manila — with Bacoor just six kilometers away, Imus 10 km away, and Kawit just 13 km away from the NCR. "Marapat lamang na ipantay ang sahod sa mga karatig na lugar ng NCR dahil kung ano ang presyo ng mga bilihin sa NCR, gayundin sa Cavite (It is just right to have the same wage rate in areas near NCR because the prices of commodities in NCR are the same in Cavite," he said. Revilla is pushing for an additional P125 in workers' daily wage, raising the current P373 minimum wage to P498. "Positibo ang aking pagtingin na maitataas natin ang sahod ng mga manggagawa hindi lamang sa Cavite,

kundi sa buong rehiyon (I am confident that we will be able to raise the wage rate of workers not only in Cavite, but in the whole region)," DOLE IV-A Regional Director de Guzman said. According to De Guzman, the new minimum wage in Calabarzon may be finalized less than 30 days after the public hearing. Revilla, on the other hand, expressed hope that the new wage rate will be settled before he leaves his post as vice governor and starts his term as Cavite's 1st District representative.

CAVITEX Toll Rate Adjustment starts May 22

In cooperation with the Toll Regulatory Board (TRB), Cavitex Infrastructure (CIC) and its joint venture partner, Philippine Reclamation Authority (PRA) will implement the new toll rates for CAVITEX R-1 segment starting May 22, 2022.

The supposed implementation in Paranaque Toll Plaza



last May 12 was deferred to provide more time for the registration of PUV drivers and operators to the toll reprieve program which allows them to continue to enjoy the old toll rates of Php 25 for Class 1, Php 50 for Class 2 through a rebate

The toll reprieve program is system driven via the RFID, so all the PUVs operators and drivers have to do is enroll their account to the program in coordination with their different transport organizations. The program will run for 90 days starting on Day 1 of the implementation of the new toll rates.

Toll Regulatory Board expressed gratitude to CIC and its JV partner PRA for their cooperation and support to the mass transport groups. Target enrollees to the program are all drivers and operators of the 1,420 public utility vehicles that ply through CAVITEX.

The new rates are inclusive of the 2011 and 2014 periodic toll petitions, and add-on toll petition for enhancement

CA affirms jail term for seller of counterfeit items

The Court of Appeals (CA) upheld the ruling of the Mandaluyong Regional Trial Court (RTC) that sentenced the seller of counterfeit shoes and other items to up to five years in prison.

The CA affirmed the Nov. 14, 2018 decision of Mandaluyong RTC Branch 211 that found Manolo Samson guilty of violating the Intellectual Property Code of the Philippines' provisions against unfair competition.

"The trial court correctly imposed the indeterminable penalty of two years as minimum to five years as maximum and a fine of PHP100,000," read the decision dated May 11

and made public on Monday.

Samson, proprietor of Itti Shoes Corp., Kolm's Manufacturing Corporation, and Caterpillar Boutique and General Merchandise, distributed and sold counterfeit Caterpillar brand products such as footwear, garments, clothing, bags, and accessories.

On Dec. 5, 2000, lawyers for Caterpillar Inc. sought help from the National Bureau of Investigation (NBI), which raided Samson's outlets that sold Caterpillar products.

Two years later, more raids were conducted in various outlets owned or operated by Samson in Mandaluyong, Quezon City, Manila, Caloocan, Makati, Parañaque, Las Piñas, Pampanga, and Cavite after reports that he continued to sell imitation products.

The court said the "accused intended to deceive the public as to the identity of the goods sold or of the manufacturer thereof," and that "the trial court

therefore did not err in finding the accused guilty of unfair competition".

The Caterpillar trademark was first used in 1904 on track type tractors.

In the Philippines, the Caterpillar trademark was registered in 1968, initially for tractors, tractor parts, and equipment. (PNA)
