

Cavitex-C5 Link **Expressway starts** collecting provisional toll fees

Province of Cavite, Oct. 30 (PIA) - The Cavitex-C5 Link Expressway that opened for motorists last July 22, 2019 has started collecting provisional initial toll for the use of passage last October 24, 2019.

To people then, he an inspiring preacher who could make the word of God live in their hearts as few other men could. Saint Anthony de Padua born in Lisbon, Portugal in 1195 joined a community of Augustinian canons when he was fifteen; after two years he was transferred to one of the Orders house in Coimbra, then Portugal's Capital and there, in 1221 he saw something that marked the turning point in his life: the relics of a number of Franciscan friars. In 1227 after the death of St. Francis, St. Anthony returned to Italy, where he was stationed in the city of Padua. BASIC SERVICES CARAVAN FOR RELOCATED FAMILIES IN MARAGONDON

The BJMP Calabarzon Health Services Division headed by CINSP Edna Leonor donated medicines while some of their officers and those of the PNP offered free haircut and performed dental extraction.


