Destabilization rumors vs. gov't won't do PH any good – solon

An administration lawmaker on Tuesday warned that rumors of political instability will only hurt the country's economy and make life more difficult for Filipinos.

In a statement, Cavite 4th District Rep. Elpidio Barzaga Jr. pointed out that any rumors of alleged destabilization efforts against the administration of President Ferdinand R. Marcos Jr. will only shoo away investors, even if the Armed Forces of

on the back of 1.315 trillion yen worth of Japanese aid five railway, two aviation, and two maritime projects. "(Kishida) would be happy to know that the Philippine side has lived up to its commitments, that despite challenges, we are on track to what we have committed to deliver," he said.

The five railway projects are the LRT Line 1 Cavite Extension, LRT Line 2 East Extension, MRT Line 3 rehabilitation and maintenance, the North-South Commuter Rail System, and the Metro Manila Subway Project (MMSP).

Bautista also thanked Kishida for Japan's help in developing the country's railway sector.

"With 150 years of experience in rail development, with 30,000 km. of rail, with 25 billion riders a year, there are no better senseis than these kind, compassionate, generous, hardworking and honest people," he said.

Bautista noted that when Kishida was still Japan's foreign affairs minister in 2017, he was already "a backer of our country's drive to modernize our transportation system."

"To us, Prime Minister Kishida has always been a member of the Philippine railways team. He's all aboard," he said.

Kishida arrived in the Philippines on Friday for a two-day official visit to boost defense, security, and economic cooperation between the two countries. He is scheduled to visit the MMSP depot and its train simulator room in Valenzuela City on Nov. 4. To date, civil works for the 33-km. MMSP and its 17 stations are ongoing.

Once completed, the MMSP will reduce the travel time between the Ninoy Aquino International Airport Terminal 3 and Valenzu-35 minutes. (PNA)

"We cannot afford any political and economic instability. A plot to overthrow the administration won't do us any good," he said.

He added that what the country needs is a "concerted" effort to address the economic challenges it is facing and not rumors of adventurism being fomented by retired soldiers.

Barzaga cited the statement of the think-tank Stratbase ADR Institute that addressing economic challenges "requires a concerted effort among policymakers, the business community, and other relevant stakeholders."

"Instability is the last thing the country needs right now as it continues to face economic challenges, particularly controlling inflation, which remains the most urgent national concern of the majority of Filipinos," the chairperson of the House Committee on Natural Resources said.

the Philippines (AFP) has ber increased to 6.1 percent, up from 5.3 percent in August, the fastest pace in four months. The figure has brought the year-to-date inflation to 6.6 percent. As prices of basic commodities surged, Barzaga said talks of a brewing plot to destabilize the Marcos administration "will only cause the economy another black eye." "We don't need their adventurism. Go, and the journalist's coworker and president of the Mindanao Independent Press Council (MIPC), Editha Z. Caduaya, was a stark reminder of how dangerous it is to work in the media. Stephen Kyle A. Jumalon, the son of the murdered reporter, communicated via phone patch to thank President Ferdinand R. Marcos Jr., the PTFoMS, and the media community for helping his family get justice. People all over the country were shocked when Jumalon was killed in his radio booth during his morning show on November 5. President Marcos immediately took action, calling for a full investigation

into the killing and sending his apologies to the Jumalon family. Gutierrez claimed once more how serious the situation was and offered a P100,000 prize for information that would help quickly catch the perpetrators responsible for this horrible crime. Even though something terrible happened, the media conference was seen as a big success. More than

150 reporters from Metro Manila, Southern Tagalog, the Bicol Region, and Central Luzon came together to talk about press freedom and safety. The PTFoMS and the whole country are now waiting for the people who killed Jumalon to be caught. They hope that the prize will make people speak out again and bring justice to a voice that was silenced too soon.

Agri-tech solution projects to get funding support from NEDA - Palace

Malacañang on Saturday welcomed the approval of PHP100 million worth of funding allotment for 25 innovation projects, including several agri-tech solution initiatives.

In a statement, Communication Secretary Cheloy Garafil said the agri-tech solution projects that would receive funding support from the National Economic and Development Authority (NEDA) would help increase food productivity in the country.

She made the statement a day after the NEDA announced that its National Innovation Council Executive Technical Board approved the allocation of PHP100 million for 25 innovation projects under the agency's 2023 Innovation Grants.

"The 2023 Innovation Grants project is aligned with the efforts to promote local innovation in national development and sustainable economic growth, as outlined under the Republic Act 11293 or the Philippine Innovation Act," Garafil said.

She noted that the Alternative Onion Storage System using the Controlled Temperature and Automatic Air Flow Mechanism proposed by the Occidental Mindoro State College is among the agri-tech solution projects that will get funding assistance.

He also sees it as an opportunity for all stakeholders to come together and chart a course towards more effective, humane, and equitable incarceration practices that could lead to meaningful and lasting reforms.

"Our department sincerely appreciates the Supreme Court's commitment to helping us address and reform the conditions of persons deprived of liberty (PDLs). It is a significant move towards achieving a fair and just criminal justice system," Abalos said in a statement.

The Supreme Court also expressed high hopes that the inter-agency National Jail Decongestion Summit scheduled December 6 and 7 will be able to come up with comprehensive solutions to address the 386-percent overcrowding in the country's prisons.

"The National Jail Decongestion Summit is expected to be a significant step forward in fostering a more just and effective criminal justice system, ensuring the protection of individual rights, and promoting the overall well-being of our communities," the SC said in a statement.

The SC said the summit will bring together stakeholders, experts, and justice sector actors from across the nation, along with international partners, to devise comprehensive strategies that prioritize sustainable solutions for the reduction of inmate populations in correctional facilities.

"The Summit will provide an essential platform for collaborative discussion, innovative idea sharing, and the exploration of evidence-based practices. Addressing the root causes of overpopulation and implementing effective measures to alleviate the strain on correctional systems are among the primary objectives of this crucial gathering," it added.

Gesmundo, Abalos and Justice Secretary Jesus Crispin C. Remulla, along with legal experts, advocacy groups, and representatives from relevant government agencies will contribute their insights and expertise toward the development of sustainable and equitable solutions through panel discussions, workshops, and presentations, the SC said.

Meanwhile, BJMP chief Jail Director Ruel Rivera emphasized the urgency of addressing jail congestion, noting the bureau's continuing efforts to address the situation.

"In 2018, our facilities were operating at an alarming congestion rate of 600 percent, posing serious challenges to the well-being and reformation of PDL. Today, we are proud to report that we have successfully reduced the congestion rate to 351 percent in 2023, thanks to various innovative programs and collaborations," he added.

The ongoing initiatives by the BJMP include the establishment of additional jail facilities, the enhancement of the PDL Welfare and Development Program, and the enhancement of Jail Paralegal Programs that assist inmates in the speedy disposition of their cases.

Fate of winning PDL bets in village polls

In the meantime, the BJMP said it will not extend preferential treatment to three detainees who won in the recent barangay elections.

BJMP spokesperson Chief Insp. Jayrex Bustinera said the bureau will allow the three to perform their job while in detention.

The three detainees won as barangay kagawad (councilors) in Dasmariñas City in Cavite; Tanay town in Rizal; and Cagayan de Oro City in Misamis Oriental.

"There will be no change (in their treatment), there will be no VIP treatment that will be extended to them," Bustinera said in a radio interview.

The Supreme Court, in a decision issued in August last year, has allowed PDLs to participate in the elections, specifically those who are yet to be convicted by final judgment.

Bustinera said a court order will still be required if the barangay officials need to go out of their detention cells to perform their duties and responsibilities as barangay officials.

He said the BJMP has coordinated with the Commission on Elections to clarify how these officials can perform their job while in detention.

"While waiting, according to our legal office, we are going to follow precedent from the Supreme Court on former senators who were detained and were allowed to perform their jobs," Bustinera said.

Asked if the councilors will be given access to the internet, phones and computers to perform their duties, Bustinera said they are still looking into these measures.

He noted that PDLs are enjoying the privilege of e-dalaw or electronic visitation and that some inmates are also attending the hearing of their cases virtually.

"If there is proper coordination, that can be done by the BJMP," he said, adding any visit to these officials will have to be coordinated with the BJMP, just like with the other PDLs. (With a report from Benjamin Pulta/PNA)

House adopts resolution upholding chamber's integrity, honor

The House of Representatives on Monday adopted a resolution upholding its integrity and honor and expressing full support to the leadership of Speaker Ferdinand Martin G. Romualdez.

During the plenary session, the chamber adopted the report from the Committee of the Whole on House Resolution No. 1414, to preserve the honor and integrity of the institution against destabilizing efforts.

House Majority Leader Manuel Jose Dalipe said the House members stand firmly behind Speaker Romualdez's leadership to improve the "delivery of our constitutionally-mandated obligation to serve the people through legislation."

"The encompassing majority believes that if we continue to work together, the House of Representatives could more effectively alleviate poverty, build on a stronger future ahead, and compete on efficiencies through laws, measures, and policies that strengthen our republic, and address the most pressing issues confronting us today. The majority believes that this chamber could achieve all these and many more, under the thriving and inspirational leadership of Speaker Romualdez," Dalipe said in sponsoring the report of the Committee of the Whole on HR 1414.

In a separate sponsorship speech, Gonzales cited Romualdez's exemplary leadership responsible for maintaining a dynamic, socially coherent, and independent legislature and his unwavering commitment to defending the dignity, integrity, and reputation of the House of Representatives.

"We are deeply touched by the strong leadership of Speaker Romualdez who chose to uphold the dignity and honor of our beloved institution and its members. With a stalwart leader like Speaker Romualdez, we are confident that no matter

what obstacles may come our way, we will always stand strong and we will continue to perform the mandate entrusted to us by the people," Gonzales said.

Gonzales, during the deliberations, resigned as a member and official of political party PDP-Laban after naming former president Rodrigo Duterte as the person behind the demeaning attacks against the chamber.

The Lakas-Christian Muslim Democrats (CMD), National Unity Party (NUP), PDP-Laban, Nacionalista Party (NP), Nationalist People's Coalition (NPC), Partylist Coalition Foundation Inc. (PCFI), and Partido Navoteño also expressed full support to the House leadership during the Committee of the Whole.

Among lawmakers who signed HR 1414 were seven Deputy Speakers, including Pampanga Rep. Aurelio Gonzales Jr., Batangas Rep. Ralph Recto, Las Piñas City Rep. Camille Villar, Cebu Rep. Vincent Franco Frasco, Antipolo City Rep. Roberto Puno, Ilocos Sur Rep. Kristine Singson-Meehan, and TUCP Party-list Rep. Raymond Democrito Mendoza, as well as Minority Leader and 4Ps Partylist Rep. Marcelino "Nonoy" Libanan, among others.

"The House has always taken criticisms as part and parcel of a healthy, vibrant, and working democracy, but it takes exception to statements made that undermine the independence, integrity, and reputation of the institution," the lawmakers said in the resolution.

"As a source of our strength and inspiration, we support the Speaker's relentless dedication in amplifying the voice of every Representative, regardless of the challenges and barriers encountered as demonstrated by his staunch commitment to preserving the democratic values," they added.

In the resolution, the lawmakers stressed that the "dig-

PhilHealth Regional Office IVA, headed by Regional Vice President Dr. Danilo M. Reynes recently handed the capitation check amounting to Php 72.9M to Quezon Governor Angelina "Helen" Tan as part of the frontload fund for the Primary Care Provider Network (PCPN).

Quezon Province is one of the five provinces to form a Primary Care Provider Network PCPN) through the Quezon PCPN which will integrate their resources and services in a network under the Sandbox setting for a more effective delivery of primary care services through PhilHealth's Konsulta (Konsultasyong Sulit at Tama).

The PhilHealth Konsulta covers patient consultations, health risk screening and assessment including 13 laboratory tests, and

21 essential medicines as ordered/prescribed by the doctor according to patient's medical needs.

Currently, PhilHealth Konsulta providers are being paid an average of P500 to P750 per patient per year on a reimbursement basis after services have been rendered. With the PCPN, funds will now be frontloaded through advanced payments even before services have been rendered.

Jumalon, known affectionately to his listeners as 'Johnny Walker'. Mr. Jumalon was a respected voice in the media community, dedicated to delivering news with integrity and courage from his station at Gold FM 94.7 in Calamba, Misamis Occidental. This brutal crime is not only an attack on a single individual but an assault on the principles of free speech and the safety of journalists everywhere. The killing of a journalist in the line of duty is a threat to the democratic fabric of society and to the public's right to information. We at PAPER Inc. condemn this atrocious act in the strongest possible terms and stand in solidarity with the family, friends, and colleagues of Mr. Jumalon. We commend the Presidential Task Force on Media Security's (PTFoMS) swift response in calling for the Philippine National Police (PNP) to activate a Special Investigation Task Group (SITG). PBBM exhorts maximum deployment of forces amid geopolitical challenges

President Ferdinand R. Marcos Jr. on Monday urged the Department of National Defense (DND) and the Armed Forces of the Philippines (AFP) to conduct a strategic review and maximize forces deployment to ensure that strategies remain attuned to the current and future geopolitical challenges.

"As we move now from focusing on ensuring internal security for the country, we now have to bolster the country's external defenses. And I exhort the DND and the AFP to maximize and strategically review the deployment of our forces to ensure that their strategies remain responsive to the current and future geopolitical realities," Marcos said in his speech during the 67th founding anniversary of the Naval Special Operations Command (Navsocom) in Sangley Point, Cavite.

"Let us also continue harnessing the skills of our specialized units in preparing for all contingencies. The Navsocom, with its expertise in Sea, Air, and Land, or SEAL, operations, must be utilized to support naval defense and enhance maritime security," he added.

The President encouraged the Navy to strengthen the unit's capabilities by partnering with forces from like-minded states towards upholding shared commitment to freedom of navigation, peace and stability, and the rule of law.

As AFP commander-in-chief, Marcos made an assurance that the administration is committed to strengthen the Navsocom's capabilities through the acquisitions under the Revised AFP Modernization Program. The administration will also support the unit in implementing programs that enhance knowledge and skills of personnel as well as ensure the welfare and the well-being of their families. Marcos praised Navsocom for its performance, particularly through extensive counter-terrorism training and operations, including rescue missions which, he said, have greatly supported the AFP's internal security efforts, especially in southern Philippines.
