Powerhouse consortium bids for Sangley airport

A consortium of local and foreign companies has submitted an unsolicited proposal for the development of the Sangley Point International Airport (SPIA) project after the Cavite provincial government's second attempt to bid out the project failed last month.

The unsolicited proposal was submitted to Cavite Gov. Jonvic Remulla last week, with the so-called SPIA Development Consortium seeking to form a joint venture with the province of Cavite for the development of the massive airport project.

The SPIA Development Consortium is composed of domestic and foreign companies with successful track records in developing, investing

Dismantling of illegal fishing structure in Cavite started

The Department of Environment and Natural Resources (DENR) has started the dismantling of illegal aquaculture structures in Cavite as part of government's efforts for the Manila Bay rehabilitation amid opposition from fisherfolk.

DENR was joined by the Philippine Coast Guard and the local government of Cavite City in removing "sapra" or abandoned fish traps made of bamboo with "superlight" to attract fish.

Tall bamboo structures

were demolished starting Thursday, Nov. 4, while fishing paraphernalia, including improvised superlight and wide fishing nets with smaller holes, were recovered during the operation.

"Just like what we've said a long time ago, our first objective is to see is to believe. No more floating debris here in Manila Bay, that is our target," DENR Usec. Benny Antiporda said in a statement Saturday, adding

vaccination of minors in the National Capital Region on October 15, 2021.

In Noveleta town, children with comorbidities accompanied by their parents lined up at the Primark Town Center vaccination center in Barangay Magdiwang to get the first dose of their Covid-19 vaccine.

Other municipalities which started their pediatric vaccination meanwhile, include Tanza which has inoculated 30 minors, Carmona with 30 minors, Noveleta

with 60 minors, and Mendez-Nuñez town which has inoculated 457 adolescents.

Trece Martires City also rolled out its vaccination program for the pediatric population with 50 minors given with the first shot of the Pfizer Covid-19 vaccine.

The local governments of General Mariano Alvarez and General Emilio Aguinaldo also joined other towns in Cavite in commencing its inoculation program for minors. According to Aguinaldo Rural Health Unit,

children aged 12 – 14 years are included in the community-based immunization for the anti-measles, tetanus, diptheria including the anti hpv/anti- cervical cancer for girls aged 14 years and will subsequently be scheduled for the Covid-19 vaccination after the said cbi activities.

The City Government of Tagaytay announced it will begin vaccinating minors on Friday, November 5 while the pediatric vaccination in Imus will commence on Monday, November 8. To prepare for the city's pediatric vaccination rollout to be held on Monday, November 8, the city government of Imus held a simulation exercise at the Ospital ng Imus supervised by Imus City Health Office Medical Office IV, Dr. Ferdinand Mina. Pfizer-BionTech is one of the two vaccines with emergency use authorization for 12 to 17 years old issued by the Philippine Food and Drug Administration. -Ruel Francisco, PI Cavite (with reports from Dennis Abrina and LGUs)

A key member of the consortium is the Yuchengco Group of Companies, a major Philippine conglomerate engaged in construction, infrastructure development, banking, insurance and automotive services, among

It also includes Cavitex Holdings Inc., chaired by businessman Luis Virata. Cavitex Holdings was responsible for the development, design and construction of the Manila-Cavite Expressway project, a 14-kilometer-long controlled-access toll expressway linking Manila to Cavite province.

The other local company is Lucio Tan's MacroAsia Corp., which will provide management and technical services for the aviation support and logistics component of the project.

MacroAsia will be a non-equity member of the consortium.

MacroAsia and stateowned China Communications Construction Co. Ltd. had won the first bidding for the SPIA project in 2019, submitting the sole bid.

However, the airport deal awarded to the tandem was terminated last January due to the various deficiencies in the submission of requirements to conclude the joint venture agreement, prompting the provincial government of Cavite to start anew with its search for a partner for the SPIA project.

As previously reported by The STAR, the Cavite provincial government declared a second failed bidding when it did not receive any bids for the airport project after the deadline last Oct. 20.

Powerhouse... From B1 Joining the local firms in the SPIA Development Consortium are renowned global companies Samsung C&T Corp. of South Korea, Munich Airport International GmbH, and the London-based design and engineering firm Arup Group.

Samsung C&T built

in Kuala Lumpur, the iconic Burj Khalifa in Dubai, Terminal 1 of the Incheon International Airport, and the extension of the Changi International Airport. It also built the Incheon Bridge and the Yeongjong Bridge, which are the main access and support infrastructure to Incheon International Air-

Munich Airport International GmbH, on the other hand, is the management services arm of Munich Airport, Europe's only five-star rated airport and certified best airport for the past 14 years.

The consortium said that collectively, they "have the necessary legal, technical and financial qualifications to implement the project and carry out sound viable business strategies and financing plans that will lead to the project's successful development."

The consortium said it is ready to commence full project development activities as soon as the project award is granted. "We share the vision of delivering SPIA as a modern, world-class, efficient, and green international hub airport and new main gateway to the country that Caviteños and all Filipinos will be truly proud of," it said.

The proposed partnership with Cavite province will encompass the development, design, financing, construction, operation and maintenance of the Sangley airport project.

The airport is seen to provide an alternative to, and ease the congestion at, the Ninoy Aquino International Airport, as well as boost economic growth and enhance the local tourism and aviation industries.

Sangley airport is envisioned to become a fully-modernized, world-class and green airport that is designed to expand as demand for air transport services increases in the next 30 to 40 years, and as operations at NAIA are eventually phased out to allow for a redevelopment of the site and its surrounding areas.

Mayor Isko to pursue construction of bridge linking **Bataan to Cavite and Batangas**

Presidential aspirant and Manila Mayor Francisco "Isko Moreno" Domagoso on Wednesday, Nov. 10, said he would push for the construction of a bridge connecting the provinces of Bataan, Cavite, and Batangas.

Domagoso, along with his running mate Willie Ong and Aksyon Demokratiko's senatorial bets, paid a visit to the farmers and fisherfolks in Balanga City, Bataan on Wednesday.

In his speech, the Aksyon Demokratiko standard bearer said he will pursue the construction of a bridge that will link Bataan, Batangas, and Cavite if he is elected as the country's next president.

"We will continue the Build, Build. But in our case, habang tinuloy yung mga sinimulan na, tayo naman (while continuing what has already begun, we), mag-build, build, build tayo: build more schools, build more hospitals, build more

industry, build more jobs and build the bridge from Bataan to Corregidor, to Batangas and Cavite," he said.

Domagoso said linking these three provinces would result to a faster transport and easier exchange of goods.

While the construction of linkage may be costly, the Manila mayor believes that the benefits it will give to the public is beyond value.

"Mura lang yon. Kasi walang halagang maitutumbas ang kagaangang maibibigay sa bawat tao ng mga bagay na ginagawa ng gobyerno... Tao muna ang mauna sa pamahalaan ko (Mura lang yon. Because there is no value that can compare to the ease that can be given to each person by the things that the government does ... People come first in my government)," Domagoso said.

Bataan Governor Albert Garcia, meanwhile, thanked Domagoso for paying a visit to the province, as well as for



helping them in responding to the COVID-19 pandemic.

Garcia said Domagoso helped the province in setting up a cold chain facility in the Capitol

"Kaya naman outside of Metro Manila, inuna naman ang Bataan sa supply ng ba-

kuna, at kaya outside of NCR, nangunguna ang Bataan sa pagbabakuna sa mga kababayan (That is why outside of Metro Manila, Bataan takes the lead in the supply of vaccines, and so outside of NCR, Bataan takes the lead in vaccinating its countrymen)."


