In a statement late Friday, the poll body said the BSKE bets were disqualified after the First and Second Division found them liable for premature campaigning and vote buying.

Caviteño 'lucky pick' bettor claims P147.3-M Super Lotto jackpot

Christmas came early for a Cavite resident who became an instant millionaire after hitting the PHP147.3 million jackpot of the Oct. 15 Super Lotto 6/49 draw. In a statement on Friday, the Philippine Charity Sweepstakes Office (PCSO) said the 46-year-old bettor claimed his prize at the agency's main office in Mandaluyong City on Oct. 17.

"Hindi ko alam na ako yung nanalo kaya inulit kung tinitingnan results ng draw sa Facebook (I didn't know that I was the winner so I again checked the draw results on Facebook)," the winner said.

He disclosed that his winning combination was a Lucky Pick or a system-generated selection from his previous bets.

Before winning the jackpot prize, the winner said he had already won three digits in Super Lotto 6/49.

The bettor said he would use the money for the construction of his family's "dream house."

this month to govern and manage the Maharlika Investment Fund (MIF). "So sa ngayon pong November, sa tingin ko mukhang kaya na pong ma-organize ng MIC. I think they (will) still be required to register with SEC (Securities and Exchange Commission) at magkakaroon na po sila noong kanilang authorized capitalization na nasa batas (So this November, I think they could already organize the MIC. The MIC, or the Maharlika Investment Corporation, will be managing the MIF. I think they will still be required to register with SEC and from there, they would have an authorized capitalization according to the law)," he said.

Salceda said he expects the MIC to make its first investment by February or March next year.

The MIC serves as the primary vehicle for mobilizing and utilizing the MIF for investments in transactions aimed at generating optimal returns on investments

Salceda said Consing is an "excellent fit" as president and CEO of the MIC given his extensive experience in both financial management and management of large infrastructure projects.

"In that sense, he is an excellent fit for both the financial and the developmental functions of the Fund. He is the man for the job," he added.

Salceda said Consing has extensive experience in project financing, chief of which is the USD398 million Project Finance for Victoria International Container Terminal, adding he received various awards for this project deal.

Consing, he said, was also chair of at least five companies, including the Laguna Gateway Inland Container Terminal, Inc., the country's first dry port.

Consing also comes with an academic background in public governance, having graduated BA Political Science from De La Salle University, Salceda said.

"Maharlika is at the crossroads of finance, development, and public administration. Consing has a strong background in all three areas. For this reason, I am very confident in his appointment," he added.

The Presidential Communications Office (PCO) said as president and CEO of MIC, Consing is tasked to establish a diversified portfolio of investments in local and global financial markets and other assets that align with the Fund's objectives; manage and invest the initial and future contributions to the Fund; and accept and manage investment mandates aimed at increasing income for development goals.

Out of the 11 losing bets, nine ran for SK kagawad and two for barangay kagawad, the Comelec said.

Tarlac had the most number of disqualified candidates with seven, followed by four each in Batangas and Laguna. Pampanga has

two disqualified candidates while Manila, Quezon City, Rizal province, and Maguindanao del Norte province has one each. The poll body said there are still 318 pending motu proprio disqualification cases against BSKE candidates. These include

292 disqualification cases for premature/illegal campaigning and 26 for vote-buying and/or vote selling. Earlier, the Comelec ordered the suspension of the proclamation of winning candidates who have pending disqualification cases. (PNA)

BFAR: Massive fish kill in Cavite caused by algal bloom

The Bureau of Fisheries and Aquatic Resources (BFAR) on Thursday said the massive fish kill which occurred in Cañacao Bay in Cavite City was caused by algal bloom.

Algal bloom is a natural phenomenon which happens when micronutrients increase in water, causing increased micro algae formation. As micro algae increase, dissolved oxygen which is much needed by fishes, becomes depleted.

"Natural phenomenon po iyan. Hindi natin alam kung kailan yan susulpot at kailan rin mawawala (That is a natural phenomenon. We don't know when it will start and when it will end)," BFAR Information and Fisherfolk Coordination Unit head and spokesperson Nazario Briguera said in Bagong Pilipinas Ngayon interview.

"Ang tanging puwede lamang natin gawin ay magkaroon ng continuous monitoring sa water quality (What we can do is have a continuous monitoring of the water quality)," he added.

Since the algal bloom only killed blackchin tilapia, Briguera said the fishing industry and the fishing activities in Manila Bay will not be affected.

"Hindi po ito farmed tilapia at wala po ito masyadong commercial value. So, in terms of fishing activities, tuloy pa naman yung mga mangingisda natin sa Manila Bay at dun lang naman sa Cañacao Bay nangyari ito (These are not farmed tilapia and they do not have much commercial value. So in terms of fishing activities, our fishermen continue fishing in Manila Bay because only Cañacao Bay was affected),"

Briguera also clarified that the fish kill cannot spread to nearby areas because algal bloom is a natural phenomenon that could be attributed to abrupt change in temperature and not water pollution.

Over 200 sacks of dead fish have been collected in Cañacao Bay, causing some families in the area to evacuate due to foul odor. The stench kept them from eating and sleeping

"We will continue to extend the necessary technical assistance. As for the affected families, we learned that the local government unit responded immediately," he said. (PNA)

The expo also aims to make horseracing an integral part of the country's sports tourism efforts," said Philracom chairman Reli de Leon, who conceptualized the expo.

The expo, which is the first of its kind in local horseracing, was launched at the San Lazaro Business and Leisure Park in Carmona, Cavite in October last year, an event that drew the racing fans. (PNA)

Guard against Covid-19 despite drop in cases - health expert

Senior citizens, the immunocompromised and people with comorbidities are advised to continue protecting themselves against the coronavirus disease 2019 (Covid-19) despite a reported decrease in cases nationwide.

Philippine College of Physicians president and infectious disease expert Rontgene Solante said Wednesday the decrease in the number of Covid-19 infections shows that current variants may not be as highly transmissible as previous variants.

He said the Filipino population may have already acquired a high wall of immunity against Covid-19.

"Pero ang problema, wala na tayong mga (But the problem is we no longer have) booster vaccination," he said during a Bagong Pilipinas Ngayon briefing.

On Monday, the Department of Health (DOH) reported 128 daily average of new cases for the period of Oct. 30 to Nov. 5.

It is 18 percent lower compared to the 155 cases logged from Oct. 23 to 29. For the week of Oct. 30 to Nov. 5, the DOH recorded no new Covid-19 deaths.

"Even with the low number of cases, ang paalala pa rin natin sa publiko, especially sa mga vulnerable population, hindi pa rin iyan ligtas tayo kasi baka matsambahan tayo (We remind the public especially the vulnerable population that you're not safe from having the infection)," Solante said.

"Alam naman natin kapag Covid at vulnerable population ka, mataas taas ang risk na pwede mag-severe ang Covid ng mga population na ito (We know that if you're part of the vulnerable population and you have Covid, your condition may become severe)."

As of Nov. 6, the DOH said the top five regions contributing to the new cases tally for the week are the National Capital Region, Region 4-A (Calabarzon), Central Luzon, Central Visayas and Soccsksargen.

The five areas with the most number of new cases include Quezon City, Rizal, Manila City, Cavite and Bulacan. (PNA)
