Pacquiao ready for political slugfest

LGU suspends mandatory wearing of face shields

ALFONSO, Cavite (PIA) — The local government of Alfonso approved and passed Executive Order no. 67 s. 2021 suspending the mandatory wearing of face shields in the municipality effective Friday, November 12, 2021.

The order followed after the loosening of quarantine protocols in NCR and in the CALABARZON regions due to the continuous decline in the number of CoViD-19 cases recorded in the past weeks. The ordinance reads that wearing of face shields will be

there is ample supply of all CoViD-19 brands that are authorized for the immunization.

"This is the time to register for the vaccination because we have plenty of available CoViD-19 vaccines," urged Punzalan. To be able to attain the goal of herd immunity at the soonest possible time, the RHU targets to distribute a total of 11,000 jabs per day.

Meanwhile, the local government is currently coordinating with the schools' administrations for the efficient assessment and processing to speed up the town's Pediatric vaccination. Despite the decline in recorded positive cases, the RHU continues to remind the public to continue observing the minimum health standards including the mandatory wearing of face shields that serve as additional protection against infection of the CoViD-19.

regional office had continuously supported the fisherfolks and farmers in Cavite that were heavily affected by the natural disaster with P 176M funds allocated for the province under the Taal Rehabilitation and Recovery Program.

During the event, DA Secretary William D. Dar awarded P144.5M of the funds to the province with a certificate of the grant received by Provincial Administrator Alvin Mojica.

A total of 103 farmers' associations or 6,384 registered farmers in 12 cities and municipalities in the province benefit from the program with their representatives receiving the certificates during the event. The beneficiaries were from the cities of Dasmariñas with 12 farmers' associations, 517 farmers; General Trias with 7 farmers' associations, 316 farmers; Tagaytay city with 9 farmers' associations, 269 farmers; Trece Martires with 3 associations, 400 farmers; and the from the municipalities of Silang with 11 farmers' associations, 1,417 farmers; Amadeo with 10 associations, 274 farmers; Alfonso with 7 associations, 492 farmers; Gen. "I already became a champion in many weight divisions in boxing. Now, I want to be a champion in public service," said Pacquiao, standard-bearer of the Probinsya Muna Development Initiative party founded by former Cebu Gov. Lito Osmeña, who died in July.

Pacquiao was in Cebu City to attend the wedding of the son of Cebu City Rep. Rodrigo Abellanosa.

He and Vice President Leni Robredo, who is also seeking the presidency, were among the principal spon-

Pacquiao said he was ready to face anyone in the political arena and would not bother himself with the political plans and actions of other candidates.

loying with the people "All I ask is that people carefully choose who [should] lead the country because it seems there are people who are just toying with us, toying with the people," he said in Tagalog.

He stressed that, as far as he is concerned, there is no turning back on his bid for the presidency and he will vigorously pursue his desire to serve and fulfill his quest to get rid of corruption in all levels of governance.

He made the remark amid speculation that he made a deal with President Duterte when they met on Tuesday night, but the Pacquiao camp said the meeting was just a visit "between and among friends." Mr. Duterte and Pacquiao had been

exchanging bitter words since the senator criticized the Chief Executive for failing to fulfill the promises he made when he ran for president in 2016. 'Mega prison' for corrupt Pacquiao began criticizing the Duterte administration after the President told Energy Secreatry Alfonso Cusi to take control of the Partido Demokratiko Pilipino-Lakas ng Bayan party, an issue that remains unresolved by the Commission on Elections.

While in Cebu, Pacquiao also met with the MP3 Movement, a coalition of volunteer leaders pushing for his presidency.

In his speech, Pacquiao reiterated his promise to launch an all-out war against corruption and promised to

build a "mega prison" that would be solely intended for corrupt government officials.

He said that this facility would be equipped with closed-circuit television cameras that were fed directly to Malacañang as well as a hospital to house detainees who suddenly get sick when they are on trial.

Pacquiao said he would make sure there won't be a phone signal inside the mega

His meeting with the MP3 Movement was followed by a forum with young Cebu businessmen where Pacquiao revealed his plan to provide zero-interest loans for micro, small and medium enterprises so they can immediately recover from their losses during the pandemic.

Matibag says, Bong Go's prexy bid consolidates PDP Laban forces

PDP Laban Secretary General, Atty. Melvin Matibag, on Monday said the filing of Sen. Christopher Lawrence "Bong" Go of his certificate of candidacy for President in the 2022 national elections has served to consolidate the forces of the ruling party. In an interview at the morning Radio/TV program of Daily Tribune, aired over DZRJ Teleradyo Bandido TV and RJ 810 AM, Matibag admitted that in the past few days some members expressed concern over uncertainty in the party's standard bearers for the 2022 national elections. "To be honest, in the past few days, many questions were raised (by our members). Now that we have a definite candidate for President, our local candidates are more confident of our party's direction. Of course, they want to know for certain as to who would carry the banners of PDP Laban," Matibag said. On Saturday, PDP Laban President Alfonso Cusi issued an open letter to the ruling party's members, through Matibag assuring them that nothing has changed, including their objective to secure victory in the coming national and local elections. "We urge you to toe the party line and remain steadfast. President Rodrigo Roa Duterte will personally lead our campaign and is committed to support all our candidates," Cusi added. It could be recalled that Sen. Ronald "Bato" Dela Rosa had filed his certificate of candidacy for presidency under PDP Laban but said he is willing to step aside if presidential daughter and Davao City Mayor Sara Duterte would take his place. Likewise, Sen. Bong Go hinted in an emotional speech last week that he might withdraw his candidacy for vice president. But on Saturday, after Mayor Sara filed her certificate of candidacy (COC) for vice president under Lakas-CMD, Sen. Go withdrew his candidacy for vice president and instead ran for president under Pederalismo ng Dugong Dakilang Samahan (PDDS). 'When Sen. Bong Go filed his certificate of candidacy, it's not under PDP Laban. But just the same, our alliance agreement is clear that PDP Laban will also be in the frontlines of the campaign of Sen. Bong Go," Matibag clarified. "Sen. Bong Go is committed to carry the flag of PDP Laban even if the CONA (Certificate of Nomination and Acceptance) he used is from the PDDS," he added. Matibag said they are in constant communication with PDP Laban members all over the country. "In fact, today we will have our NEC (National Executive Committee) meeting to schedule our National Council meeting, probably on the first week of December," he said. In the meantime, Matibag said President Rodrigo Duterte and Sen. Go will start going around the provinces to endorse local candidates of PDP Laban. But he refused to comment on the possibility of President Duterte facing off with Mayor Sara for the vice presidential race. "If President Duterte would decide to run for any position, you can be sure that we will support and promote the candidacy of the President," Matibag said.

to continuously rehabilitate and restore the marine and coastal ecosystems in Manila Bay pursuant to Section 3 of Administrative Order No. 16 signed by Executive Secretary Salvador Medialdea, under the authority of President Rodrigo Roa Duterte on February 19, 2019.

"The entry and movement of bamboo for other purposes, including but not limited to construction materials for houses, scaffolding, bridges, fences, and buildings and for furniture shall be allowed," Cuna said in his memorandum.

Per initial data given by the respective local government units, there are a total of 370 illegal aquaculture structures in Cavite waters: 271 in Cavite City, 97 in Kawit, and 2 in Noveleta. However, per data gathered during the actual marking conducted

from September 15-22, 2021, a total of 949 structures had been marked: 789 in Cavite City and 160 in Kawit. Most of these structures are bamboo-made. On November 4, 2021, Manila Bay Inter Agency Task Force - Cavite Cluster started the clearing/ dismantling of 32 sapras in Cavite City. DENR CALA-BARZON Regional Executive Director Nilo Tamoria said that the said demolition is part of the Manila Bay Rehabilitation Program of the DENR. Gatchalian bats for regular **COVID-19 tests for teachers**

Senator Sherwin Gatchalian on Tuesday, Nov. 16 pushed for regular COVID-19 tests for teachers after witnessing the start of the pilot implementation of limited in-person classes in select schools on Monday, Nov. 15.

Gatchalian, who chairs the Senate Committee on Basic Education, Arts and Culture, made the call after two schools in Zambales postponed the limited face-toface classes after seven teachers from both schools tested positive for COVID-19 after taking rapid antigen tests.

The senator said it is necessary for the government to consider regular COVID-19 testing of teachers to ensure a smooth transition under the new normal.

"Dapat pag-isipan din natin ang regular na COVID-19 testing ng mga teachers. Pati 'yung vaccination nila ay dapat nating i-monitor nang mabuti (We need to think of doing regular COVID-19 testing for our teachers. We should also monitor their vaccination)," Gatchalian said during his visit to schools that are participating in the dry run of in-person classes.

"To minimize risks, we need to test. Kaya dapat



mapondohan ang testing ng mga teachers at kung may nag-positive man, merong nakahandang suporta para sa kanila (That's why we need to allocate funds for the testing of our teachers so that should one of them get positive of the coronavirus, they can easily be given financial support," said Gatchalian.

Gatchalian said the Department of Education (DepEd) should work with the Philippine Health Insurance Corp. (PhilHealth) in creating a special line at the very least for teachers.

least help ease the burden on teachers who fall ill with COVID-19 since they have to spend out of pocket expenses first before receiving reimbursements from Phil-

Gatchalian, who is seeking to be reelected in the May 2022 elections, said there is also a need to provide financial support to schools to ensure that adequate public health supplies and facilities for water, sanitation, and hygiene (WASH) would be maintained.

"What we need is sup-He said this would at port. Kailangang maipaabot natin 'yung suporta sa mga paaralan sa pamamagitan ng pondo upang makabili pa sila ng mga kagamitan at tuloy-tuloy ang paglilinis ng paligid (We need to provide financial support so they can buy supplies needed to maintain health and safety protocols)," he said.

"Importante sa health protocols ang paglilinis, pagbili ng mga sabon, at paggawa ng iba pang mga pasilidad (It's important to maintain health protocols by cleaning, buying the soap, and constructing the necessary facilities)," Gatchalian stressed.
