# SSS issues guidelines on calamity assistance for members and pensioners affected by Quinta, Rolly, Ulysses

The Social Security System (SSS) announced that it would provide a calamity assistance package for its members and pensioners in areas that are declared and will be declared under the State of Calamity by the National Disaster Risk Reduction and Management Council (NDRRMC) due to Super Typhoon Rolly and Typhoons Quinta and Ulysses. SSS President and CEO Aurora

C. Ignacio said that starting 27 November 2020, the SSS will open three programs to provide financial assistance for typhoon-affected members and pensioners.

These programs are the Calamity Loan Assistance Program (CLAP) for qualified members and Threemonth Advance Pension for SS and Employees' Com-

# **DOTr** sees interoperability << P1

Autosweep tags are issued by the San Miguel Corporation (SMC) for the Skyway, South Luzon expressway (SLEx), STAR Tollway, Tarlac-Pangasinan-La Union Expressway (TPLEx), Ninoy Aquino International Airport Expressway (NAIAx), and the Muntinlupa-Cavite Expressway (MCX). Easytrip, on the other hand, is issued by the Metro Pacific Tollways Corporation (MPTC) to be used in the North Luzon Expressway (NLEx), Subic-Clark-Tarlac Expressway (SCTEx), Cavite Expressway (CAVITEx), C5 Southlink, and Cavite-Laguna Expressway (CALAX). During the same session, Senator Nancy Binay raised the question on whether motorists without radio-frequency identification (RFID) would be penalized starting December 1 as previously announced. "I asked them about the penalty. According to them, they will not impose a penalty... There will be a penalty but hindi raw sila mag-iimplement ngayong Pasko," Senate Majority Leader Juan Miguel Zubiri said after conferring with DOTr officials present in the session hall.

Booths for cash payments should not be totally eliminated too by toll road operators, Binay underscored. "Just to add, when I travel abroad, there's always a booth for cash transactions for those renting a car. The concept of totally cashless, I haven't seen that in other countries," she said.

The cashless toll collection scheme is pursuant to the DOTr's Department Order No. (DO) 2020-012.

The DOTr has previously explained that the Toll Interoperability Project has three phases, of which the implementation of 100% cashless and contactless toll payments form phase one.

Under phase 2, motorists would have to use 2 RFID wallets which will make a single RFID sticker readable by sensors at different toll roads. Each wallet will contain the 'load' for payments at specific toll plazas.

Phase 3 involves the use of just one RFID sticker for all toll expressways, and maintain only one wallet for toll payments. A lawmaker in the House of Representatives has urged the DOTr to postpone the implementation of this scheme until the RFID system of the two toll operators are interoperable but the agency rejected the call, saying it is "duty-bound to protect the health and safety of public transport passengers and stakeholders" amid the pandemic.—(DONA MAG-SINO) LDF, GMA News

pensation (EC) pensioners, which will accept applications until 26 February 2021. Also, there is a Direct House Repair and Improvement Loan for qualified members, which will be open for one year from the issuance of its corresponding circular.

(Calamity Loan Assistance Program) Under the CLAP, qualified members may avail of a loan equivalent to the average of their last 12 monthly salary credits (MSC) rounded up to the nearest thousand or the amount they applied for, whichever is lower.

To qualify for CLAP, members must have a My.SSS account at www.sss.gov.ph; have at least 36 monthly contributions, six of which should be posted within the last 12 months before the month of application; be a resident of an NDRRMC-declared calamity area and suffered damage/loss to their properties due to Super Typhoon Rolly and Typhoons Quinta and Ulysses; have not been granted any final benefit such as permanent total disability or retirement and; have no outstanding loans under the Loan Restructuring Program or previous CLAPs.

**CLAP** applications must be filed online through members' respective My.SSS accounts. Their employers must certify applications of employed members through the employers' My.SSS account. The calamity loan is payable within two years in equal monthly installments with a 10 percent interest rate per annum and a one percent penalty for late payments. The service fee of one percent of the loan amount is waived.

Amortizations will start on the second month following the date of its approval. The payment deadline for the said loan is every last day of the month following the applicable month.

Calamity loan proceeds will be credited through members' disbursement account registered with the SSS, which may be a Philippine Electronic Fund Transfer System and Operations Network participating bank account; Unified Multi-Purpose Identification Card enrolled as an ATM card; or Union Bank of the Philippines Quick Card.

(Three-month Advance Pension) SS and EC pensioners residing in NDRRMC-declared calamity areas due to Super Typhoon Rolly and Typhoons Quinta and Ulysses may apply for the Threemonth Advance Pension.

However, retiree-pensioners who have existing loans under the Pension Loan Program (PLP) are not qualified for the advance

Repair and Improvement Loan) Employed, self-employed, voluntary, and Overseas Filipino Worker SSS members whose residence is in an NDRRMC-declared calamity area and whose house was destroyed or damaged by Super Typhoon Rolly and Typhoon Quinta and Ulysses may apply for a Direct House Repair and Improvement

Under the program, they may avail of a loan of up to one million pesos.

To qualify, the member must have at least 24 monthly contributions, three of which posted within the last 12 months before the month of application; not more than 60 years old at the time of application; have not been previously granted a Direct House Repair and Improvement Loan; have not been granted any final benefit nor refunded SSS contribution; and he/she and his/her spouse, if applicable, must be up to date in the payment of all other existing loan/s with

The SSS has waived the processing fee for the said loan program. It has an annual interest rate of eight percent for loans of up to P450,000 and nine percent for loans over P450,000.

Payment terms for the loan program must be a multiple of five years with a maximum of 20 years, plus a six-month moratorium. The loan term must not exceed house/improvement's the economic life, as determined by the SSS; and the age of the applicant must not exceed 65 years old at the end of the term. The said loan will be due starting on the seventh month from its approval and is payable in equal monthly installments.

Applications for the program may be filed at the Member Loans Department, in the SSS Main Office (for NCR), and Housing and Acquired Asset Management Sections (for non-NCR).

The United Nations Children's Fund (UNICEF) also warned that the most affected children, including their families, are at increased risk of COVID-19 infection and other diseases because of crowding in evacuation cen-

The lawmaker emphasized the importance of implementing the Comprehensive Emergency Program for Children (CEPC), which was created under Republic Act No. 10821 or the Children's Emergency Relief and Protection Act. Under the law, the CEPC should serve as the basis for handling disasters and other emergency situations to protect and support the immediate recovery of children, as well as pregnant and lactating mothers. LGUs are also mandated to integrate the CEPC in their Local Disaster Risk Reduction and Management (LDRRM) plans and budget.

Part of the components of the CEPC is the establishment of child-friendly spaces in areas under a state of

mandates the Department of Health (DOH) to coordinate with the DSWD, LGUs, and civil society organizations (CSOs) to provide the health, medical, and nutritional needs of affected children, including psychosocial interventions. Since the CEPC ensures immediate delivery of basic necessities and services to affected children such as food, water, medicines, and sanitary and hygiene kits, Gatchalian pointed out that public health supplies needed to help prevent the spread of COVID-19 such as face masks, alcohol, and sanitizers should also be distributed to children and their families. While the CEPC also mandates the Department of Education (DepEd) to ensure the resumption of educational services for all children, Gatchalian also recommended that the agency should help in linking learners to the DOH, civil society organizations, and other professionals who could provide psychosocial interventions. ## DOH's "microscopic 1% share in infra budget ignores COVID reality"

Senate President Pro Tempore Ralph Recto said the "biggest factory defect" of the Palace-proposed 2021 national budget is "the microscopic 1 percent share of health" in the infrastructure and capital outlays pie.

"In the midst of the pandemic, when the deficiencies of hospitals and the health system have been exposed, how can this be overlooked by all the President's men?" Recto said.

Recto's interpellation of the general principles of the 2021 budget elicited the admission that the P11.4 billion earmarked for equipment and buildings of the DOH next year account for only 1 percent of the proposed P1.1 trillion capital outlays for the entire government.

"This is counter-intuitive. Bad science meets bad politics. Why put a crisis to waste? Countries are doubling spending



Along with the dredging projects to be conducted, Usec. Leonel said that they have recommended reforestation projects under DENR's National Greening Projects to be implemented in Cagayan Valley, especially in watershed areas.

The agency is also eyeing reforestation projects in upland areas through its Integrated Social Forestry Program (ISFP), which encourages villagers to cultivate forest trees and agricultural crops. "Meron din po tayong available na perennial crops na pwede nating ilagay din sa kagubatan. Hindi man mapuputol but the communities can benefit from the fruits of the trees that it can provide. This can be part of the alternative livelihood to be given to the communities instead

na magputol pa sila dun [We also have perennial crops that we can plant in forests. This can't be cut down as timber but the communities can benefit from the fruits of the trees]," he added. ISFP aims to assist families generate incomes through the use of appropriate upland technologies while protecting the environment.

# Cavite bldg collapses due to typhoon Ulysses

DASMARIÑAS CITY, Cavite — Retrieval operations are ongoing in the building extension of the factory of Polytechnique Mfg., Inc. in Purok 4, Langkaan 1, Dasmariñas, Cavite.

Several construction workers sleeping at the back of the building were trapped when the building collapsed Thursday.

The victims were identified as Jomer Blesario, 27, carpenter; Rolly Dijal, 23, construction worker; Dennis Maquiling y Olbo, 38, laborer.

The injured victims are undergoing treatment at the Pagamutan ng Dasmariñas, according to the CDRRMO headed by Reynor Calzado with the help and support of barangay officials of Langkaan 1, the Dasma Fire Department and the PNP Dasmariñas headed by COP Richard Ang.

# Water service interruptions for Maynilad customers in 10 Metro areas and parts of Cavite on Nov. 18-24

The cleanup will be done to help restore the normal volume of water it produces, the water concessionaire added.

In an advisory Tuesday evening, Maynilad said affected

areas in Metro Manila include Pasay, Caloocan, Las Pinas, Muntinlupa, Paranaque, Makati, Quezon City, Navotas, Malabon, and Manila.

Three areas in Cavite, namely, Imus, Kawit, and Bacoor will also experience the daily water interruption.

The full list of affected barangays per city is posted on Maynilad's official Facebook page.

Maynilad, meanwhile, told its customers that the first-out water might be blurred or colored once the water supply re-


