Escudero first put forward the bill in 2007 when he was elected to the Senate and refiled it in 2013 in a move to boost transparency and accountability, and curb graft and corruption within the bureaucracy.

"Hindi po tayo matitinag na ihain ang panukala nang paulit-ulit at ipagtanggol ito sa plenaryo kung tayo ang pagbibigyang muli ng taumbayan na maglingkod sa Senado," Escudero said.

"Umaasa tayo na hindi man ngayon, darating din ang pagkakataon at panahon na magiging katangga-tannggap na ang panukala at magkaroon din ng malawakang panawagan ang mga mamamayan," the veteran legislator said.

Under Senate Bill No. 16 Escudero filed when he was senator, he sought to compel all public officials, except those who are serving in honorary capacity, to file a waiver that will allow the anti-graft court to examine the bank deposits and other investments as a deterrent to graft and corruption.

"Public office is a public trust. Government officials are accountable to the public," Escudero said in his explanatory note in the proposed bill. "To ensure that the civil servant does not use her position to enrich herself, it is necessary that we put in place a mechanism which will enable the government to audit the finances of the civil servant." If approved, Escudero's proposed measure will lift restrictions under Republic Act No. 1405, or the Bank Secrecy Act of 1955, which prohibits disclosure of or inquiry into deposits with any banking institutions, as well as provides penalties of jail term or fines for offenders.

Escudero, who is seeking a new six-year term in

the Senate under the Nationalist People's Coalition, has challenged candidates seeking elective posts in the 2022 national elections to bare their statement of assets, liability and net worth (SALN) in the spirit of transparency and accountability and also aid voters in choosing the next leaders of the country.

"Tulungan natin ang mga botante para makapili ng susunod ng mga líder ng bansa sa paglalahad ng ating mga SALN. Karapatan nilang malaman ito para mapag-aralan kung sino ang dapat at karapat dapat sa kanilang boto," he explained.

Since 2010, when he

was still a senator, Escudero has been filing his SALN together with the waiver authorizing the Office of the Ombudsman to examine his bank deposits. "Kung wala namang itinatago, dapat walang katakutan. Kung wala naman kinakatakutan, dapat huwag itago," Escudero said.

after a similar expedition was thwarted off by water cannons of Chinese gunboats.

"This is being watched by our fishermen in which the West Philippine Sea has been a traditional fishing area," Villanueva said. "Kung barko at sundalo nga po ng ating Republika ay hinaharang, paano pa po kaya ang ating mga mangingisda na naka-bangka lang?"

This will cost a lot of fishing jobs and food on the table, he added. Villanueva said those who will resupply the Marines stationed in the scuttled World War II vintage ship should just ignore the scare tactics of the "great wall of ships" blockading the shoal. "Kung hindi po makakarating ang pagkain sa mga sundalo natin sa BRP Sierra Madre, hindi lang sila ang magugutom. Tiyak po tayo na pati ang ating mga mangingisda ay mangangamba na maging biktima ng panggigipit ng Chinese coast guard.

But Villanueva believes that the assurance given to Defense Secretary Delfin Lorenzana by the Chinese ambassador to Manila of non-interference to the supply run "will be observed because doing otherwise is a bully move that will be condemned universally."

"If you let the soldiers aboard the ship die of hunger, then the optics will be very bad. Hindi po maganda tingnan para sa isang bansa na merong charm offensive sa buong mundo," he said.

treatment of mild to moderate cases of COVID-19.

Under the MOA, the OVP will issue a guarantee letter (GL) under its special medical assistance program to any qualified patient referred by a volunteer doctor in the OVP's Bayanihan E-Konsulta (BEK) and is further assessed and prescribed Molnupiravir by QualiMed facilities.

Usec. Philip Dy signed for the OVP, while Jaime E. Ysmael, President and CEO, and Margaret A. Bengzon, Group COO, signed for the QualiMed Health Network.

The Food and Drug Administration (FDA) has issued a Compassionate Special Permit (CSP) for the use of Molnupiravir, developed by Merck (known as MSD outside of the US and Canada) and Ridgeback Biotherapeutics, to several hospitals. This includes QualiMed facilities like QualiMed San Jose Del Monte in Bulacan and QualiMed Manila within the PGH Compound, both located in the NCR Plus area.

The first shipment of Molnupiravir arrived in the Philippines, last November 17, the first in Southeast Asia.
