# 7 Cavite cops axed over looting at drug suspect's home



Seven of the eight Cavite police officers who were caught on video while ransacking the house of a retired professor in an anti-drug operation have been dismissed from the service. In a press briefing in Camp Crame, Quezon City on Wednesday, Philippine National Police (PNP) spokesperson Col. Jean Fajardo said top cop Gen. Benjamin Acorda Jr. has signed the dismissal order against Staff Sergeants Jesus Alday, Julius Barbon, and Emil Buna; Corporals Jenerald Cadiang and Lew Amando Antonio; and patrol officers Reymel Czar Reyes and Rene Mendoza. "They will be slapped with six counts of grave misconduct, two counts of less grave misconduct, one count of grave irregularity in the performance of duty, grave dishonesty and

conduct unbecoming of a police officer," Fajardo said, adding that Acorda based his decision on the recommendation of the police force's Internal Affairs Service.

This stemmed from the Aug. 2 operation of the members of the PNP Drug Enforcement Group (PNP-DEG) unit, who were in civilian clothes when they forcibly entered the house of 67-year-old suspect Rebecca Caoile in Barangay Alapan 1-A, Imus City, Cavite. In a viral video, Caoile was heard screaming for help during the incident. It also showed that other cops who remained outside of the suspect's residence were tinkering with a parked motorcycle and some police officers carrying some items from her house, including a tire and a motorcycle rim. The police officers also allegedly took cash, a laptop, and other items from Caoile's residence. Caoile was then arrested. They were relieved and taken into police custody after the incident pending criminal and administrative investigation. Charges of robbery were later filed against them.

Meanwhile, the eighth police officer, Senior Master Sgt. Daisy Diones has been exonerated from grave misconduct charges. "There was no enough basis or evidence to find her guilty because accordingly, her only participation was to frisk the female suspect. She was not involved in the act of forcibly entering the house," Fajardo said. Fajardo, however, said Diones would undergo a pre-charge investigation for neglect of duty while relieved Imus Police chief Lt. Col. Michael Batoctoy and several other police officers would also undergo precharge investigation for neglect of duty under the doctrine of command responsibility. She added that the penalty for grave neglect of duty would depend on the result of the pre-charge investigation on the embattled police officers. (PNA)

The pilot testing of automated voting for Barangay and Sangguniang Kabataan Elections (BSKE) at Pasong Tamo Elementary School in Quezon City encountered only minor glitches like power interruption and paper jamming of vote counting machines.

Barangay Board of Canvassers (BBOC) chief Edna Bañaga said automated system remains more efficient and faster due to the absence of human interpretation of it said. "In places with low handwritten ballots.

She said a total of 133 secure digital (SD) cards, including 72 in Pasong Tampo, were used for the pilot testing of the automated voting in select Quezon City areas.

Other Quezon City's polling precincts that used VCM are CBE Town covered court and Judge Feliciano Belmonte Sr. High School.

High voter turnout

In its initial observation of the 2023 BSKE, NAM-FREL noted that the long overdue polls are so far "generally peaceful, orderly".

Across the country, NAMFREL observers reported that "there has been a high turnout of voters, especially among senior citizens who turned up early outside voting centers prior to the start of voting" in most voting

general, regular voters outnumber SK (Sanguniang Kabataan) voters, reflecting the fact that there are more regular-age voters registered than SK voters," turnout of voters this morning, NAMFREL observers said the numbers may increase as the day progresses," it added.

NAMFREL volunteers said turnout was low early this morning in Nueva Valencia, Guimaras due to rainy weather while some voters in Zamboanga City opted to cast their votes later after

In Al-Barka, Basilan, NAMFREL observers reported that Armed Forces of the Philippines personnel had been requested by members of the EBs to be present at the entrance to polling places to provide security to the EBs.

At the Malaig Elementary School in Balindong, Lanao del Sur, NAMFREL observers reported that soldiers equipped with tasers are stationed at polling places to maintain peace and order.

In Cotabato City, NAM-FREL reported that about 15 percent of EBs at the Vilo Central Elementary School resigned the day before election day due to concerns regarding their security, especially during the counting.

The EBs were replaced by personnel from the Philippine National Police.

Also in Cotabato City, at the Kimpo Elementary School, NAMFREL observers were barred by local police from entering the voting center to observe the elec-

The observers were told that no media or external observers were to be permitted

NAMFREL said it is verifying other incidents reported in the media that appear to be election-related.

"NAMFREL will include them in forthcoming updates once verified by the NAMFREL volunteers on the ground. NAMFREL will continue to gather observations throughout the day," it

Voting will end at 3 p.m. and counting and canvassing of votes will begin shortly after. (with a report from Noemi S. Reyes/PNA)

Comelec Chairman George Erwin Garcia said on Monday that they are expecting around 70 to 75 percent voter turnout for the barangay and SK elections, which is a slight increase from the

2018 elections that only ranged between 70 to 71 percent.

Garcia also noted that the barangay and SK polls went smoothly and were generally peaceful.

President Marcos extended his gratitude to the Filipino people and to everyone who went out and cast their votes in the recently concluded elections. (PND)



### **Envoy: Japan ready to invest more in big-ticket PH projects**



Tokyo will continue investing in the Philippines' big-ticket projects, Japanese Ambassador Kazuhiko Koshikawa reaffirmed Thursday.

Speaking at the 49th Philippine Business Conference and Expo in Manila, the envoy said Japan "has always been and continues to be" the largest official development assistance (ODA) donor of the Philippines but there is still room for the partnership to grow further.

"Japan and the Philippines have very strong, solid economic ties," he said.

"As we forge commitments in our priority industries, we want to assure you that Japan will continue to invest in big-ticket projects to help shape a thriving future for our fellow Filipinos and for our investors," the envoy added.

A big chunk of Japanese investments in the country goes into infrastructure projects, among which are the North-South Commuter Railway (NSCR), Metro Manila Subway Project (MMSP), LRT-1 Cavite Extension, LRT-2 East Extension and MRT-3 rehabilitation.

The Japanese envoy said there had been "renewed and growing interest" among Japanese investors in the Philippines, especially as both countries gradually recover from the impacts of the coronavirus disease 2019 pandemic.

Koshikawa also pointed out that need to develop more disaster prevention-related infrastructure in the Philippines and provide a unique opportunity for Japanese companies to leverage their experience, know-how and technology.

'Amend CREATE'

Just as the Philippines doubles efforts in attracting investors, Koshikawa said the country should also "create a level-playing field for its business environment" that is as attractive or more attractive than its Southeast Asian neighbors.

Koshikawa said the CREATE Act of 2021, with all its good intentions, "has been cited as having made the business environment less competitive".

"Fortunately, legislators are currently deliberating the CREATE MORE bill in the lower house which has the potential to resolve the taxation challenges being faced by export-oriented companies," he said.

"We strongly hope that the proposed amendments will soon be realized," he added. Koshikawa warned that if the VAT-related provisions are not appropriately amended, "many companies, including that of the Japanese, may pull-out their businesses in the Philippines".

The envoy said Japan has always been a top investor in the Philippines over the last decade, but compared to investments made through Singapore and the Netherlands, "Japanese companies have invested more than what is represented in the statistics". (PNA)
