IMUS CITY, Cavite - Imus City Mayor Emmanuel Maliksi urged on Friday the officials and members of the city's livestock association, including meat vendors, dealers, hog raisers, and the public to support the efforts to remain Asian swine fever (ASF)-free by helping "police our ranks."

Maliksi made the call as he led city officials and Imusenos in a boodle fight - a "military" style eating in which food, comprised of pork-based dishes, piled on top of banana leaves were laid out on long tables to be eaten with bare hands - at the city's public market.

Exhibit revisits Cavite town's early 20th century livelihood

KAWIT, Cavite -- The historical town of Kawit may be synonymous to General Emilio Aguinaldo's declaration of Philippine independence in 1898 and his iconic abode, which now turned into a shrine and museum in his honor. Aside from this, the town is also known for its leading livelihood activities in the early 20th century.

This is the highlight of the National Historical Commission of the Philippines' (NHCP) free exhibit, dubbed "KA(la)WIT: Baldomero and the Livelihood of early 20th century Kawit" at the Museo ni Baldomero Aguinaldo (MBA) in Binakayan village which opened here on Friday.

"The exhibit aims to in-

form the present generation and the public not just about the town's origin but its livelihood activities back at the era when it was still considered a predominantly agricultural town," MBA curator Ahzel Miral said.

From Ka(la)wit to Kawit Founded in the 16th century, what is now known as a first-class municipality is considered one of Cavite's oldest towns. It was popularly referred to as Cavite el Viejo (Old Cavite) during the Spanish era, where its name was derived from the word "kalawit" or hook, "in reference to the small hooked-shaped peninsula jutting out to Manila Bay from Cavite," Miral said

One of the nearest towns from the Manila, Kawit is considered as a highly-urbanized town. But back in the early 20th century, Cavite el Viejo was a relatively small pueblo in terms of population and land area where most of its lands were used by the olden townsfolks for farming.

Grade 1 pupils of Bertrand Russel (Binakayan village) try the mock-up salt-making activity, one of

The boodle fight was done to assure residents that the pork sold in Imus city is safe to eat and that the city is ASF-free, Maliksi said.

The activity is also aimed to help meat vendors, dealers and hog raisers in the city to promote their live pigs, meat, and meat by-products to the public and to continue the awareness on ASF. As he advised the public to remain vigilant and help in monitoring its members' activities, Maliksi's advice to meat vendors, dealers and hog raisers at the event is to start with its members.

"Kaya sa mga miyem-

bro natin tayo magsisimula, ipupulis natin ang ating mga miyembro (That's why we start with our members, we'll police our ranks), " he said.

He also advised the association to deputize its members to initiate its own information drive, and to include those who do not sell pork or livestock.

The information drive, Maliksi added, will prevent the public from buying pork meat or live pig from ASF-affected areas. Imus city government is aggressive in its information drive to prevent ASF from entering the city by using all possible platforms available in traditional and non-traditional

"Pag nakapasok yan dito, mas malaki ang magiging epekto nyan sa ating hanapbuhay, negosyo (If ASF enters the city, it will have a bigger impact on our means of livelihood, business)," the mayor said. The other initiatives done by the city to prevent the entry of ASF include an Executive Order to impose the temporary ban on entry of live pigs, pork and pork by-products coming from ASF-affected areas; strict implementation of "No Shipping Permit, No

Veterinary Health Certificate, No Acceptance" for slaughter; and monitoring of backyard hog raisers in the city to stop swill feeding to pigs. The city also holds post-slaughterhouse inspection in all public and private markets including supermarkets in the city to ensure that all meat comes from accredited slaughterhouses and undergoes the proper inspection. Maliksi also called on the public to report to the city veterinary office any unusual death or disease observed on their animals and to implement biosecurity in their farms. (PNA)

In 1884, with an area of 1,542 hectares, the town was composed of six barrios--Poblacion, Binakayan, Putol, San Juan, Gahak, and Tabon-- 1,193 hectares of which were devoted to farming, while the rest was idle land.

"The exhibit coalesces the words Kawit and Kalawit as it combines the town and its most notable imagery of the farming industry."

The exhibit will also take the guests back in the early 20th centuries to explore the town of Kawit in the perspective of the leading

livelihood activities, "when aside from farming, Cavite el Viejo (old Cavite) also had other industries like fishing, salt production, and blacksmithing," Miral added.

Of its leading livelihood activities back then, only the salt production and blacksmithing remain. These industries are only some of the reasons why the town remains popular among tour-

Another Aguinaldo in history

The exhibit also aims to transmit and disseminate significant information about another Aguinaldo who figured in history, Baldomero, where a shrine and museum in his honor is also managed and run by NHCP.

"In this atmosphere (where we present the leading livelihood activities), we inject the image of Baldomero Aguinaldo, a general of the revolution, a Kawiteño, and a farmer," Miral said.

The exhibit, which runs until Nov. 30, will also put into context how Baldomero Aguinaldo lived as a farmer after the revolution and retired to a private life in his humble abode, now known as the MBA.

The exhibit also aims to inform the public of another Aguinaldo who figured in history, Baldomero, a general of the revolution, a native of Kawit and a farmer. (PNA photo by Gladys S. Pino)



INTENSIFYING AWARENESS ON ELIMINATING VAWC

The Provincial Social Welfare and Development Office intensifies its advocacy to achieve a safe and violence-free province with the conduct of a Gender Based Violence Awareness Seminar at the Ceremonial Hall of the Provincial Capitol Building in Trece Martires City on September 26, 2019. The activity was attended by male employees of the provincial government, PNP Women and Children Protection Desk (WCPD) Officers, Men Opposed to Violence Everywhere (MOVE) Officers and Barangay VAW Desk Officers to encourage them as active partners in integrating efforts to eliminate Violence Against Women and their Children (VAWC).

The group were welcomed by Provincial Administrator for Community Affairs, Mr. Alvin Mojica, who called for everyone's cooperation in promoting awareness on preventing VAWC which should start at home and in the workplace.

Meanwhile, Third District Board Member Dennis T. Lacson advocated for equality by removing discrimination and shared some examples showing unequal treatment between men and women in society. He also stressed out that a good husband should know how to treat his partner right, quoting "Gawin mo yung tama siguradong hindi ka magkakamali". Likewise, former Board Member Irene Bencito urged the partakers to put an end on gender stereotyping. She added that in order to gain respect, one should also treat people with respect.

The seminar was led by PCPT Renalyn P. Lim, Chief of WCPD and Social Welfare Officer II Rodolfo C. Buhay, RSW. PCPT Lim reported the VAWC situation and problems of LGUs based on the data gathered from January 2018 to August 2019. In 2018, out of 603 children cases, 207 were physical injuries/intentional mutilation cases and 153 rape cases while as of August 2019, out of the total 300 cases, 88 were physical injuries/intentional mutilation cases and 72 were other acts of abuse which mostly happened in the City of Dasmariñas, Bacoor and Imus. She also elaborated the Anti-Photo and Voyeurism Act (RA 9995) reiterating the liabilities and penalties to be imposed in committing the crime and violating the law. She reminded everyone to use social media wisely and always think before they act or share.

Topics on Gender Based Violence, Anti-Violence Against Women and their Children (RA 9262) and Anti-Human Trafficking (RA 9208) were conversed by Mr. Buhay. He provided the ratio of VAWC classified into physical, sexual, pregnant women violence. He also tackled the 3 elements of trafficking which are acts, means and purposes and said that this kind of crime can be reported to the barangay, the PNP and local social welfare office.

During the discussion, representatives from Office of the Provincial Governor Mr. Bholie Razon and Mr. Albert Sañez shared their own perceptions about the training course. Mr. Razon encouraged them to have a balanced and equal treatment between men and women while Mr. Sañez shared his belief that women deserve to be loved not to be hurt.

To determine the effectiveness of the program and draw commitment, participants were asked to write down what they will do to end violence in the aspect of personal, family and in the workplace.

As a response, representative from PG-Enro Mr. Arnel Paredes underscored the importance of respect regardless of gender, age and beliefs while Dasmariñas City WCPDO Maria Victoria Divina hoped that the lecture will serve as motivation for participants to use their voice in eliminating violence to the community.

In closing, Social Welfare Officer III Ms. Henelyn Lapizar left a word of advice reminding participants to share with their colleagues what they have learned, encouraged them to put it into practice and as a public servant, always lend a helping hand to others.



49 ASPIRING YOUNG ENTREPS GRADUATED IN PCLEDO BIZ ICREATE BATCH 2



Aiming to empower future young entrepreneurs, the Provincial Cooperative, Livelihood and Entrepreneurial Development Office (PCLEDO) and World Vision Development Foundation, Inc. facilitated the last session of BIZ iCREATE-Cavite's Responsible Entrepreneurs Aiming Toward Economic Sustainability for the Youth Sector on September 27, 2019 at the PCLEDO Training Area, CaCoDec in Trece Martires City.

The last session involved the business plan presentation of the nine groups, divided into 2 sets with each group given 20 minutes to discuss and defend their business plan. Panelists were Cavite State University-Main Faculty Researcher Mr. Zandro M. Catacutan, Vice President of M2B Commercial & Trading Corporation Mr. Michael Bacanto,

Technical Program Manager on Economic Development of World Vision Mr. Cesar M. Bautista for Set 1 while Owner of Aqua 4A & Reclusado Marketing Mr. Allan G. Reclusado, Owner of Precious Knowledge Training Center Ms. Angelina M. San Pedro and Program Manager on Economic Development of World Vision Mr. Douglas Chua were for Set 2. During the presentation, panelists recommended ways on how to enhance their products and services, shared insights on how to handle their target market and how to identify proper packaging, brand name and pricing. They also underscored the significance of being unique in the business industry. Forty-nine young aspiring entrepreneurs consisted of Pag-Asa Youth Association of the Philippines (PYAP) members from different cities and

municipalities successfully completed the Batch 2 BIZ iCREATE training. The graduation ceremony was held at the Ceremonial Hall of the Provincial Capitol Building in the afternoon. They were congratulated by Provincial Administrator for Community Affairs Mr. Alvin Mojica who shared the reason behind why PYAP has been very close to his heart, as he was once a PYAP member in his early years. He encouraged the young ones to finish their studies and pursue a job or put up their own business.

In order to support the business journey of the young hopefuls, the local government gave cash incentives that will serve as starting capital for their small business. Likewise, Mr. Bautista of World Vision Development Foundation, Inc. expressed his appreciation to the administration for be-

ing aggressive and active in boosting entrepreneurship in the province.

Dr. Aldrin P. Antivola, BIZ iCREATE Resource Person, compared the journey of graduates to the cycle of caterpillar that turns out to be a beautiful butterfly and to an eagle who knows how to soar high. Highlight of the program was the announcement of winners for Best in Business Plan which was awarded to the City of General Trias (Chicken N' Marbles) coached by Mr. Reclusado and City of Dasmariñas (Brownut Company) coached by Mr. Bacanto.

On behalf of BIZ iCRE-ATE Batch 2, Ms. Mirriam Salacayan took the opportunity to thank everyone who has been part of the program. She shared that it is not easy to manage a business as it needs focus and strong determination to make it work.
