"This is also dangerous to those with preexisting health conditions such as asthma, heart and lung diseases, as well as the more vulnerable ones like the elderly, pregnant women, and children. We are repeatedly advising the public to limit their exposure to vog by staying indoors and using N95 masks,"

Bornas said during an RDRRMC meeting on October 9 that they have observed for the first time a prolonged high-concentration volcanic degassing in the volcano, similar to what happened at the Miyakejima Island in Japan when Mount Oyama emitted volcanic gases for

five years after it erupted in not all the [risk] factors are 2000. "May mga cycle na tumataas [at] bumababa, pero it is generally decreasing. We can expect that this will go on for five (5) years [and] we have been experiencing this for two and a half years."

When mixed with rainfall, volcanic gas emission also converts into acid rain which can damage crops and corrode metal surfaces such as roofs and vehicles.

On October 8, the Department of Health (DOH) IV-A logged 714 cases of respiratory complaints due to exposure to volcanic gases, including 638 in Batangas, 49 in Cavite, 16 in Laguna, and 11 in Rizal Province who have experienced symptoms such as fever, eye and respiratory irritation, sore throat, breathing difficulties, cough, rashes, and other symptoms.

"We acknowledge that

measurable and that they are supporting evidence. But the diagnoses and actions should not be based solely on instrumental data. We need preemptive and proactive measures. Aside from the scientific measurements, we need to undertake other actions that are proactive." DOH Region 4A Disaster Risk Reduction Management in Health head, Dr. Voltaire Guadalupe said. Several local government units in the region suspended face-to-face classes on Monday to lessen the students' exposure to unhealthy air.

Air quality assessment by the Department of Environment and Natural Resources (DENR) - Environmental Management Bureau (EMB) IV-A shows 0.071 ppm sulfur dioxide concentration in Tagaytay City on October 8. "This means that the [air quality] was still okay, but we are already alarmed due to the high concentration of sulfur dioxide in the ambient air." explained EMB Environmental Specialist, Stephanie Rei Batungbakal. Meanwhile, its Talisay monitoring station reported better air quality, recording normal sulfur dioxide, PM10 and PM2.5 concentration levels on October 7.

In its October 10 advisory, PHIVOLCS said that Taal Volcano remains under Alert Level 1 as upwelling of volcanic fluids is still being observed in the Main Crater

The Bataan-Cavite Interlink Bridge (BCIB) and Panay-Guimaras-Negros Inter-Island Bridges (PGNIB) are expected to start their construction within the next two years, Department of Public Works and Highways (DPWH) Secretary Manuel Bonoan told senators on Tuesday.

For the BCIB, Bonoan said the detailed engineering design is almost complete and already set to be presented to the National Economic Development Authority (NEDA) within the week.

Meanwhile, he said the PGNIB's engineering design will undergo a rebidding process by next year.

"For Panay-Guimaras, the detailed engineering design is for, unfortunately, it's going to be rebid --the consultancy services for the detailed engineering design. But we are confident that we will be able to award by December this year and so that the detailed engineering design will probably commence by next year," Bonoan said during the Senate deliberation of next year's proposed budget of the DPWH, assuring that by 2025, the BCIB's civil works can start.

# Multiple poll watchers of bets considered vote buying

The Commission on Elections (Comelec) on Monday warned candidates for the Barangay and Sangguniang Kabataan Elections (BSKE) that deployment of multiple poll watchers may already be considered as vote buying.

"Dapat po isang watcher lang sa kada presinto, minsan kumukuha sila ng dalawa bilang alternate. Minsan, isa muna sa umaga, tapos magpapalit sa hapon kapag magbibilangan na (There should only be one poll watcher per precinct, sometimes, they get two as alternates. At times, one watcher is present in the morning, and will be changed in the afternoon during the canvassing of votes)," Comelec Chairperson George Erwin Garcia said in an interview

with Radyo Pilipinas. "Yung iba po ginagawang singkwentang watchers sa isang presinto. Iyan po ay ico-consider nating vote buying sa ating bagong patakaran (Others have 50 watchers in a single precinct. That shall be considered vote buying under our new guidelines)," he said,

Garcia explained that this may fall under the presumption of vote buying and vote selling, which could result in the candidates' disqualification, or being charged with an election of-

He said the poll body will only allow alternate poll watchers on October 30.

Identifying multiple poll watchers per candidate is much easier now, considering reports from the public, he added. "Pwedeng mai-report sa amin iyan at pwedeng gawing basehan ng pormal na kaso... kahit na report lang, kami na mismo ang nangangalap ng ebidensya (That can be reported to us, and that may be used as basis of a formal complaint, even it's only just a report, we will be the ones to gather evidence)," he said.

He also insisted that only personnel from the Parish Pastoral Council for Responsible Voting (PPCRV) are authorized to assist voters, not the so-called "watchers" of BSK bets.

Garcia also cited the PPCRV's authorization to secure the voters' list alongside designated precincts under its assistance help desk.

The Comelec, meanwhile, is almost a hundred percent done in its preparation for the October 30 polls, according to Garcia.

"Patuloy po ang pagdala natin ng accountable forms, mga balota at election returns. Nakumpleto na rin iyong aming tini-train na mga guro (We are continuously delivering accountable forms, official ballots, and election returns. We have also completed the number of teachers being trained),"

he said. Garcia said the poll body targets to finish the delivery of all accountable forms nationwide this week.

Last October 5, the Comelec started the deployment of official ballots and accountable forms, with the first batch sent to the Bangsamoro Autonomous Region in Muslim Mindanao (BARMM) and Caraga.

Accountable forms in the farthest regions in the country are being prioritized in the deployment, with the National Printing Office (NPO) assigned in northern areas including Cordillera Administrative Region (CAR), Ilocos Region, Cagayan Valley, Central Visayas, and the National Capital Region; and all other remaining regions' official ballots coming from Comelec's warehouse in Sta. Rosa, Laguna.

The Comelec said it has a real-time tracker of the election paraphernalia being delivered through a shared technology with the Philippine National Police (PNP).

Likewise, Garcia assured focus on the preparations for the voting setup of the vulnerable sector, including senior citizens, persons with disabilities, and pregnant women.

He also cited preparations for the voting of persons deprived of liberty (PDLs). The poll body, meanwhile, is scheduled to have its final briefing for the upcoming BSKE by October 20. (PNA)
