The first leg of the hearing on October 9 was presided by Vice Governor Athena Tolentino with Board Member Maurito Sison who delivered the opening remarks.



other health care services. "What my spouse and I want is to bring services to the people. These are just baby steps, and hopefully we will be able to make a difference all around the country," the First Lady said.

Francisca Villanueva, a 68-year-old resident of Tagaytay City, was among the recipients of medical assistance and maintenance medicine.

"We are grateful to the government because it is able to provide medical support to seniors like us," she added.

The LAB caravan had previously visited Carmona, Silang and Dasmariñas in Cavite and the provinces of Batangas and Laguna, where it also brought free medical consultations, laboratory testing, and medicine to communities.

Its ultimate goal is to achieve universal health care, ensuring that all Filipinos have equal access to high-quality and affordable healthcare products and services while being protected from financial risks.

Araneta-Marcos the free healthcare services represent the Marcos administration's commitment to providing accessible primary care services to the people.

"I just want to thank everyone for your hard work and support in coming here and helping those in need. Thank you very much to all of you, sama sama tayong babangon muli para sa Bagong Pilipinas," she added.

The Department of Health-Calabarzon said the LAB program is in keeping with the government's commitment to provide access to healthcare services to the people. SMC, gov't forge CSR collab to clean up & rehab Luzon rivers

Three years after it launched its landmark river cleanup and flood mitigation initiative--which has led to the removal of over 3 million metric tons of silt and solid wastes from the Pasig, Tullahan, and San Juan Rivers--San Miguel Corporation (SMC) is setting its sights on a more ambitious goal: cleaning up and rehabilitating three major river systems as well as other tributaries and waterways throughout Metro Manila, Pampanga, Cavite, and Bulacan.

Dubbed as "SMC's Adopt-A-River program", this initiative is possibly the country's biggest and most impactful corporate social responsibility (CSR) effort in collaboration with the national and local governments.

The initiative has gained broad-based support from various stakeholders, including national, provincial and city governments, whose localities stand to benefit from the massive undertaking.

Department of Environment and Natural Resources (DENR) Secretary Ma. Antonia Yulo-Loyzaga and Department of Public Works and Highways (DPWH) Secretary Manual Bonoan led national government support for the program at the formal signing of the memoranda of agreement. Also present at the signing and joining the effort were Cavite Gov. Juanito Victor Remulla, Pampanga Gov. Dennis Pineda, and Navotas City Mayor John Ray Tiangco.

"This initiative is unlike lo-Loyzaga lauded the com-

anything we have seen before. It is perhaps the most extensive environmental effort involving both government and the private sector. In one decisive move, we are cleaning up many major rivers and waterways. We are doing this as a public service, at no cost to the government or taxpayers," SMC President and CEO Ramon S. Ang said.

He added that: " It is important to understand that cleaning up rivers is not a quick fix. It is a very important step in the river restoration process. It paves the way for polluted waterways

SMC began its river advocacy three years ago spending over P3 billion and removing over three million metric tons of oil and waste from Pasig River, Tullahan River and San Juan River.

The massive initiative covers the following rivers:

- River systems in Bulacan including the Meycauayan, Maycapiz-Taliptip, and Mailad Rivers, the Bambang Creek, Marilao River, Sta. Maria River, Guiguinto River, Pamarawan River, Labangon-Angat River, Malolos River, and Hagonoy River.

- Waterways in Navotas City, including Muzon River, Batasan River, and the Navotas River
- San Pedro River in La-
- San Juan River DENR Secretary Yu-

pany for its continuous efforts to clean up major river systems and the expansion of the program, aligned with government's environmental objectives.

"This partnership enables DENR to achieve three main mandates by investing and allowing water to flow and impound it correctly where it is needed. Most of all, we are able to fulfill a new role assigned to us by our President when he created the Water Resources Management Office... We are very grateful to San Miguel Corporation for its kind and generous support to our government activities," Loyzaga

For his part, DPWH Secretary Bonoan said: "We commend SMC for taking this noble initiative, for using your own resources and manpower to rehabilitate rivers that will benefit numerous communities and residents of various provinces. The initiative not only reflects commitment to environment stewardship, but also signifies dedication to preserving our rivers that have suffered the brunt of pollution and neglect and human activities."

The local government partners also extolled the efforts of SMC to clean up waterways in their areas.

"What they plan to do is solve the problem in Noveleta, Rosario, General Trias, and Imus, which comprise maybe 10% of the land area, but 90% of flooding. With JICA and San Miguel, we expect to solve flooding in



Cavite 100%," said Cavite Governor Remulla.

"What affects Bulacan affects Navotas, affects Manila, affects Cavite," Remulla continued. "(Ramon Ang) brings us together to realize there is hope for this country if we act together."

For his part, Governor Pineda said: "Noong nakaraang kalamidad, talaga pong namorublema kami kung paano bibigyang solusyon ang baha sa probinsya. Kaya nagpapasalamat po ang mga Kapampangan kay boss Ramon Ang at sa SMC... Alam ko po na ang gagastusin ninyo dito bilyon, pero wala po kayong inaasahan na kapalit. Hindi po namin makakalimutan itong tulong na binigay niyo."

Navotas City Mayor Tiangco, who lauded SMC's cleanup of the Tullahan River in support of the rehabilitation of Manila Bay, said: Our ultimate goal is to restore the waters surrounding Navotas to a classification fit for fishing, aquaculture, and other recreational water activities. Hence, we fully support San Miguel Corporation's Adopt-A-River program and its noble endeavor to clean up and rejuvenate bodies of water."

Ang said that while the expanded project already covers the major rivers and waterways that significantly contribute to flooding, the initiative may still be expanded as needed, should government request the coverage of more rivers.

He added that SMC has already started conducting bathymetric studies on the rivers, to determine problem areas that have become shallow due to decades of accumulated silt and garbage. DENR and the company will then develop the appropriate dredging plans.

Over the last three years, as it implemented its ambitious P3-billion cleanup effort for the Pasig River, Tullahan River, and San Juan River, SMC has acquired various specialized heavy equipment that enable it to conduct river cleanup efforts in various conditions more efficiently.

Ang said that its cleanup personnel have also gained significant experience and skill in conducting cleanups efficiently and according to government standards.

SMC's efforts have been credited with lesser incidences of flooding throughout Metro Manila, despite the yearly succession of typhoons, as the removal of millions of tons of solid wastes have deepened and widened once shallow and heavily polluted rivers.

This has complemented the government's continuing flood mitigation efforts, including the putting of pumping stations in critical areas.

Job fair caravan held in Tagaytay City

Job seekers were able to submit their resumes, engage in on-the-spot interviews, and learn more about the companies and their available positions. This direct interaction allowed applicants to make a personal connection with

DOH launches framework to combat mental health stigma

CALAMBA CITY, Laguna (PIA) -- The Department of Health (DOH) has launched its Mental Health Strategic Plan 2024-2028, as part of its bid to promote mental health literacy and address the stigma in seeking professional help.

The Mental Health Strategic Plan is a five-year framework in reducing premature mortality, prevent and treat substance abuse, and reduce the vulnerability of individuals and communities to mental, neurological, and substance use disorders.

According to DOH, the plan will deinstitutionalize mental health care by easing access to support services in the communities with its collaboration with the Quirino Memorial Medical Center.

"In Calabarzon, many have already adopted the community-based approach on mental health. Municipal and City Health Officers who were already trained are helping diagnose patients," Geneva Calanog, Mental Health Program Outcome Manager of DOH Calabarzon said.

Calanog further explains, "It's either sila mismo 'yung tumitingin sa pasyente or minsan bumababa kami na may kasamang psychiatrist from the Quirino Memorial Medical Center and the National Center for Mental Health para mag-supervise. Kasi minsan, kahit trained ka na mayroon pa ring mga agam-agam to diagnose whether this is really a mental health situation"

To further capacitate health workers in addressing the mental health gap in the region, the DOH said they will also conduct post training supervision in the community.

"[Starting] the first quarter next year, we will conduct post training supervision to see if the Municipal Health Officers are practicing the mental health gap. We also need the masterlist of patients for the allocation of psychotropic drugs."

Calanog believes that although mental, neurological, and substance abuse literacy among

the general public is improving, patients are still hesitant to seek professional health due to stigma. "They are ashamed to seek professional help, in fear that they will be judged. Although times have changed, and mental health is freely discussed, stigma [on the issue] still exists." Calanog said.

Health institutions have reported around 2,015 cases of mental health disorders in the region, with Laguna Province recording the highest number of reported cases with 764, followed by the provinces of Quezon (509), Cavite (278), Batangas (243), and Rizal (222). (PB)

Graduates, employers very satisfied with tech-voc training - TESDA



According to surveys done by the Technical Education and Skills Development Authority (TESDA) for the last five years, tech-voc graduates are "very satisfied" with the training they received.

Likewise, employers who hired graduates of technical vocational education and training (TVET) programs found the performance of these workers to be "very satisfactory".

The results on the satisfaction of the TESDA graduates is based on TESDA's Study on Employment of TVET Graduates (SETG) in the last five years, which disclosed that the delivery of the training program has significantly influenced the employment rate in relation to the overall satisfaction of the graduates in their respective training programs.

"The SETG in the last five years have shown that an average 93% of tech-voc graduates are either 'very satisfied' or 'satisfied' with their training," said TESDA Secretary/Director General Suharto T. Mangudadatu.

Likewise, in the last five years, 52.33% of TVET graduates on average found that the skills they had acquired were very useful, while some 31% conveyed that they used some of the competencies they acquired from their tech-voc training.

"We regularly ask tech-voc graduates to their training based on entry requirements, trainers' methodologies, tools and equipment, knowledge expertise of the trainers, learning materials, training activities, training facilities, training duration, level of knowledge, skills and attitudes acquired, and assessment method," explained the TESDA head.

The SETG is conducted annually to measure the relevance and effectiveness of tech-voc training programs.

This information is further validated in TESDA's annual Employment Satisfaction Survey (ESS), which recorded employers to have rated their tech-voc graduates' performance to be "very satisfactory" on average in the last four survey rounds.

The ESS serves as one of the monitoring and feedback mechanisms to generate inputs and comments from the industry regarding their perspective on the performance of employed TVET graduates, TVET provisions, certification, and other TVET-related areas.

Meanwhile, according to Secretary Mangudadatu, many tech-voc graduates who have trained under TESDA have found success after finishing their respective training programs.

One of them is Joeminel Cutcharo, a holder of Automotive Servicing NC I to NC IV at TESDA's Auto-mechanic Training Center in Eastern Visayas. Joeminel, a victim of typhoon Yolanda, took up his tech-voc course as a way for his family to recover from the disaster. Joeminel went on to represent the Philippines and earned medals in the ASEAN Skills Competition in Thailand, and the WorldSkills Competition in Russia. He currently works as an automotive technician at the Laguna plant of a known Japanese car manufacturer.

Another TESDA graduate, Chef Roxanne Joy Magday-Ningala, took Bread and Pastry Production NC II training at the Provincial Training Center in Nueva Vizcaya after she quit her job as a domestic helper in the Middle East. Currently, she is now employed at a large dessert shop and wholesale bakery in Malé, Maldives, and has even assisted the world's top Master Chefs.

"These are just a few real-world examples of the impact that TESDA and tech-voc has made on the lives of its graduates," added the Secretary. (TESDA)

COMELEC, PNP on alert for 2023 BSKE, Taal volcano activity



Authorities in the Calabarzon region are keeping a close watch on the conduct of the 2023 Barangay and Sangguniang Kabataan elections (BSKE) and the continuing activities of Taal Volcano as election day draws near.

Police Major Gerry Malipol said more than 9,000 personnel from the Philippine National Police Regional Office IV-A are ready to be deployed along with the Armed Forces of the Philippines, Philippine Coast Guard, Bureau of Fire Protection, and the Regional Maritime Unit to ensure safe and fair elections.

The Commission on Elections (Comelec) is also on alert on the activities of Taal Volcano, which may affect the conduct of elections in surrounding areas.

Lawyer Gretchen Dolarte, Batangas provincial election officer, said the poll body is prepared to declare a 'failure of election' if incidents such as fire, flood, earthquakes, or similar events occur on election day.

"Our top priority is the preservation of life, so our election board is required to evacuate polling places if necessary. However, they must report the situation to our election officers and secure all equipment and supplies. They must also inform the party representatives, citizen arms, and watchers about any transfer or suspension of voting," she said.

In past barangay elections, the PNP recorded a minimal number of election-related incidents involving candidates and their supporters. Incidents included two cases in 2010, three in 2013, and two in 2018.

"Despite these incidents, it is safe to assess that the BSKE in the region were generally peaceful. Nevertheless, we continue to monitor the presence of potential private armed groups that may be involved in activities related to the election period," Malipol said.

Under the Omnibus Election Code, an election may be postponed due to violence, terrorism, loss or destruction of election paraphernalia or records, force majeure, and other situations that would undermine the conduct of a free, orderly, and honest election.

Calabarzon comprising Cavite, Laguna, Batangas, Rizal and Quezon has 15,660,770 registered voters for the October 2023 polls, making it the most vote-rich region in the country. (PB)
