

PHP40,000 worth in guarantee letter to the funeral service provider to cover the burial expenses.

DSWD-Calabarzon regional director Dr. Barry Chua said the department also offered education assistance to the victim's 6-yearold daughter.

Digna Esguerra-Cabrera, Ahldryn's grandmother, thanked the DSWD for providing necessary support to the family left by the victim.

unless they have a valid reason to leave. Provincial Ordinance No. 420-2023, otherwise known as the "BSKE 2023 Curfew Ordinance," imposes a daily six-hour curfew within the boundaries of

the province from Oct. 19 to 30. The edict mandates that all individuals, regardless of age, remain indoors, and not loiter or assemble in public during the hours covered by the curfew. Exempted from

the order are election officers and those performing official duties related to the elections, law enforcement officers, people traveling to or from work or in emergency situations, and individuals

with parental permission for essential activities. The Sangguniang Panlalawigan of Cavite approved the curfew ordinance during its 63rd regular session held in Trece Martires City on Monday.

VP Sara: Set aside politics, brace for impending economic challenges

Vice President and Education Secretary Sara Z. Duterte urged her supporters on Wednesday to divert their attention in preparing for the economic implications that the war in the Middle East and Ukraine may bring to the Philippines.

This, after supporters of Duterte started posting green ribbons on social media amid the issues being hurled against her in connection with the request and spending of confidential and intelligence funds (CIF) by the Office of the Vice President (OVP) and the Department of Education (DepEd).

In a statement, Duterte said politics should be set aside and focus more on ensuring that every family is secured and stable in the coming months.

"Naiintindihan ko ang inyong pagkadismaya at galit hinggil sa mga isyu tulad ng pakikialam sa budget at usapin ng confidential fund. Among those who showed their support to the Vice President was Batangas Vice Governor Mark Leviste who posted in his Instagram a photo of a green ribbon with "Sara" and "I stand solidly with my Vice President" in it.

Duterte said these expressions of support and trust gives her the inspiration to continue serving the country.



She, however, said unity and preparedness should come first especially that the price of commodities continue to spike. "May oras para sa lahat at hindi ito ang panahon ng paninira at pamumulitika lalo na malayo pa ang susunod na eleksyon (There is a time for everything and this is not the time for detraction and politicking especially the next (national) elections is still long way ahead)," Duterte noted.

The OVP and DepEd were among the agencies that were stripped of CIF at the House of Representatives to reallocate it instead to law enforcement agencies. (PNA)

He added that the Comelec shall also deploy poll materials for the pilot automated elections from the Comelec warehouse in Sta. Rosa, Laguna.


"Today, Oct. 18, is the scheduled deployment and delivery of OBs (official ballots) and AES (automated election system)-related items for use in the "pilot areas" regarding the automated BSKE," Garcia said.

Pilot areas for automated polls include Barangay Pasong Tamo in Quezon City District 6 with 60,766 voters; as well as Barangay Paliparan III and Barangay Zone II in Dasmariñas City, Cavite, with 51,435 and 1,475 voters, respectively.

The Comelec, meanwhile, has yet to receive confirmation on the completion of delivery in the Bangsamoro Autonomous Region in Muslim Mindanao, Zamboanga Peninsula, Northern Mindanao and Soccsksargen.

Earlier, the Comelec assured to prioritize deployment to the farthest areas in the country with the help of the Philippine National Police, Armed Forces of the Philippines, and the Philippine Coast Guard.

For Metro Manila, the scheduled deployment of official ballots and other election materials is set from Thursday to Friday. (PNA)
