Cavite City Hall of Justice closed due to COVID-19

After a number of its employees tested positive for the 2019 novel coronavirus disease (COVID-19), the Cavite City Hall of Justice has been ordered temporarily closed until October.

The Supreme Court Public Information Office (SCPIO) said in its Twitter post on Thursday, Sept. 24, the closure of the office will be from Sept. 24 until Oct. 7.

Cavity City Executive Judge Franco Paulo Arago issued the temporary closure



order pursuant to the executive order of Cavite City Mayor Bernardo Paredes and with prior consultation with Deputy Court Administrator Raul Villanueva.

Arago cited that "several employees of the Cavite City Hall of Justice have tested positive for COVID-19."

The magistrate explained the temporary closure will "give way for the thorough disinfection of the entire Hall of Justice and also for purposes of conducting contact tracing of those with whom said employees had close contact with."

"During this period, MTCC (municipal trial courts in cities) and RTC (regional trial court) Branches, including their respective OCCs (Office of the Clerk of Court), may be reached through their official email address and mobile numbers as posted in the Supreme Court website as well as at the entrance of the Hall of Justice," he advised the public.

Aside from the Cavite City Hall of Justice, the SCPIO said that Halls of Justice of Iloilo City and Tayug in Pangasinan have also been closed due to COVID-19 infections.

The Iloilo City Hall of Justice was ordered closed from Sept. 24 to 25 by Executive Judge Victor Gelvezon so that it can undergo disinfection.

Likewise, the Tayug will undergo disinfection and will be closed starting noon on Friday, Sept. 25, as directed by Executive Judge Emma Ines-Parajas.

The provision of computer tablets is part of the local government's program in support of education in the New Normal with the use of blended learning modality, online classes supported with learning modules.

In partnership with Smart PLDT, the free tablets include free Smart Sim cards with LTE or Free Data that can be used to access the internet. Also, the municipal government ensured access to the internet with the installation of Free WiFi Hotspots in all 16 Barangay Centers, 7 Public Elementary Schools, 1 Junior High School, 1 Senior High School, in some covered courts, and at the municipal plaza.

"We thank the LGU, Mayor Dino Chua for the initiatives to help us face the challenges of education in the New Normal, as you have always supported us and the students of Noveleta," Asst. The LTFRB said the re-

ernment units (LGUs) covering the routes following a "comprehensive agency engagement" with stakeholders, including the terminal and bus operators.

Based on the circular, drop-offs and pickups in any part of the modified routes are prohibited except for the designated stopover points and terminals where the bus will last stop. The public vehicles would be monitored by authorities via the global navigation satellite system. Operators would also get a QR Code that must be placed on a short bond paper and posted inside the bus. Passengers, meanwhile, need to secure a travel authority/pass from the Philippine National Police near the terminal; a valid ID; a written consent allowing the LGU to subject them for Covid-19 testing or quarantine if needed; and other documents required by the LGU or the Inter-Agency Task Force for Emerging Infectious Diseases (IATF-EID). The LTFRB said both drivers and passengers need to follow the protocols set by IATF-EID, including wearing face mask and face shield, carrying and using alcohol and sanitizer, and following the one-meter physical distancing. Eating, drinking, and talking to other passengers as well as taking calls from a cellphone while inside the public vehicle are also prohibited.

A passenger must get a trip ticket two days prior to the date of travel via an online platform or at the bus terminal itself. "Buying a trip ticket is prohibited on the day trip unless it's an emergency like family problems or health," the LTFRB said. All buses that would travel in modified provincial bus routes would be subject to regular monitoring, the LT-FRB added. (PNA)

Safety protocols for provincial buses pushed

Health and safety protocols should be in place before provincial buses resume operations in Metro Manila beginning Sept. 30, the government's pandemic task force said over the weekend.

Inter-Agency Task Force for the Management of Infectious Diseases and Cabinet Secretary Karlo Nograles made the statement after transport agencies allowed 12 modified provincial bus routes going to Metro Manila

from Batangas, Cavite, Laguna and Pampanga to open.

Based on new guidelines, provincial buses may only pick up and drop off passengers at designated terminals in Metro Manila. Passengers need to secure their tickets two days before the trip except during emergencies. Nograles said there should be proper coordination among local governments to prevent the transmission of COVID-19.

The Land Transportation Franchising and Regulatory Board (LTFRB) has reminded bus operators to strictly comply with standard health protocols. LTFRB National Capital Region director Zona Tamayo said the health of passengers is still the government's utmost concern.

A total of 286 provincial buses will be allowed to resume partial operations in Metro Manila on Wednesday.

Under the LTFRB mem-

orandum circular, stringent protocols should be put in place to mitigate the possible transmission of COVID-19 among passengers.

Officials have reminded passengers not to eat, talk or answer phone calls while in buses. Passengers' body temperature must also be checked prior to boarding buses. Those who have COVID-like symptoms will not be allowed to board. -Romina Cabrera

Gatchalian seeks to improve quality of teacher education, training

Senator Win Gatchalian has filed Senate Resolution No. 526 seeking a Senate inquiry on the quality of teacher education and training in the country, including the performance of Teacher Education Institutions (TEIs).

The quality of teacher education and training and the performance of TEIs eventually reflected in the learning outcomes of students, Gatchalian said, citing the results of the 2018 Programme for International Student Assessment (PISA). The global survey revealed that out of 79 countries, the Philippines ranked lowest in Reading Comprehension and second lowest in both Science and Mathematics.

The senator also cited a Congressional Commission on Education (EDCOM) report which stated that the teachers' poor performance is due to poor teaching training, low quality of students enrolled in teacher training, and meager opportunities for professional development.

Gatchalian emphasized that despite the creation in 1994 of the Teacher Education Council (TEC) and the National Educators Academy of the Philippines (NEAP) in 1992, the training for distance learning, which is a Twenty-First (21st) Century skill that a teacher should readily possess, has only commenced this year due to the COVID-19 pandemic.

TEC is tasked to design collaborative programs for pre-service teacher training, in-service training, re-training, orientation, and teacher development. NEAP, for its part, is mandated to provide the learning and development needs of the increasing number of teachers and school leaders by streamlining professional development.

To date, 620,794 out of 800,000 teachers have been trained for distance learning, the Department of Education (DepEd) reported.

Even before the pandemic hit, Gatchalian said teacher quality has already been a challenge in the country, pointing to the results of the Licensure Examination for Teachers (LET) in previous years. Between 2014 and 2019, the elementary teacher licensure examination results showed that the average passing rate was only 28 percent while results of the secondary teacher licensure examination showed that the average passing rate was only 36 percent.

The expertise of teachers is another cause for concern, Gatchalian said. Elementary and high school teachers are not equipped to teach considerable portions of the K to 12 curriculum, results of the World Bank's Philippines Public Education Expenditure Tracking and Quantitative Service Delivery Study (PETS-QSDS) revealed. Except for English elementary teachers, the average elementary or high school teacher could correctly answer fewer than half of questions on subject con-
