# Grab driver lives up to righteous views

LIFE'S INSPIRATIONS: "... For I am not ashamed of the gospel, for it is the power of God for the salvation of all who believe..." (Romans 1:16, the Holy Bible)>

**GRAB DRIVER LIVES UP TO HIS RIGHTEOUS VIEWS:** Johannes Organo Comia is one Grab Philippines-Metro Manila driver who lives up to a code of prompt service, untainted honesty, and unadulterated truth.

Last September 24, 2019, he was the Grab driver that responded to my request for a ride going to Ninoy Aquino International Airport Terminal 2 on my way to a Central Visayan city for a court hearing, together with my wife, former Judge Angelina Domingo Mauricio.

He was driving smoothly, enough to send me to a short nap. At the NAIA Terminal 2 Departure Area, I got down, got my luggages, and after paying, went inside the terminal to check in.

It was at that point that I realised that my clutch bag containing my IDs and cards, and, of course, my money for the trip, was not with me, and may have fallen inside the car. I immediately called Johannes through his phone and explained my predicament.

Before I finished, he said "yes", my clutch bag was found by him, and he was just trying to call me to return it. He then volunteered to come back to NAIA T 2. Wow. Was I really glad to receive my bag from him. Thank God in His Name of Jesus, Amen!!!

"**MANY FILIPINO DRIVERS ARE ILL-DISCIPLINED**": Lack of discipline among many Filipino drivers as the real reason why Metro Manila is currently experiencing its most harrowing episodes in traffic management was the prime topic of the discussion that I had



with Johannes Organo Comita, a Grab Philippines Metro Manila driver who returned to me my clutch bag that I left in his car on September 24, 2019.

According to Johannes, many Filipino drivers have become too ill-mannered and selfish, wanting to always be ahead of all other drivers on the road. No one want to be in line and wait for their turns anymore, so that their cutting lanes every so often contribute heavily to the worsening of the traffic situation, at any given time.

Johannes vehemently claimed that while he himself had worked overseas for quite some time, he never saw the kind of rude and bad mannered, and totally greedy style of, driving he is now seeing among many of his colleagues on the road. This is the reason why, he said, he does not agree when foreigners say Filipinos are a bunch of good people. "Can someone who is good be lacking in self-discipline?" he asks.

**WHY HAVE DRIVERS BECOME ILL-DISCIPLINED?** What could have caused this malady, I asked Johannes Organo Comia, a driver for Metro Manila of Grab Philippines. Well, I wasn't surprised when he was unable to give any answer. I told him there is one reason for this: it is the devil which is now in control of a great number of Filipinos today, because they no longer have any training and instruction on the Word of God, disabling them from obeying His commands. Johannes could only manage to smile at what I said.

native plants, said Rolando Maningas, information chief of DA-ATI 4-A.

"It is the desire of this book to re-introduce some of these native plants, identified for (their) culinary uses, landscape potentials, and timber utilization, to its readers," Maningas said.

He said priorities in food production changed to products with higher yield, but diversity and sustainability dictate that native plants and fruits should not be ignored.

MoCa Family Farm owner Gigi Morris, who nurtured her interest in native plants, saw the benefits of these plants despite the pressure of the misconception that Philippine native trees have little economic benefit.

Morris said together with other custodian farmers who manage a wide range of native plant production in their own little way, growers, propagators, and promoters of native plants are reaping the benefits of these plants.

She said these benefits include nutritional diversity, food security, income-generating opportunities, ecosystem benefits, and maintenance of cultural identity.

Morris said she hoped the book would lead to the understanding of the economic potentials of native plants. One of the 25 native plants featured in the book, arranged alphabetically, is the alingaro (scientific name *Elaeagnus triflora* Roxb, from the *Elaeagnaceae* family), whose fruit has a sweet, tangy flavor and can be used

to make an excellent savory sauce or sweet jam.

The fruit of the alupag tree (of the Sapindaceae family) may look warty and has a rough peel but its whitish, semi-transparent flesh, wrapped around a black seed, tastes delicious and juicy.

The book contains photos and general information about the plants and their economic potentials, culinary uses, and tips on propagation. (PNA)

the province.

On the other hand, Dr. Ferdinand Mina of Imus City Health Office recommended for a massive HIV awareness campaign tapping the LGBT community through creation of an LGBT organization in Cavite.

Speaking on the 2nd day of the event, Dr. Nelson Soriano, officer-in-charge of the Public Health and Technical Services and Head of Provincial Epidemiology Service Unit of the PHO challenged all the participants to help address the alarming health issue of HIV pointing out that "open networking like social media as a big help in solving the challenges encountered."

6th District Board Member Kerby Salazar, Chairperson-Committee on Health, Nutrition and Population suggested the creation of a program designed for everyone not just focused on LGBT community.

"More than increasing awareness, activities and programs that can help end the stigma should be formulated," said BM Salazar and

promised to utilize his term to improve the healthcare and nutrition program in the province.

The event also served as a venue for the recognition of the major accomplishments of the Provincial HIV Program.

The status and accomplishments of the four treat-

## Open canals seeded with tadpoles in Cavite

Dr. Jonathan Luseco of the City Health Office was joined by village leaders, barangay health workers, and volunteers in tadpole seeding. These tadpoles feed on wrigglers of dengue-carrying mosquitoes.

The vector control method is part of the city's massive drive to contain dengue through the Department of Health (DOH) "Sabayang 4 O'clock Habit para Deng-Get Out" campaign.

Aside from the seeding operation, local and national government agencies also conducted massive clean-up operations in open canals in Barangay Pasong Camachile.

The clean-up teams of volunteers removed trashes that clogged waterways, which are possible breeding sites of the dengue-carrying mosquitoes.

"Dapat po hindi lang local government unit nagtatrabaho, dapat po buong community. Hindi po ito kaya ng CHO lang, ng iilang volunteers lang (this is not the work of the local government unit alone, but of the entire community. The CHO and few volunteers cannot do this alone)," Luseco said in an interview. (Dennis Abrina/PNA)
