#### DOH starts Cavite-wide orientation on BHWs' role under UHC

TANZA, Cavite, Sept. 3 (PIA) - The Department of Health in Region IV-A has started its province-wide orientation of Barangay Health Workers (BHWs) in Cavite about primary health care at the community level and their responsibilities under the universal health care (UHC).

Themed "Sa UHC Walang Maiiwan, BHW ay Kailangan," the two-day capacity building seminar held at Tanza Oasis Hotel on August 29-30 delved not just on its specific role, but includes basic training on health care, "including the preventive and curative aspect," said Chief Local Health Support Division Dr. Noel G.

# CAVITE PROMOTES INCLUSIVE WORKPLACE FOR PWDs



In order to break the barriers in the workplace and enable productive environment for Persons with Disability (PWDs), the provincial government of Cavite through the Provincial Disability Affairs Office (PDAO) conducted the Advocacy Forum in Promoting Inclusive Employment and Barrier-free Workplace in the province held on August 29, 2019 at the DPWH Seminar Area, New DPWH Bldg., Brgy. De Ocampo, Trece Martires City.

Participants to the post National Disability Prevention and Rehabilitation Week Celebration were members of the Provincial PWD Council, officers of the Federation of PWDs in Cavite, city/municipal Public Employment Services Office (PESO) Managers; and some representatives from the private companies, all thankful for the provincial government's initiative to raise awareness among them the provisions of the RA 10524 or the Magna Carta for Persons with Disability, especially on inclusive employment. The orientation on the act expanding the positions reserved for PWDs was led by Mr. Ritchmon Jose from the Department of Labor and Employment (DOLE-

IV-A), discussing its aim to give PWDs equal opportunity for employment. Aside from the nitty-gritty of the act, Mr. Jose left everyone with an important quote from Scott Hamilton saying that "The only disability in life is a bad attitude," which was agreed upon by many.

In addition, a tax technician from the Bureau of Internal Revenue (BIR), Ms. Perlie Ann Garcia highlighted the tax incentives for employers hiring PWDs, sharing that private companies that employ PWDs are entitled to

During the seminar, Regional BHW Outcome Manager Kristine Mariel C. Villasanta stressed that under the UHC, barangay health workers will conduct the profiling of families in their respective areas in order for every family to have a health folder.

"Once a family has this health folder, a health professional or health facility can access a person's health record, history of treatment and medications everywhere in the country. In, short, he/ she can go to any health facility and request for treatment without repeating any procedure already done such as x-rays, blood tests as it is already recorded in the health folder," said Villasanta.

Under UHC, a system will be developed for the identification of those persons most needing medical attention and also to ensure that health care resources will be used to maximize improvements in health.

"It is a vital health care planning tool that will be used for families, communities, and populations," Villasanta added.

There are a total of 21,405 BHWs Region IV-A (Calabarzon) which is composed of the provinces of Cavite (2,182); Laguna (2,054); Batangas (7,686); Rizal (2,476); and Quezon (7,007).

The regional office will continue to conduct a province-wide orientation for all of the BHWs to update them on their functions and responsibilities under universal health care. (Ruel Francisco, PIA-Cavite with reports from DOH IV-A)

Likewise, Ms Tina Puyat from the Office of Board Member Dennis Lacson who heads the Committee on Women, Family, Children, PWDs, Elderly and Social Services at the Sangguniang Panlalawigan pledged for creation of ordinances in the province that will protect

tual or sensory impairments which in interaction with various barriers may hinder their full and effective participation in society on an equal basis with others. However, Ms. Jossa Carreon, a Youtube influencer who has orthopedic disability has her own definition for PWD. Ms. Carreon told listeners and her followers that as for her, PWDs stand for Persons with Determination. She was able to open the minds of everyone inside the room with her words of motivation - to embrace differences and be proud because there's always hope.

Since not having equal opportunities can put one at the back of the pack. PDAO has also invited the Operations Lead of Project Inclusion Network, Mr. Jim Nemeño from the Unilab Foundation, for the discussion on Access to Work Model: Breaking Barriers to Work Place. Mr. Nemeño started his presentation with true stories of employed PWDs to catch attention of participants. He was able to teach how to empower PWD jobseekers through career coaching facilitation; plus how to enable disability readiness of employers and how to engage strategic sectors by partnering with different organizations for a holistic access to work model. Mr. Nemeño also disclosed that 90% of PWDs perform at par or even better with their co-workers as per the Global Disability Inclusion, proof that hiring PWDs is really a win-win situation in the society.

In closing, Provincial Social Welfare and Development Officer Fely Servañez thanked everyone's cooperation and contribution to achieve an enabling workplace for PWDs in Cavite. With more than 42,000 PWDs in the province as of year 2018, the government must continue to encourage private companies to believe when PWD jobseekers say "I can do that." ---PICAD





#### GCTA law: persons rapped for heinous crimes cannot be free

LIFE'S INSPIRATIONS: "...Your rulers are rebels, partners with thieves; they all love bribes and chase after gifts..." (Isaiah 1:23, the Holy Bible).

GCTA LAW, RA 10592: PEOPLE CHARGED WITH HEINOUS CRIMES CANNOT BE SET FREE BECAUSE OF GOOD CONDUCT: So everyone will know, I am coming out this day, here at Kakampi Mo Ang Batas, with one very important part of Republic Act 10592, or the so-called "good conduct time allowance" law.

Republic Act 10592 is the law that allows reducing the time during which a convicted felon should stay in jail, on account of that felon's good conduct or exemplary behavior while in prison.

Here is what Section 1, Republic Act 10592, says: "Provided, finally, That recidivists, habitual delinquents, escapees and persons charged with heinous crimes are excluded from the coverage of this Act..."

SARMENTA-GOMEZ RAPE-MURDER CAS-ES, HEINOUS CRIMES: Now, based on Section 1 of Republic Act 10592, or the "good conduct time allowance" (GCTA) law, does former Calauan, Laguna Mayor Antonio Sanchez have any right or entitlement to be given a reduced prison term so that he could already be released from Muntinlupa City at present? To enable us to answer this question, we should know: what were the criminal cases that sent Sanchez to Bilibid?

According to official documents, the cases that were responsible for jailing Sanchez were the rape-murder cases involving Eileen Sarmenta, and the related murder case of Alan Gomez, in the early 1990s. What kind of cases are rape and murder charges, like the cases with which Sanchez was charged in court? Clearly, they are classified as heinous crimes since they are penalized with life sen-

Under existing regulations in the Philippines, any crime which is penalized by life imprisonment would be considered as a heinous crime. Now, if the crimes with which Sanchez was charged, tried, and ultimately convicted are considered heinous crimes (not just one, but three separate heinous crimes), there should be no question at all that he could not be released based on GCTA.

WHY DID FAELDON ALLOW SANCHEZ TO GO SCOT-FREE? The really difficult question here pertains to the head of the Bureau of Corrections National Penitentiary in Muntinlupa City. Why did this head, Director Nicanor Faeldon, signed the release order of former Calauan, Laguna Mayor Antonio Sanchez, when the former town executive was clearly not qualified to be so released?


No doubt, Faeldon knew, or ought to have known, what Republic Act 10592, or the "good conduct time allowance" (GCTA) law contains. Faeldon also knew, or ought to have known, on account of his own personal acumen and intellect honed by his stay at the military establishment, that Sanchez could not have been eligible to receive the benefits of that law.

So, all points indicate that Faeldon had a very grave and compelling reason that prompted him to sign the documents allowing Sanchez to go scott-free. And this is what the Senate, under Sen. Richard Gordon of the Blue Ribbon Committee, should endeavor to discover or unearth. Faeldon is no oxymoron. And he is not someone who could easily be cowed by anyone into releasing Sanzhez. Let's wait and see if Gordon can have the wit and the mental agility to find out what lies behind all these!

## HAKABitenya! A BREASTFEEDING AWARENESS CELEBRATION IN CAVITE

Hundreds of nursing mothers in the province joined HAKABitenya! Year 2, a simultaneous latch-on activity in celebration of the breastfeeding awareness month, held on August 30, 2019 at the Ceremonial Hall of the Provincial Capitol in Trece Martires City.

Provincial Nutrition Program Coordinator Ms. Helen Peñalba welcomed guests and participants to the event, thanking the presence of the mothers and their children to partake in the provincial health's program on scaling up local health and nutrition and intensifying strategies for maternal, neonatal and child health. Meanwhile, on behalf of Chairman of the Committee on Health, Nutrition and Population Board Member Kerby Salazar, Mr. Kyle Salazar delivered his opening remarks, telling stories how breast milk from his mom and sometimes from aunts turned him into a smart and healthy young man.

Bacoor City Mayor Lani Mercado-Revilla who served as guest speaker to the event shared her experience as a breastfeeding mom, reminding that formula milk from the cow is for calf only while the milk of mothers should be given to the baby. The mother of Vice Governor Jolo Revilla shared that she breasts fed all her seven children, and that in Bacoor City, there are organizations of moms who even donate breastmilk. Likewise, Mayor Lani also underscored the importance of providing proper nutrition to the baby's first 1000 days to avoid stunted growth.

More inspiring talks that promote breastfeeding and proper nutrition to babies covered the one-day event. The



breastfeeding peer counselor, South PiNanays Founder and President Marie Paz Regina Atienza, tackled some do's and don'ts for mothers when they breastfeed. Ms. Atienza even gave away lactation cookies to every mom who participated during the activity to add fun while learning.

In addition to further enlighten mothers, Nutritionist Dietitian Joan Marie Pedron tackled the salient features of RA 11148 known as the "Kalusugan at Nutrisyon ng Mag-Nanay Act of 2018. The provisions encompass social welfare support and counseling for parents on dietary supplementation, lactation management, psychosocial stimulation, plus capacity-building of barangay health and nutrition volunteers for

implementation of related health services needed by mothers and their baby. Successful breastfeeding stories also gave moms the confidence and proper learnings on nurturing their babies. Ms. Ludette Lontoc, Development Management Officer IV from the Provincial Health Team Office (PHTO) expressed the closing remarks on behalf of Dr. Armida Camposagrado, DMO 4, PHTO, telling mothers to spread the good news on Hakab. PhilHealth Act. One of the important developments was the introduction of system-based claim of benefits where the claimants are no longer required to present their PhilHealth ID or Member Data Record (MDR) for this purpose. Meanwhile, Ms. Ramento introduced different types of PhilHealth membership such as Formal Economy member, Informal Economy member, Senior Citizen Program member, OFW members and Lifetime members. To qualify for a Lifetime membership, the particular member should be more than 60 years of age at the time of application, no longer an income earner and has paid 10 years' worth of PhilHealth contributions. An open forum followed after the discussions and different questions and queries of the elderlies were answered and clarified. A closing remark from Ms. Edelyn V. Rodil, Social Insurance Officer II concluded the event. --(PICAD)
