Mega quarantine facility for COVID patients completed in Cavite



The Department of Public Works and Highways (DPWH) has completed a 151-bed mega quarantine facility for COVID-19 patients in Carmona, Cavite.

Located in Barangay Lantic, DPWH Secretary Mark A. Villar said that the mega isolation facility will "facilitate treatment and care of COVID-19 patients from Carmona and other parts of the industrial zone of Region 4-A (Cavite, Laguna, Batangas, Rizal, and Quezon area)." The project was supervised by the DPWH Task Force to Facilitate Augmentation of National and Local Health Facilities which was created to address the needed health system facilities to decongest hospitals as part of the government's efforts in battling the pandemic.

the local government's programs and to ensure the safety and security of the people of Imus," Mayor Maliksi said. Despite the ongoing pandemic, the Imus PNP had conducted 128 operations that resulted to 335 arrests.

Aside from their peace keeping program Oplan Sita, the Imus City Police force had provided other services especially during this health emergency crisis like the distribution and provision of relief packs to 206 beneficiaries thru their "Kapwa Ko, Sagot Ko" program.

Likewise, the Imus PNP had provided free transportation with the "Hatid Tulong" program in which 13 residents availed of the program while 55 commuters took advantage of the "Libreng Sakay." The PNP personnel had kept the city safe during the community quarantine by manning the check-points located in strategic areas in the city and roaming the city streets to monitor the movements of the residents to contain the spread of the COVID-19 disease, and also tasked to validate the applications for the issuance of Travel Authorities for the Lo-

cally Stranded Individuals. The above-mentioned programs and initiatives were just some of the services the Imus City PNP had undertaken in support for the local government's massive campaign to keep the city safe to live in.

Imus PNP is headed by PLtCol. Gerald S. Dee with a full staff of 150 personnel composed of seven

Undersecretary Emil K. Sa- 14 signing of memorandum dain, head of Task Force to Facilitate Augmentation of National and Local Health Facilities, turned over the facility to Carmona Mayor Roy M. Loyola.

staging area and built bored piles - the deep foundational support, along the stretch up to Dr. Santos Station until Ninoy Aquino Avenue.

The company is starting to construct piers - elevated structures, along Ninoy Aquino Avenue as well.

Jetty construction works along Paranaque river are almost halfway done, with bored piling works expected to begin soon in the same area. The project also

achieved another milestone with the installation of the first 2 pi-girders (chief horizontal support in a structure) in front of the pre-cast yard along C5 Extension, Las Pinas City.

The Cavite Extension project makes use of an above-ground launcher, a special engineering method, to allow for faster execution and minimal effect on the ground-level traffic. The viaducts are transported aboveground instead of street-level. "LRMC has been in close partnership with Maynilad and CAVITEX Infrastructure Corporation for the necessary activities to prepare the foundation for LRT-1 Cavite Extension (CEMT)" noted Project Execution Manager Reynaldo Pangilinan.

"Despite the limitations brought by the quarantine period and the necessary adjustments, we have been able to make progress on this

project," he reiterated. "We also request for the continued understanding of all CAVITEX motorists, and advise them to plan their trips ahead," Pangilinam hastened to add.

"We are aware that this will bring temporary inconvenience.

But once the project is completed, travel between Baclaran and Bacoor will be faster, easier, and more convenient for our commuters."

Cavite COVID-19 vaccine trials to undergo FDA, ethics review first — DOH

The Department of Health on Wednesday said the planned COVID-19 vaccine trials in Cavite will have to undergo a review by the Food and Drug Administration and an ethics board before they could begin.



African Swine Fever (ASF) recorded in Carmona, Cavite

CARMONA, Cavite – The municipal government reported on Wednesday a case of African Swine Fever (ASF) in Barangay Lantic.



The local government unit (LGU) received a letter from the Department of Agriculture on Sept. 8 confirming the ASF case. Mayor Roy M. Loyola asked hog raisers and residents to coordinate with local officials if they suspect an ASF infection in their area. Consumers are also encouraged to buy pork only from legitimate sources and to make sure that the vendor has a National Meat Inspection Service accreditation certificate. The LGU is coordinating with the Provincial Veterinary Office to intensify measures to mitigate the spread of the viral disease that affects pigs. "Nung Sabado I read the does not ha

Cavite Governor Jonvic Remulla last week announced that his province would undertake a COVID-19 vaccine trial through the La Salle Health Sciences Institute. He said it would happen in the next two weeks. But the FDA earlier told ABS-CBN News that the Cavite trial does not have approval yet. All proposed COVID-19 vaccines would have to undergo FDA approval before being allowed to enter the Philippines. Vergeire said the proponent of the Cavite study agreed and promised to update them regularly.

"They are still negotiating and finalizing their protocol," the health official said.

She said once it is approved by the FDA and an ethics board, the proponent of the trial would inform the DOH so it could start. Vergeire said they have yet to receive details on the planned clinical trials.

Remulla said the vaccine trial would involve those developed in the United States and the United Kingdom. "Walang puwedeng magumpisa ng any clinical trial kung wala kayong approval ng FDA at wala kayong approval ng ethics review (You cannot start if you do not have the approval of the FDA and the approval of an ethics review). If you do that, you are violating specific laws so you will be sanctioned and you will be asked to stop," Vergeire emphasized.

She explained that because these are new vaccines and medicines, they have to be regulated to ensure the safety of Filipinos. Otherwise, they "may cause harm to our citizens." There are still no approved vaccines or drugs against COVID-19. Vaccine frontrunners are still undergoing Phase III clinical trials, which involve largescale testing for the safety and efficacy of the vaccine. The Philippine government has been in talks with vaccine developers from China


and Russia but none have been finalized yet.

"Ang sabi August sila maguumpisa for the phase 3 clinical trials sa Russia," Vergeire said of the Sputnik vaccine from Russia. "But ito ay through the emergency use approval ng gobyerno."

(They said phase 3 clinical trials should start in Russia in August. But this is through the emergency use approval of the government.)

Russia has said it would be using its vaccine on health workers first even if it has only finished Phase II trials.

The Philippine vaccine expert panel is still studying results of Russia's Phase I and Phase II trials to see if the vaccine is really safe and effective. Vergeire said they will update the public once the panel shares more information with them.
