Half of PNP force undergo drug test, says PNP exec

About half of the 230,000 police force in the country have been subjected to drug testing this year as the Philippine National Police (PNP) heightens its internal cleansing drive, a key official said.

Gracing the 122nd Police Service Anniversary of the Police Regional Office 8 (Eastern Visayas), PNP deputy chief for administration, Lt. Gen. Rhodel Sermonia, said drug testing is an endless program to ensure that no police officer uses illegal drugs.

They voluntarily submitted to the random drug testing as part of the efforts of the organization to ensure a drug-free PNP. "We want to undergo everyone for drug testing, but funding is a major concern. It's good that

some of our local police units have been getting support from local government units to carry out the drug test," Sermonia told reporters in a press conference.

He reported that test results revealed 25 personnel, or less than 0.02 percent, have tested positive for prohibited drugs.

This figure represents a significant decrease from the 2016 record of over 200 personnel testing positive for illegal drugs.

'This significant reduction is a testament to the PNP's commitment to rooting out any form of misconduct within its ranks and its dedication to maintaining the highest ethical standards," he added.

Of the 25 personnel, eight have been dismissed from the service, one resigned, and the rest are on summary hearing proceedings. Sermonia, the second highest PNP official, has been visiting regional offices to relay the internal cleansing campaign of the organi-

During his speech before stakeholders from the government and private sectors in the region, Sermonia

said they have been tightening their recruitment process to ensure that only honest and reliable individuals enter the service. "We have been implementing a nameless and faceless recruitment system to avoid the 'palakasan' (patronage) system. We don't consider requests from politicians and our friends during the recruitment process," he said. Sermonia also asked commanders to carry out the internal disciplinary mechanism and intensify efforts in reiterating the doctrine of command responsibility and police operational procedures to every police officer on the ground. chief of DTI-Calabrazon's consumer protection division, said they hired more personnel as the agency lacks manpower, with each province being monitored by only three employees.

"We have brought in contractual employees to help us in monitoring prices. But they still have to be trained. Our job is not only to monitor the price of rice but also other goods subject to the fair trade law," he said.

Cupit explained that enforcing EO 39 is a joint effort by the DTI, Department of Agriculture, Department of ernment and the local government units (LGUs) in the five-province region.

He said that during the last meeting of concerned agencies earlier this week, it was agreed that all LGUs in Calabarzon would reactivate their respective price coordinating councils to strengthen the government's ability to exact compliance with price controls. The DTI official confirmed observations that much of the rice currently being sold in wet markets, grocery stores and supermarkets are priced well above the

announced price ceilings.

This is often because imported rice, "fancy" rice and other varieties of rice classified as "premium" are not covered by EO 39, Cupit

He noted that rice retailing for PHP41 and PHP45 per kilo is often sold out because of the high demand.

Supply is also relatively limited so sellers are often left with only their more expensive premium rice stocks.

To ensure constant availability of cheaper rice, Cupit said concerned agencies in Calabarzon are keen

on proposing modifications to the implementing rules of EO 39.

"We might propose that every retailer be required to have at least one variety of rice that can be sold at PHP45 per kilo. The retailer will be given a free hand on the quality of that rice, as long as it is always available, and can be sold at no higher than PHP45 per kilo," he

Cupit said the rice harvest season has commenced and fresh stocks of affordable rice are expected to be delivered to retailers soon. (PNA)

"are intertwined." "The youth is the hope of the country. However, they are being recruited [New People's Army (NPA)], brought to use illegal drugs, criminality, violent extremism, and terrorism. We don't want the future of the country to be like that," she told local reporters.

DepEd, she said, has proof of recruitment to violent extremism and terrorism among the youth.

She said the use of confidential funds has a legal basis and that there is no proof of wrongdoing from the Office of the Vice President (OVP) and DepEd for its utilization.

"It was duly approved by the Congress, and it was dispersed and utilized according to law. As to the approval, we leave it up to the discretion of the Congress and Senate for we can only propose based on what we know based on our work," she said.

Addressing the critics of her office's use of confidential funds, the Vice President said she was waiting for Act Teachers Party-list Rep. France Castro to produce "documented proof" showing wrongdoing.

"They keep on attacking me, and I am just waiting for them to give me something concrete that I did something wrong. They keep on attacking in the hope that the

He said workers in Region 4-A will receive pay hikes of between PHP35 to PHP50 per day, depending on what part of the region they belong to.

Minimum wage earners in the non-agriculture sector of "extended metropolitan areas," such as Antipolo City and Cainta town, will be making the most money after PHP50 is added to their daily pay, bringing it up to PHP520 per day.

The lowest pay was also raised to PHP429 for agricultural sector workers in the most developed parts of the

Meanwhile, workers in the agriculture sector in Calaca and Carmona will receive an increase of PHP89 daily due to their reclassification from first-class municipalities to component cities.

This brings the minimum wage up to PHP479 for non-agricultural workers and PHP425 for agricultural

The wage order is expected to directly benefit 719,704 minimum wage earners in the region, the National Wages and Productivity Commission (NWPC) said in a statement.

"About 1.6 million fulltime wage and salary workers earning above the minimum wage may also indirectly benefit as a result of upward adjustments at the enterprise level arising from the correction of wage distortion," it said. Gacosta said the wage adjustment will officially take effect on Sept. 24, and not

He said DOLE monitoring teams will be interviewing employees from companies across the region to ensure compliance with the latest wage order.

"We conduct inspections daily because some companies still refuse to pay minimum wage. They are often exposed by disgruntled employees... they are all eventually caught and held accountable," he said in Filipino. (PNA)

PEZA: Approved projects in various ecozones hit PHP111 billion

Project approvals in various economic zones nationwide hit PHP111.2 billion as of Sept. 7, 2023, Philippine Economic Zone Authority (PEZA) Director General Tereso Panga reported Friday.

In a statement, Panga said the latest investment approvals figure are higher by 180.6 percent compared to the same period a year ago.

The PEZA Board approved 27 projects, amounting to PHP14 billion, during its meeting on Thursday (Sept. 7).

Data shared by PEZA showed that 11 of these projects are export enterprises that will be located in Batangas, Cavite, Laguna, Davao del Norte and Cebu.

The Board also approved five information technology enterprises projects to be located in Makati, Cebu, Laguna, and Pasay; five facilities enterprises in Batangas and Laguna; two ecozone projects in Occidental Mindoro and Cavite; two domestic enterprise projects in Batangas and Laguna; and two logistics enterprise projects in Batangas and Cavite.

"So, we are on track on not just realizing our target for the year, which is 10 percent increase in investments. These are all aligned with the targets of other key industries such as electronics, IBPAP (IT and Business Process Association of the Philippines), where we expect also the Philippines to achieve a 6 to 7 percent growth rate, which is one of the best performing economies in the region," Panga said.

Currently, PEZA is operating a total of 422 ecozones across the country, the biggest of which are in Metro Manila, Calabarzon, Central Visayas, Central Luzon and Western Visayas. These ecozones are host to 4,372 locator companies.

"PEZA plays an important role in realizing this objective



as we are the agency pioneering ecozone development in the country. Since its founding, PEZA has contributed PHP4.177 trillion to the national coffers. Ecozones have also played a crucial role in attracting foreign direct investments that generate the much-needed jobs, exports, local and national revenues, and other economic opportunities for the Philippines," Panga added.

House members vow to work harder amid high survey ratings

Members of the House of Representatives on Sunday promised to work harder and be worthy of the high rating they obtained based on a recent OCTA Research survey.

"To know that more than half of our countrymen trust us and approve of what we have been doing in this chamber galvanizes us to push forward. If they like what they see, then more of it they will see," Gonzales said.

Senate OKs bills to boost salt industry, learners' mental health

Senators unanimously approved on Monday Senate Bill gency situations, and other marginalized sectors. Nos. (SBN) 2243 or the Philippine Salt Industry Development Act, and 2200 or the Basic Education Mental Health and Well-Being Promotion Act.

SBN 2243 seeks to create a Council, with the Secretary of the Department of Health as a member, which will focus on the development of the salt industry.

Sponsored by Senator Cynthia Villar, the measure came from findings that the Philippines imports 90 percent of its salt requirements despite being an archipelago with one of the longest coastlines and wide access to saltwater.

During the previous deliberations, Villar recalled that in the 1950s, the Philippines' salt industry boomed as new fishponds and salt farms were built in the provinces of Pangasinan, Bulacan, Occidental Mindoro, Cavite, Parañaque City, Negros, Cebu and other provinces.

"Salt producing areas in the Philippines reached an estimated peak of 5,000 hectares nationally, producing an estimated 240,000 metric tons annually. This boom in growth supported a growing population and the development of the salt industry in the 1960s and 1970s," she said.

The measure is also one of the 20 priority measures of the Legislative-Executive Development Advisory Council to be passed before the year ends.

Meanwhile, Senator Win Gatchalian, who authored and sponsored SBN 2200, cited its passage as a significant step forward in addressing what he called a "pandemic of mental

This came after the significant increase in the number of deaths by suicide among basic education learners in recent

"Considering a looming mental health pandemic, it is crucial for the government to urgently intervene by improving and investing in mental health services across healthcare, protection, education, and welfare," Gatchalian said in a previous statement.

SBN 2200 seeks to institutionalize the School-Based Mental Health Program to promote and ensure the mental health and well-being of learners in public and private basic education institutions.

It also covers out-of-school children in special cases that include learners with disabilities or conditions, indigenous peoples, children in conflict with the law, learners in emer-

The Philippine Statistics Authority (PSA) was created by virtue of Republic Act (RA) No. 10625 otherwise known as the Philippine Statistical Act of 2013 dated 12 September 2013 and with mandates that are enhanced and expanded by the establishment of the Philippine Identification System pursuant to RA 11315 or the Community-Based Monitoring System

The CBMS is a data collection and analysis system that uses volunteers to collect data from households in rural and urban areas. The data collected through CBMS is used to track progress in various development indicators, such as poverty, education, and health.

The PSA is responsible in the implementation of Civil Registration System (CRS) for registering births, deaths, marriages, and other vital events. The CRS data is used to track population trends and to issue birth certificates, death certificates, and marriage certificates.


The PSA is also the implementing agency in-charge of the PhilID which is being issued as identification cards to all Filipinos. The PhilID card is used to verify identity and to access government services.

The PSA commemorative stamp features the agency's 10th anniversary logo and the imposing façade of the PSA main building to celebrate its achievements over the past de-



cade. It also emphasizes the agency's enhanced cooperation and partnerships with other government agencies and local government units.
