## DOH says Covid-19 spread slows down; PH still high risk

The increase in coronavirus infections appear to be slowing but the country's health systems capacity remains at high risk, a health official said Monday.

Speaking at an online media forum, Health Undersecretary Maria Rosario Vergeire said cases may still continue to increase in the next week due to the higher transmissibility of the Delta coronavirus variant and active case finding.

Citing the number of infections recorded from Sept. 13-19, Vergeire said the week recorded about 19,963 cases per day, a decrease of 5 percent from the previous week at 20,950. "Looking at our epi-

## Cavite LGUs urged to defy DENR's order

Fisher's group Pamalakaya is urging four local government units (LGUs) in the province of Cavite to stand with their constituents who are bound to lose

source of livelihood against the order of the Department of Environment and Natural Resources (DENR) to dismantle illegal fishing structures in their coastal areas.

In a statement released on Monday, Sept. 20, Pamalakaya urged the LGUs of Cavite City, Bacoor City, Noveleta, and Kawit "to stand alongside their coast-

al constituents on their fight against the unjust order" of the DENR to demolish mussel and oyster farms in the Manila Bay.

According to the group, the order will only displace at least 15,000 residents whose livelihood depends on mussel and oyster farming in the area. The group also doubted the mandate by saying that DENR's order is only a "prelude to massive reclamation projects that are meant to wipe out not only the fishing structures but also the fishing villages along Manila Bay."

PAMALAKAYA asserted that local government units can cite the Section 16 of the Local Government Code of 1991 to go against the agency. The provision

# Senators support increasing OVP budget for 2022

SENATORS on Tuesday, September 21, 2021, expressed support to providing the Office of the Vice President (OVP) a bigger budget for 2022.

Under the National Expenditure Program submitted by the Department of Budget and Management (DBM) to the Congress in August, P713.41 million was allocated to the OVP.

It was 21.5 percent lower than the office's 2021 budget of P908.79 million and below the P714.56 million proposed by OVP.

"The National Expenditure Program (NEP) submitted by DBM for 2021 was approximately P700 million and the Senate increased it to P900 million or so.

I don't think it's an exaggeration to say that we will probably do the same because we have seen you made wise use of your budget and you had a kind of multiplier effect by partnering with so many organizations," Senator Sonny Angara, chair of the Senate committee on finance, said during a budget hearing.

He noted that the proposal of several congressmen at the House of Representatives of increasing the OVP's budget to at least a billion was not an "unreasonable goal" considering how it handled its budget and its initiatives to help the government address the coronavirus

disease 2019 (Covid-19) pandemic. "We will refer the budget of the Office of the Vice President favorably to the plenary with increases still to be determined at this point," Angara added.

Senate Majority Leader Juan Miguel Zubiri and Senators Franklin Drilon and Francis Pangilinan all agreed to Angara's statement.

During the hearing, Vice President Leni Robredo said P5.995 million of their budget for 2020 were used for the procurement of over 600,000 personal protective equipment (PPE) sets that were distributed to medical frontliners.

She said they pursued a more sustainable alternative by partnering with local designers and medical experts in locally producing PPEs, which doubled as income generation for 23 sewing communities from Metro Manila, Cavite, Laguna, Cebu, Lanao del Sur, and Nueva

Ecija. She said they also partnered with several non-government organizations for the conduct of donation drive from March 13 to April 30, 2020, where they were able to raise P55 million allocated for various Covid-related efforts, including the provision of free shuttle to frontliners when public transportation was suspended after the declaration of lockdown in March 2020.

The OVP also established free dormitories with necessary amenities such as WiFi access for frontliners and essential staff amid the pandemic.

"The OVP also set up Community Kitchens to address hunger in the poorest communities affected by the pandemic.

The initiative continues this year but has shifted to donations received from various donors," said Robredo, adding they also conducted free Covid-19 testing. (Sun-Star Philippines)

stated that LGUs are mandated to promote the general welfare of their constituents and ensure support, among other things, the preservation and enrichment of culture and enhance the right of the people to a balanced ecology within their respective territorial jurisdiction.

"The local executives in Cavite are morally, politically, and constitutionally obliged to protect the welfare of tens of thousands of fisherfolk who are deemed to lose their source of livelihood courtesy of the national government's directive against fishing structures in Manila Bay,"

AKAYA national chairperson, said in a statement. "We will continue to oppose this undertaking in various legal institutions such as the Supreme Court and the Philippine Congress, and through mass actions in the parliament of the streets and in the court of public opinion," he added. The schedule of the fishing structures dismantling in Manila Bay has been postponed from September 7 to September 25. Despite this, PAMALAKAYA said it will continue to monitor and protest the demolition order.

In a press briefing on Sept. 8, DENR Usec. Benny Antiporda said small-scale

fisherfolk would benefit from the dismantling of illegal structures in the Manila Bay

as they would no longer have to travel far to avoid the said structures just to fish.

Cavite Gov. Juanito Victor "Jonvic" Remulla Jr. has expressed his interest to run for a second term. Tagaytay City Councilor Althea Tolentino, daughter of Cavite Eighth District Rep. Abraham "Bambol" Tolentino and Tagaytay City Mayor Agnes Tolentino, has been eyed as Remulla's running mate under the Magdalo Party.

In the first district of Cavite, former Kawit Vice Mayor Paul Abaya has openly declared his wish to replace his brother, Rep. Boy Blue Abaya in Congress.

Boy Blue is in his third and last term as representative.

The Abaya family held congressional posts for three decades now starting from their father, former Rep. Plaridel Abaya.

Jun Abaya, elder brother of Boy Blue, will run against First District Board member Davey Chua.

The Chua political clan also has an extensive influence in the area. His brothers Dino and Denver are Mayor of Noveleta and Vice Mayor of Cavite City, respectively.

In the second district, deputy speaker Rep. Strike Revilla will run as Mayor of Bacoor while his sister-in-law, Bacoor Mayor Lani Mercado, will run for Congress.

Sen. Ramon "Bong" Revilla Jr.'s eldest son, Bryan Revilla, will run for vice mayor against incumbent Vice Mayor Karen Evaristo.

Jolo Revilla, another son

of Bong and Lani, is the first nominee of the Agimat partylist.

In the third district, Rep. Alex 'AA' Advincula of the lone district of Imus City will run for a mayoral post with his long-term political partner former Imus Mayor Homer 'Saki' Saquilayan as his running mate.

Advincula's eldest son, Imus City Councilor AJ Advincula, will run for representative against Imus Mayor Emmanuel Maliksi, son of former Cavite Gov. Erineo "Ayong" Maliksi.

Joining Maliksi's Liberal Party are Vice Mayor Arnel "Ony" Cantimbuhan who will run for mayor and wife Jelyn Maliksi who will run for vice mayor.

In the fourth district, Rep. Elpidio Barzaga, wife Dasmariñas City Mayor Jenny Barzaga and Vice Mayor Rex Mangubat will run under the National Unity Party. As of today, no one has declared to run against them.

In the fifth district, the Loyola couple are rumored to be swapping positions as mayor and representative, respectively. Dr. Dahlia Loyola is expected to run for Mayor of Carmona while Mayor Roy Loyola will seek a seat as representative for the towns of Carmona, Silang and Gen. Mariano Alvarez (GMA).

Maricel Echeverria Torres, a former vice mayor who was recently promoted to mayor after his father Walter Echevarria resigned due to

health reasons, said she will run for mayor in 2022. She will be challenged by incumbent Vice Mayor Angela Leni Paycana.

In Silang, former mayor Omil Poblete will be running for mayor with running mate Fifth District Board Member Ivey Reyes. They will go up against Fifth District Board Member Kevin Anarna and vice mayoral bet retired police Col. Edward Carranza.

In the sixth district, three-term Mayor Antonio Ferrer is expected to exchange positions with General Trias Rep. Luis Ferrer 4th. Councilor Jonas Glyn Labuguen will run alongside Ferrer as vice mayor.

In the seventh district, as of today, no one has expressed interest in fighting congressman Boying Remulla, who is seeking a second term as representative.

Amadeo Mayor Redel Dionisio will run for reelection opposite Vice Mayor Rading Viado.

Perfecto Fidel will run for his last and final term as mayor of Indang.

Trece Martires Mayor Gemma Lubigan and Vice Mayor Bobby Montehermoso are expected to run for reelection.

In the eighth district, Tagaytay City Mayor Agnes Tolentino and Philippine Olympic Committee president Rep. Bambol Tolentino, brother of Senator Francis Tolentino, will exchange political positions.

Ambion brothers, Vice Mayor Raymund and Eighth District Board Member Reynier, are running for their final term in office.

Alfonso Mayor Randy Salamat, who is running for reelection, will be challenged by former Mayor Ver Varias.

Bailen Mayor Nelia Angeles and Magallanes Mayor Jasmin Maligya-Bautista also expressed interest to run for another term.

Naic Mayor Junio Dulan endorsed elder brother Councilor Ralph Dualan as his mayoral bet. He will go up against Vice Mayor Roger Pangilinan.

There will be a three-cornered fight in Maragondon town as Dr. Aldous Angeles, Councilor Lawrence 'Umbe' Arca and Noel Rillo will all be running for mayor. Rillo is the younger brother of incumbent Mayor Rey Rillo, who completed his three terms as local chief executive.

Ternate Mayor Lambert Bambao is running for a second term and will be challenged by former mayor Herminio Lindo.

Kawit Mayor Angelo Aguinaldo will be challenged by his cousin Boy Blue.

Dino Chua of Noveleta will be challenged by former mayor Enrico "Boy" Alvarez and Cavite City Vice Mayor Denver Chua will run against Apple Paredes for mayor.

Voltaire Ricafrente will challenge Vice Mayor Mao Luna for the top executive post in the town of Rosario.

icity or water-absorptivity which allows for easy reconstitution are among the advantages of this technology," de la Peña remarked.

According to him, the resource person talked about

how the vacuum freeze-drying process preserves the nutrient content of fruits or vegetables, compared to other drying methods, such as air-drying or sun-drying.

"The speaker, Dr. Adeli-

sa Dorado, an associate professor at the University of the Philippines - Los Baños, also identified long duration of processing time and high operating cost as the disadvantages of this technology," he added. Meanwhile, de la Peña said the Cavite Provincial Agriculturist Office expressed interest in adopting the technology for its assist-

ed farmers' association. The DOST-Calabarzon acquired a vacuum freeze-drying equipment, currently housed in the Calabarzon Food Solutions Hub in Laguna, for use of the Association of Laguna Food Processors and other food enterprises in the region in developing and commercializing food products, he said. (PNA)

demic curve, we see a new peak every week since the start of August. The average of cases in the recent week is twice as much as the average of cases we saw during the peak in April," Vergeire said.

The top five regions with the most number of new cases are the National Capital Region (NCR), Region 4-A (Calabarzon), Region 3, Region 11 and Region 1.

Meantime, the top five areas with the most number of new cases are Quezon City, the provinces of Cavite, Laguna, Bulacan and Rizal.

"The NCR Plus areas showed a steep increase in cases in the end of July. In the recent week, slight downward trend is seen and the rest of Luzon continue to show an increase while Visayas and Mindanao show a plateau in the increase of number of cases," Vergeire said.

The nation's two-week growth rate is a positive 18 percent and an average daily attack rate of 18.56 cases for every 100,000 population.

In the NCR, the seven-day moving average shows a slight decrease as cases in the recent seven days decreased by 780 cases compared to the prior week.

"The whole of the NCR is at Alert Level 4 now. Our case data shows that cases in NCR continued to increase but at a slower rate and this is evidenced by a positive growth rate in the past month and as of Sept. 19, our two-week growth rate is at 17 percent, lower but still

positive compared to that of two weeks ago at 32 percent," Vergeire said.

Previous case projections estimated the peak of the daily cases in the NCR to occur towards the end of September or early October.

The delayed peak in cases may be due to the slowdown in increase in cases brought by the community quarantine restrictions, improvement of the PDITR strategy and vaccination, Vergeire said.

"These estimates may differ from the previously we noted probably because of the compliance to public health standards, lower mobility and vaccine coverage is higher than what was assumed and included in our projections," she said.

Since the last week of July, Covid-19 deaths have been increasing, with the new peak recorded in mid-August.

The current numbers of deaths are expected to increase specifically in Regions 3, 4-A (Calabarzon) and 7.

"The average deaths per day for August 2021 is at 155 and this has exceeded the deaths in April 2021," Vergeire said.

As of Sept. 19, the nation's total number of cases since the start of the pandemic has climbed to 2,366,749.

The health department also tallied 19,271 new confirmed cases, bringing the total number of active cases to 178,196 or 7.5 percent of all cases. (PNA)

has been moved to Oct. 20. "In response to a last minute request and as a matter of equity and liberality, the joint venture proposal submission date for SPIA is reset and hereby extended by 30 days from Sept. 20, 2021," the SPIA project's PPP-selection committee said.

The province of Cavite is seeking to develop the SPIA as a modern, sustainable, and world-class international hub airport development and main gateway without any sovereign debt or guarantee.

The winning joint venture partner will be responsible for co-developing the airport project, together with the province of Cavite, as well as provide the necessary equity investment, debt financing and credit enhancements.

Four companies bought the bid documents for the SPIA project as of its deadline last June 28. These were infrastructure conglomerate Metro Pacific Investments Corp. (MPIC), state-owned China Communications Construction Co. Ltd. (CCCC), Philippine Airport Ground Support Solutions Inc. (PAGSS), and Mosveldt Law Office.

CCCC and partner MacroAsia won the first bidding for the SPIA project in 2019, submitting the sole bid. However, the airport deal awarded to the tandem was terminated last January due to the various deficiencies of the submission of requirements to conclude the joint venture agreement, prompting the provincial government of Cavite to start anew with its search for a partner.

# Suspects selling allegedly overpriced tocilizumab nabbed in Cavite

Suspects selling allegedly overpriced tocilizumab nabbed in Cavite Operatives of the Criminal Investigation and Detection Group (CIDG) on Thursday arrested two individuals in an entrapment operation in Cavite after allegedly selling overpriced arthritis drug tocilizumab, which is used to treat COVID-19 patients. According to Emil Sumangil's report on "24 Oras," authorities arrested Terence Jabatan and his accomplice, Romanito Bigkas, in Bacoor, Cavite.

The CIDG retrieved one bottle of tocilizumab from the suspects. "Yung mga nangangailangan po sa pharmacy or sa ospital. Hindi po kaliwaan. Hindi din po tay sigurado kung talagang authentic 'yung binibili nating gamot," deputy provincial officer Police Major Daniel Yema said.

[For those who need the drug, purchase it from the pharmacy or hospital. You're not sure if what you're buying is really authentic.] The CIDG said that the drug was being sold for P80,000 per bottle, almost triple the price indicated in the market. "Ito pong tocilizumab ay merong wholesale price na P20,000 tapos meron siyang maximum retail price na P28,000. Online po, ginagamit po nila social media sa pag bebenta," Yema said. Jabatan, meanwhile, said he only sought to help others who needed the drug. "Binili ko po siya ng P79,000, pinasa ko lang ng P79,000 po. Walang tutok, walang bayad na kahit anong interes kasi kahit ngayon may marinig kayo na mamatay ang tatay ko, in good heart, tutulong at tutulong ka," Jabatan said. In a separate operation, the

CIDG also arrested live-in-partners Arnold Menor and Janmarie Mangosing. Authorities retrieved one bottle of tocilizumab that was being sold at P80,000. The suspect said they did not know that the selling of tocilizumab was prohibited.—Joahna Lei Casilao/LDE, GMA News
