3M Sinovac doses arrive in PH, vaccine supply hits over 51M

The Philippines continues to receive a steady supply of Sinovac vaccines with the arrival of another 3 million doses of the China-made jabs on Tuesday afternoon, August 31.

In an interview, NTF Against COVID-19 Chief Implementer and vaccine czar Carlito G. Galvez, Jr. said these vaccines will be deployed mostly to Region 4-A, Region 3, and other regions that are experiencing surges in infections such as Region 6, 7 and 8.

Galvez gave the assurance that the bulk of the vaccines arriving this September will be allocated to the provinces and regions, particularly those with high cases.

On the other hand, the vaccines to be deployed in the National Capital Region (NCR) will be for second doses. "Karamihan dito na pupuntahan ng

The construction of Imus Retarding Basin has a detention pond area of about 35 hectares while Bacoor Retarding Basin has two (2) temporary storage pond or basin connected by sluiceway

"I strongly advise residents to stick to the facts, review and understand information based on scientific evidence on the safety and efficacy of Covid vaccines and not to rely on unverified online information or groups of individuals who will try to manipulate you and provide you misleading reports and false claims about the vaccines," Regional Director Eduardo C. Janairo stated.

A certain group of individuals, identified members of the "Gising Maharlika," a so-called local independent news and media

alternative source, reportedly distributed pamphlets to residents in Liliw, Laguna on August 23, 2021, informing them that masks and swab tests do not work, and that no person could die of COVID-19.

"For those who have received such information or has read in their social media platform about this online anti-Covid vaccine movement, I advise you not to share and influence other people so as not to amplify these rumors which are not based on scientific evidence," Janairo strongly urged.

About 99.77% vaccine recipients have not reported any severe adverse reaction and only 23% have experienced mild symptoms which

resolved naturally." The government has already admin-27,806,881 vaccine istered doses in the country, as of August 26, 2021. In CALA-BARZON, 1,681,899 individuals were already fully vaccinated. A total of 2,582,878 has received their first dose.

Imus City Agri Office keeps farming, agriculture thriving

TRECE MARTIRES CITY, Cavite (PIA) – The agriculture sector in the city of Imus continuously develops despite the CoViD-19 pandemic thru its City Agriculture Office (CAO).

The department aims to bring the programs and projects to the local farmers, to support the food sufficiency level of the city, and ensure to resolve the objective of sustainable food production.

City Agriculturist Robert R. Marges said the city still has about 567 hectares of rice fields and about 80-100 hectares of vegetable farms after progress and development resulted to the conversion of many rice fields to industrial zones, commercial complexes, and subdivisions.

These rice fields and vegetable farms are located in Barangays Malagasang 1 & 2, Alapan 2B, Pasong Buaya, Anabu 1B, Medicion, Tanzang Luma, and Carsadang Bago.

CAO services include the responsibility to distribute certified quality seedlings, and organic fertilizers



to ensure the high quality rice production of 284 local farmers under the Rice Competitiveness Enhancement Program (RCEP) of the Department of Agriculture (DA)

The office provides crop insurance to farmers to compensate their crops damaged during calamities and or destroyed by pests to assure capital infusion and help them start anew with their livelihood.

Moreover, the agriculture office also provides technical assistance to teach methods and techniques, as well as distribution of free vegetable seeds to farmers and residents who wish to

start their own backyard garden.

Notably, the LGU's program for the promotion of organic agriculture not only aims to protect the environment thru deviation from the use of chemicals/synthetic fertilizer that poisons the soil, but will also ensure that the food they eat are safe.

Demonstration farms under the said program provide technical trainings and seminars, including technology packages to would-be farmers and garden hobbyists.

The recent development of communal gardens in barangays and subdivisions that promote urban gardening aims to sustain food security for the community in the midst of the ongoing pandemic.

The Farmers' Information and Technology Services Center (FITS Center), a program of the CAO not only serve as research center for farmers but also to students and other farming enthusiasts with agriculture experts to educate and guide them through their journey as farmers.

Not only does the CAO provide programs to train farmers, there are other field work activities that conduct personal farm visitation, and inspection of the local farm-

ers in their fields to guide them, and to examine the crops for signs of crop disease or insect problems and address the problem immediately.

Farmers' meetings are regularly held for consultation with CAO and discussion of local farmers' concerns.

CAO's services not only are limited to farming inputs but also include assistance with marketing thru conduct of regular price monitoring in local markets that help regulate the prices of farm produce, as well as give concrete information about the variety of crops and other agriculture commodities.

And with the recent launching of the AgrIM-UStahan, the social media platform for the CAO, information regarding the various services, programs and projects, and other agriculture concerns can be easily accessed.

This latest shipment brings to 51,885,590 the total COVID-19 vaccine doses delivered to the country.

As of August 31, the Philippines has administered 33,306,355 doses, of which 19,469,998 Filipinos have received the first dose, while 13,836,357 individuals are now fully vaccinated. (National Task Force Against COVID-19)

SMC SLEX registers profit << P1

in the first half of the year rose 35 percent to P2.67 billion from last year's P1.98 billion, reflecting the improvement in traffic volume this year compared to the previous year.

SMC SLEX said the increase mainly showed the impact of the shorter length of the ECQ restrictions of only for 15 days in the first half of 2021 compared to 76 days in the same period in 2020. "SLEX traffic volume

in the first half of 2021 has been showing gradual recovery since the start of the year, and has already started to catch up to pre-COVID-19 levels," the company said.

"This was mainly driven by the expansion of industrial areas in Southern Luzon which is part of the government's continuous support in the decentralization drive to stimulate business activities outside the National Capital Region," it added. SMC SLEX earlier said it allotted P5.44 billion in capital budget this year, with P4.6 billion earmarked for the Toll Road 4 or (TR4) Project.

The TR4 includes a fourlane toll road from Sto. Tomas in Batangas to Lucena Quezon and the SLEX widening project.

The P26.1-billion toll road will shorten the travel time from Sto. Tomas, Batangas to Barangay Mayao in Lucena City from the usual three hours to just 45 minutes.

The project is expected to be completed in 2024.

TR4 is a part of SLTC's

30-year concession that will last until 2036.

The capital expenditure will also finance the toll-way facility improvement, replacement of various toll equipment and preventive maintenance for toll collection system/network enhancement project.

for a total area of 9 hectares to contain floodwaters during a storm event and reduce the peak volume of flood flow at Imus River and Bacoor River, added Underscretary Sadain.

Retarding basins are being constructed to temporarily store most, if not all, of the rainwater run-off during very high rainfall, to absorb and contain flooding in periods of high rain and later release at regulated flow rate.

Ang checked on Friday, August 27, 2021 the progress of work for the putting up of pre-cast concrete blocks revetment wall at surrounding dike, overflow dike, drainage sluice, maintenance road, slope protection, and other project components.


To date, the P2.2 Billion project has a physical accomplishment of about 85 percent, and is slated to be completed by this fourth quarter of 2021.

New Dasma CoVax process implemented

TRECE CITY, Cavite PIA - The city government of Dasmariñas recently implemented the new CoViD-19 vaccination (CoVax) process to ensure the validity and orderly process of setting up vaccination schedules.

According to Joanne Mata, Executive Assistant V, Office of the Mayor, reconstruction of the procedures was due to the confusion that resulted from text messages for confirmation of vaccination schedules using different legit numbers from the Office of the Mayor.

There were also reports of vaccinees who were not city residents, nor working

MARTIRES or studying in the city.

The new CoVax process requires the registration and follow-up will be done directly with the barangay, thru the barangay secretaries who will be responsible for the submission of the lists to the Office of the Mayor.

The Office of the Mayor in collaboration with the City Tourism Office will then arrange the schedules in the city vaccination sites of those in the registration lists, and check for double entries as well.

The arranged schedule will be forwarded to the Dasmariñas City Information Technology Office for text blasting to concerned resi-

dents. Meanwhile, those who had previously registered online just need to print the form from the dasmacito website which will be submitted to the Barangay to be included in the lists.

Non-residents who are employed and working in the city, as well as students of universities and colleges in the city may register at the Office of the Mayor.

City Tourism Officer Red Alano said that risks will always be present in any situation in the midst of the CoViD-19 pandemic in answer to the criticisms regarding the new process being not safe to the residents.

"We don't really know



when and where it is safe," Alano said.

He clarified that senior citizens who are vulnerable will always be prioritized,

and will be given consideration once in the vaccination site even without prior schedule.

The city's vaccination

program continuously conduct vaccination of the members of the A1 - A4 priority groups and will soon start with the A5 category.

Duterte orders health experts to study benefits of localized lockdowns

The Philippines is experiencing a surge in new COVID-19 cases, which is said to be brought upon by the more contagious Delta variant. As of August 31, the number of active cases in the country is 145,562. From the said number, the National Captial Region logs 40,534 active cases as of this writing.

The country has also recorded the highest oneday tally of new COVID-19 cases last August 30, which was 22,366. The rise in new coronavirus cases prompted President Rodrigo Duterte to recalibrate the government's response in regards to COVID-19. This was shared by Duterte during his Talk to the People address.

One of the recalibrations that Duterte is looking to consider is the plan to impose localized lockdowns nationwide instead of implementing a city-wide or province-wide community quarantine. Duterte has ordered the National Task Force Against COVID-19 to look into the benefits of implementing localized lockdowns, and evaluate if it would work better in containing the virus.

"Whether the rise in the number of cases is due to the Delta variant or not, we need to recalibrate our response. We are also evaluating whether granular or localized lockdown would work best in our current situation," Duterte said.

But the Inter-Agency Task Force for the Management of Emerging Infectious Diseases (IATF-EID) already asked local government units

(LGUs) to implement localized lockdowns even before Duterte's announcement during his Talk to the People address.

Resolution 135-A that was released last August 28, 2021, states that LGUs must implement localized lockdowns in areas with community transmission. The said resolution also orders LGUs to have the necessary quarantine facilities in place for "priority" or "critical" areas.

In addition, the Department of the Interior and Local Government (DILG) announced last June 26, 2020 that 112 areas all over the country have been placed by their respective LGUs under localized or granular lockdown. DILG Secretary Eduardo Año even said last year that localized lockdown is the best approach in containing COVID-19.

"Localized lockdown is like hitting COVID-19 at its source which has been proven to be effective especially in the 112 areas where it is currently being imple-

mented. It really works since the hot zones areas are secluded from the rest of the community, hence, stopping the transmission to other communities," Año said in a statement last year.

As such, implementing localized lockdowns is not new and has already been imposed since last year. DILG Secretary Año himself cited that localized lockdowns were effective when it was implemented last year. With that, looking into the benefits of localized lockdowns might be a little too late, and the government could instead explore other measures that would contain the surge of
