PBBM satisfied with performance of DOH, DND OICs



President Ferdinand R. Marcos Jr. on Thursday said he is happy and satisfied with the performance of the temporary heads of different agencies, foremost of which are the Departments of Health and National Defense.

The President made the remarks when asked by reporters, on the sidelines of the Kadiwa ng Pasko caravan in Quezon City, for an update on the appointments of several offi-

cers-in-charge in different agencies. "Wala, we just go to the process. Wala pa kaming DOH. Wala pa kaming nino-nominate. Usec. (Ma. Rosario) Vergeire is doing a fine job. Kasi we are still not out of the pandemic. So we have to continue to be careful," the President said.

"Sa DA (Department of Agriculture), sa DND (Department of National Defense), no, I think... Happy ako with the situation as it is now. We'll see. These things are revisited, especially every year at the end of the first year. I don't think that's a secret to anyone that at the end of the first year, 'yung mga ibang kandidato, they will now join the mix of possible nominees," he added.

The current DND-OIC is Senior Undersecretary Jose Faustino, a former Armed Forces chief of staff and member of Philippine Military Academy's "Maringal Class" of 1988.

The President asked for the public's patience, noting his concern is doing the job at hand. So far, he said he is satisfied with the performances of the people he appointed.

In an interview in Los Baños, Laguna, early this week,

1LT CHRISTINE MAE N CALIMA PAF, also known by her callsign Chin 335, has proven that there is really nothing impossible for any woman to achieve. On the 27th of October this year, Cougar 335 has successfully become the first ever female of Philippine Air Force Flying School (PAFFS) to notch the TEST PILOT QUALIFICATION for SF260FH Marchetti after passing the said check ride on 12 October 2022.

To say, the task of a test pilot is to fly a particular aircraft after the maintenance crew conduct scheduled maintenance and correct the recent discrepancies if any. It is a flight undertaken to check the function of specific aircraft systems on the ground and airborne; determine and identify the performance of an aircraft before it is released for normal flight operations.

For an instructor pilot to be eligible for SF260FH Test Pilot Qualification Course, he or she first needs to be a first level flight examiner which requires more than 800 flying hours; a second level flight examiner which demands a flight time of more than 1500 hours; — all of which require extensive pilot skills, time, and competence. Additionally, a set of examinations focusing on emergency procedures and engineering aspects of the aircraft are given to the aspiring test pilots to test their knowledge on the aircraft systems. Simply put, Chin 335's road to becoming a test pilot was not a simple walk in the park, let alone that she is a female.

In a written message, Chin 335 expressed her gratitude to everyone who helped her reach the milestone of becoming a test pilot.

"My journey would not be complete without the support of my lovedones-family, relatives, and friends, who supported me along the way." Her family has been her support system ever since she started her grade school, and her parents' guidance helped her immensely to become what she is today. Her excellence in every endeavor she takes is mirrored in all her achievements. It can be remembered that Chin 335 also became the Class Salutatorian of Philippine Military Academy Gabay- Laya Class of 2016, not to mention all the other awards and recognition she obtained even before entering the PMA.

"I owe all the things I have learned and skills I have de-



veloped to my Instructor Pilots, and mentors. This success will not be possible without their untiring efforts, dedication, patience, unparalleled support, and undying commitment in teaching. I will not reach this far without them, and I truly appreciate their efforts in guiding me and inspiring me to be one of them."

She also thanks the men and women of PAF Flying School for staying committed to its mandate and accomplishing its mission, adding that she will also exert the same effort and commitment in sharing her knowledge and skills with the PAF Flying School Aviation Students.
