NLEX Corporation president and general manager J. Luigi Bautista said on Monday that from Dec. 23, 2022 to Jan. 3, 2023, they will beef up their operations along the North Luzon Expressway (NLEX) and Subic-Clark-Tarlac Expressway (SCTEX) as part of their "Safe Trip Mo, Sagot Ko" motorist assistance program. The Philippine Drug Enforcement Agency (PDEA) on Tuesday destroyed over PHP7.2 billion worth of various dangerous drugs, controlled precursors and essential chemicals (CPECs) at the Integrated Waste Management Inc. (IWMI) facility in Trece Martires City, Cavite.

Destroyed were a total of 1.4 million grams of dangerous drugs and a total net volume of 101.8

SSS contribution hike to beef up benefit payments for members

The Social Security System (SSS) on Monday said that the 2023 contribution increase would help fund higher benefit disbursements to its members.

SSS President and Chief Executive Officer Michael G. Regino explained that the four-stage contribution rate hike readies the SSS fund for the future needs of its members. Starting January 1, 2023, the new contribution rate will be pegged at 14 percent, up by one (1) percent-

Hungary commits to closer cooperation with PH

Hungary is prepared to take "necessary steps" toward stronger trade relations with the Philippines, an official from the Central European nation has assured.

Katalin Bihari, Deputy State Secretary of the Ministry of Foreign Economic Relations and Foreign Affairs of Hungary, made the commitment during the Philippines - Hungary Business Networking Event on December 1. Over 80 participants representing 36 Hungarian and Philippine firms in the environmental, labor market, and information and communications technology industries attended the event. H.E. Ambassador Titanilla Tóth from the Embassy of Hungary in Manila also joined the proceedings to support the Hungarian delegation.

Bihari described the gathering as prime opportunity for Hungarian firms to increase their presence in the Philippines, build new partnerships, and diversify

Secretary also recognized the Philippines' "prominent position" in Hungarian foreign economic policy, and emphasized the country's standing as an "important trade partner to Hungary among the Association of Southeast Asian Nation (ASEAN) countries."

Ambassador Tóth affirmed Bihari's statements, attesting to the Philippines' favourable business environment. This was also echoed by a Hungarian business leader, Adrian Kiss, CEO of the Hungarian Water Technology Corporation who said "I would like to encourage all Hungarian companies to be brave, come [and] do business in the Philippines,".

Kiss extended the invitation after presenting some of HWTC's completed collaborations with Philippine government agencies. Included in this showcase was a strategic cooperation with the Laguna Lake Development Authority, intended to support the rehabilitation of the lake basin. Kiss also highlighted a partnership with the Philippine National Disaster Risk Reduction and Management Council to develop water treatment technologies for use in natural disasters.

The Hungarian executive thanked the Philippine government for holding regular meetings via the Joint Commission on Economic Cooperation, which among other subjects, explores technologies in various sectors.

The HWTC is a provider of water treatment technology, and has completed projects in 35 countries in the past 30 years. In the Southeast Asian region, HWTC counts the Philippines as among its top partners, Kiss shared in his message.

In his welcome address, Trade Undersecretary and Philippine Board of Investments Managing Head Ceferino Rodolfo spotlighted the Philippines' strong economic performance.

He cited indicators such as the country's improving export numbers, as well as the record-breaking foreign direct investments into the Philippines in 2021. The Undersecretary also reported on the Philippines' game-changing economic reforms to ease investor entry, such as amendments to the Public Service Act, the Retail Trade Liberalization Act, the Foreign Investments Act; as well as the passage of the Corporate Recovery and Tax Incentives for Enterprises Act.

Rodolfo also presented an overview of trade and investment relations between Philippines and Hungary. "Philippine exports to Hungary increased by 40.26%from USD 110.06 million in 2020 to 154.37 million in 2021. We believe the new exports of machine parts and accessories, as well as the increase in outward shipment of products such as digital monolithic integrated circuits, contributed to this growth," shared the Undersecretary.

Philippine imports from Hungary expanded by 16.68%, a development attributed to the "sharp increase" of importation in parts of refrigerators and freezers, as well as in the inward shipment of materials for electronic machinery.

The Undersecretary then underlined the Philippines' efforts toward renewable energy development.

Undersecretary dolfo cited the Department of Energy's recent decision to allow 100% foreign ownership of renewable energy sources. In November, DOE Secretary Raphael Lotilla signed a circular amending the implementing rules and regulations of the Renewable Energy Act of 2008, and allowing 100% foreign capital in renewable energy projects.

Undersecretary Rodolfo also invited Hungarian to view the Philippines as a sustainable manufacturing hub. He underlined the wealth of green metals in the Philippines, such as nickel, copper, and cobalt which can be used for battery production. Recalling another key measure, the Undersecretary reported on the executive order cutting tariffs on imported electric vehicles. The executive order was approved by the National Economic and Development Authority, which is chaired by President Ferdinand Marcos Jr.

"The Philippine government is here to support and assist you in however way we can," assured Undersecretary Rodolfo.


Amor Maclang, Convenor of Digital Pilipinas, laterdiscussed potential collaborations between the Philippines and Hungary in digitalization.

She recognized Hungary's highly digitalized state, commending the Hungarian central bank's plan to launch

a central bank digital currency. Listing viable markets for collaboration with the Philippines, Ms. Maclang cited Singapore, which she described as father of Fintech; Indonesia, the largest ASEAN economy; Israel, and Hungary. She later noted Undersecretary Rodolfo's instructions to "turn PH into a hub for research and innovation, and not just as a market."

Maclang then presented Hungarian businesses which are close to soft-landing in the Philippines. These firms are engaged in various activities, such as industrial drone development, smart city solutions, fintech, IT security services, software development and programming.

Upon the formal program's conclusion, Filipino and Hungarian companies were able to discuss opportunities in the agricultural, smart infrastructure, and technological services sectors. (BOI)

Except for the Candaba Viaduct repairs, construction and lane closures along the mainline road of the NLEX-SCTEX will also be suspended unless safety repairs are necessary.

From 6 a.m. of Dec. 23 to 6 a.m. of Dec. 26 and from 6 a.m. of Jan. 1, 2023 to 6 a.m. of Jan. 3, 2023, free towing to the nearest exit will be available to those traveling with Class 1 or light vehicles. Bau-

tista encouraged motorists to use radio frequency identification (RFID) for faster and safer transactions.

"As more people are expected to gather and celebrate this festive season, more motorists are also expected to travel. We would like to encourage them to take their trips during nonpeak hours and use RFID for faster transactions at the toll plazas," he said in a statement. He likewise encouraged cash-paying motorists to shift to RFID to avoid queuing at the cash lanes.

"Those who have no RFID may have the sticker installed for free and pay the initial load," he said.

Bautista likewise advised existing RFID users to ensure that they have enough load, while those having concerns should have their sticker checked at the nearest Easytrip station.

"The NLEX management is likewise reminding motorists to check their vehicles before traveling as well as ensure that they are fit to drive to avoid any untoward incidents," he added. (PNA)

The destruction of the dangerous drugs is in compliance with the guidelines set on the custody and disposition of seized dangerous drugs under Section 21, Article II of Republic Act 9165, or The Comprehensive Dangerous Drugs Act of 2002, and Dangerous Drugs Board Regulation No. 1, Series of 2002.

Representatives from the Department of Justice, the Department of the Interior and Local Government, local officials of Barangay Aguado, Trece Martires City, the Philippine National Police and other law enforcement agencies, non-government organizations and media partners together with key PDEA officials witnessed the activity.

Meanwhile, handed over cash rewards etary rewards to the four amounting to PHP11.2 million to four informants on Monday at the PDEA National Headquarters in Quezon City.

PDEA top officials commended the informants identified through their codenames -- Mala, Denver, Dream and Mambo -- for providing information that led to the successful anti-drug operations, seizures of voluminous amounts of illegal drugs and arrest of high-value targeted drug personalities under the PDEA "Operation: Private Eye".

preferred Konsulta providers to enable them to avail of the services included in the Phil-Health Konsulta. Series of Alaga Ka activities, site registrations for all sectors were being conducted maximizing on the partnerships maintained through the years. The PRO IVA Konsulta Team is not leaving any stone unturned to ensure that every Filipino can avail of the services and benefits they are entitled to under the Phil-Health Konsulta.

age point from the current 13 percent. "We have already expanded the benefits to our members such as the unemployment benefit, and maternity benefit under the Expanded Maternity Leave Law (EMLL). Both these benefits, however, have no particular source of funding but since 2019, we have continuously given these benefits to our members," Regino said.

From 2019 until October 2022, SSS has already disbursed P3.78 billion in unemployment benefits to more than 287,000 members.

Likewise, the annual maternity benefit disbursement rose by 78% from P7.07 billion in 2018 to P12.54 billion in 2022.

The SSS Chief also said that the previous contribution increases boosted benefit disbursements for its members. "From January 2019 to October 2022, we have released P822.86 billion benefits to our members, which is 38% higher than the P596.30 billion benefit disbursements from January 2015 to December 2018 prior to the amendment of the Social Security Law," he added.

Moreover, Regino said the latest SSS actuarial valuation revealed that the fund life would last until 2054. "The reforms in the contribution rates are among the factors that helped boosted our fund life brought by Republic Act No. 11199 or the Social Security Act of 2018,"

This is an indicator that the pension fund has enough funds to support the shortterm and immediate financial needs of our members and pensioners in the decades to come. Under the Social Security Act of 2018, SSS should gradually increase the contribution rate until it reaches 15 percent by 2025. The four-tiered contribution increase will ensure the pension fund's financial viability for the benefit of its members, pensioners, and their beneficiaries.

Under the new rate, employers would shoulder the one (1) percentage point increase for its members with employers. The employee's share will remain at 4.5 percent, while the employer's share will increase to 9.5 percent from the current 8.5

For individual paying members such as self-employed, voluntary, non-working spouse, and OFW members, they will shoulder the whole 14 percent contribution rate since they have no employers.

Moreover, there will be an adjustment to the minimum monthly salary credit (MSC) from P3,000 to P4,000, while the maximum MSC will increase from P25,000 to P30,000.

"The new SSS contribution rate is also a great opportunity to help our members beef up their retirement savings through its mandatory provident fund program or the Worker's Investment and Savings Program (WISP). We want our members to have a comfortable retirement after their productive years. Every additional peso that a member contributes is more savings for their retirement. This is the principle that we want them to adapt---WORK, SAVE, INVEST, and PROS-PER," Regino concluded.
