

the Sibul II Mangrove Nursery and Eco-Tourism Park in Orion aims to prevent potential contamination of river systems and coastal areas from E. coli.

Moreno said through the facility, they want to promote the use of a waterless toilet or dry toilet system as an alternate solution to water-flushed toilets.

"Through this initiative, the volume of pollutants draining to water bodies along the Manila Bay area may be reduced, which will eventually help us in achieving the coliform limit of 200 most probable number (MPN) per 100mL for Class C water classification," he said in a statement.

Moreno said the concept of the first waterless toilet facility in the region supports DENR's endeavor to integrate biotechnology as an effective way to address environmental concerns and mitigate the effects of climate change.

According to the MGB, the eco-toilet system works by separating human waste from urine, which passes through the urine diverting dehydrating toilet bowl.

Upon separation, the nitrogen-rich solid waste is then covered with agro-industrial materials like fly ash, bentonite and zeolite, including organic-rich matters such as shredded dried leaves and carbonized rice husks.

This creates an alternating layer of n-rich and c-rich materials, which act as basic components of fertilizer.

On the other hand, the urine is likewise treated and

processed into a liquid fertil-

Moreno said the DENR is set to install these e-toilet facilities in other Manila Bay areas in the region.

The Manila Bay area covers eight provinces and 178 local government units in three regions of the country -- the National Capital Region (NCR), Central Luzon and Calabarzon.

Of the eight provinces, Bataan, Bulacan, Cavite and Pampanga are coastal areas. (PNA)

MWSS asseses final rebate << P1

assessing the final rebate amount, which shall not be recoverable or passed on to the consumers," MWSS-RO Chief Regulator Patrick Lester Ty said in a news release on Wednesday.

"Based on the investigation conducted by the MWSS-RO into the prolonged water service interruptions that have been adversely affecting the well-being of customers served by the Putatan

Water Treatment Plants (PWTP) since Dec. 20, 2022, Maynilad was found to have violated its Service Obligation of ensuring the availability of an uninterrupted 24-hour supply of water to connected customers within the PWTP Supply Zone," Ty added. In a meeting held last Jan. 6, Maynilad accepted the findings of the investigation and volunteered to provide a rebate to the affected custom-

ers. Meanwhile, the MWSS-RO has ordered Maynilad to fasttrack the resumption of normal water supply to the affected customers, especially during this time of the pandemic when water is most essential for safeguarding public health. Maynilad is the largest private water concessionaire in the Philippines in terms of customer base. It is the concessionaire of the MWSS for the West Zone

of the Greater Manila Area, which is composed of the cities of Manila (certain portions), Quezon City (certain portions), Makati (west of South Super Highway), Caloocan, Pasay, Parañaque, Las Piñas, Muntinlupa, Valenzuela, Navotas and Malabon all in Metro Manila; the cities of Cavite, Bacoor and Imus, and the towns of Kawit, Noveleta and Rosario, all in Cavite province. Marife Robios, an administrative assistant, and Allan Fresnido, the office manager, were arrested during the raid. However, both stated that they were only office workers and did not deal with the buyers.

According to the CIDG, the company lacks the necessary legal documents to conduct business.

At least 35 investors had previously filed complaints against the company after it failed to turn over fully paid properties.

DepEd-5 distributes P3.9-M learning kits from USAID, other donors

The Department of Education in Bicol (DepEd-5) has started to distribute the PHP3.9 million worth of portable classroom learning packages it received from its development partners. In an interview on Thursday, Mayflor Marie Jumamil, DepEd-5 information officer, said the "School in a Bag Kit" packages were given by the United States Agency for International Development Advancing Basic Education in the Philippines (USAID ABC+), Research Triangle Institute (RTI) International, Philippine Long Distance Telephone Company (PLDT) Smart Foundation and the Philippine Business for Social Progress (PBSP) in November last year. Jumamil said a total of 30 "last mile" schools were selected to receive a package, each set consisting of one laptop, 10 tablets (Samsung Galaxy tablets) containing smart apps, learning contents from ABC+, Kotobe app and one smart LTE pocket WiFi with PHP500 load. "Last mile schools are those with less than four classrooms, usually makeshift and nonstandard ones, no electricity, no funds for repairs or new construction projects in the last four years, and a travel distance of more than one hour away from the center, accessible only through difficult terrain," Jumamil said.

This has enabled us to increase water production to 91%, and gradually reduce the number of affected customers or lengthen the supply availability duration," Maynilad said in a statement sent to the Philippine News Agency on Thursday.

Maynilad made the assurance following the water service interruptions due to the reduced production of their treatment plant in Muntinlupa City as it accepted the findings of the investigation of the Metropolitan Manila Waterworks and Sewerage System (MWSS-RO) and volunteered to pay a rebate to the affected customers.

"We have accepted the result of MWSS RO's investigation and volunteered to pay a rebate to our customers in the south who were recently affected by water service interruptions,"

"Said interruptions were due to the reduced production of our treatment plant in Putatan, Muntinlupa, resulting from a damaged sludge removal equipment, coupled with a rise in turbidity levels of the raw water from Laguna Lake," it added.

The water company noted that they are now only stabilizing the treatment plant's system to revert back to normal levels by end of the month of earlier.

"Currently, we are just stabilizing the plant's system that was affected by the defective equipment, and monitoring the turbidity trend in the raw water supply. Barring any complications, water service should revert to normal levels by end of January 2023 or earlier," Maynilad said.

Maynilad is the largest private water concessionaire in the Philippines in terms of customer base.

It is the concessionaire of the MWSS for the West Zone of the Greater Manila Area, which is composed of the cities of Manila (certain portions), Quezon City (certain portions), Makati (west of South Super Highway), Caloocan, Pasay, Parañaque, Las Piñas, Muntinlupa, Valenzuela, Navotas and Malabon all in Metro Manila; the cities of Cavite, Bacoor and Imus, and the towns of Kawit, Noveleta and Rosario, all in Cavite province. Bataan-Cavite Bridge to cut travel time to 40min.

The Asian Development Bank (ABD) recently showed off newest renderings of the Bataan-Cavite Interlink Bridge, whose Detailed Engineering Design (DED) is set to be complete sometime in the first quarter of 2023.

Totaling 32.1 kilometers, the P3.6-billion project, which is supported by the ADB, was already at 55-percent overall completion back in September.

It's part of the state's decentralization efforts to reduce traffic and commuter woes in Metro Manila and Central and Southern Luzon. The North Channel Bridge and South Channel Bridges span 400 meters and 900 meters, respectively.

The Bataan-Cavite Interlink Bridge will look to connect the Central Luzon and Southern Tagalog regions through Correigdor Island.


This means that the four-lane bridge can drastically cut

travel time between the two provinces from five hours to just 40 minutes.

According to Department of Public Works and Highways Secretary Manuel M. Bonoan last year, the bridge should provide us with "new expansion and economic growth opportunities outside of the metropolis with investors now setting up industries leading to the route of promising new land and marine viaduct highway to be built between Regions 3 and 4A."

This bridge is an ambitious project that was first proposed in the '80s, and is now finally coming to fruition.

The alignment goes from the Timalan Balsahan shoreline in Naic, Cavite to the Alas-Asin land area in Mariveles, Bataan, which would pass through the historic Corregidor
