Maynilad to refund P27.48M to southern MM customers

The Maynilad Water Services, Inc. (Maynilad) on Tuesday said it will refund a total of PHP27.48 million to its customers in southern Metro Manila who were affected by water interruptions last December.

"We have agreed with the MWSS RO (Metropolitan Waterworks and Sewerage System Regulatory Office) on the rebate after they reviewed the causes of the services interruptions and affected areas in the south. Since the individual rebate amount depends on the experience in the specific areas, it is best for customers to get the details from the Public Information Drive of the MWSS RO," Maynilad said in a statement.

Maynilad also assured it is working to fully restore water service in the affected areas. "To date, mainte-



Noong Martes, Enero 24 ng taong kasalukuyan ay aking nakapanayam sa programang UP UP Pilipinas si Cooperative Development Authority Asec. Abad Santos, ang head ng Public Utilities Cluster (na kinapapalooban ng transport, electric water service, at communication service cooperatives) kung saan kanyang tinalakay ang kalagayan ng transport cooperative sa bansa. Inilahad sa atin ni Asec. Abad Santos na naging maayos naman ang sitwasyon ng transport cooperative sa kabuuan ngunit magkaganoon man ay humaharap ito sa samu't saring suliranin pagdating sa PUV modernization program. TRB inspects CALAX construction phase

Trece Martires, Cavite (PIA) - The Toll Regulatory Board (TRB) on Thursday, January 12 inspected the 14-kilometer operational segment of the Cavite-Laguna Expressway (CA-LAX) whose construction has reached more than 57 percent.

Once completed, CALAX will be connected to the Aguinaldo Highway expanding the road network to 45 kilometers. CALAX will then be connected to the Manila-Cavite Expressway (CAVITEX) to help decongest the major thoroughfares in Cavite and Laguna, the TRB said.


CALAX stretches from Mamplasan in Biñan, with interchanges at Laguna Technopark, Laguna Boulevard, Santa Rosa-Tagaytay Road, up to Silang East Interchange.

The TRB team led by Officer-in-Charge Josephine Turbolencia checked the expressway's operational system specifically its technological, safety, and security features, including the Automatic License Plate Recognition (ALPR) cameras and Radio Frequency Identification (RFID) system.

The group also inspected the Silang (Aguinaldo) segment of CALAX which remained at 65 percent-completion due to right-of-way (ROW) issues critical to its construction com-

Meanwhile, TRB said its government partner Department of Public Works and Highways (DPWH) is now on full swing with other project completion.

Leading the 700 devotees, Mayor Kevin Anarna lit the first candle at the image of the patron saint, Nuestra Señora de Candelaria in front of the church door followed by Vice Mayor Ted Carranza commencing the relay attempt.

Breaking the record of 366 candlelight lit held by India, Khevglacy Pascual, a staff member of the Silang Municipal Social Welfare and Development successfully lit

the 621st candle at 10:10PM before the candlelight died down. Kazuyoshi Kirimura, official adjudicator of the Guinness World Record witnessed the attempt and personally awarded the certificate for the Guinness World Record to the Municipality of Silang for successfully surpassing the challenge. The said attempt of Silang, Cavite was in celebration of the coming Feast Day of Nuestra Senora de Candelaria on February 1-3, 2023. (RBF/PIA-Cavite)

increase would translate to immediate benefits to the country's 13 million workers and will ensure the viability of the SSS fund designed to provide them with social security protection.

Enacted on February 7, 2019 by Congress, the Social Security Act of 2018 rationalized and expanded the powers and duties of the Social Security Commission (SSC) to ensure the long-term viability of the SSS. Under the law, SSS should gradually increase the contribution rate by one percentage point every two years until it reaches 15 percent by 2025.

In accordance with the schedule provided under RA 11199, the contribution rate increased to 14 percent from 13 percent in the previous year. Under the new contribution rate, employers will shoulder the one percent increase, which means their contribution will now be at 9.5 percent. The remaining 4.5 percent will be deducted from the employee.

Finance Secretary and SSC Chairperson Benjamin E. Diokno has expressed his support for the new contribution rate saying, "it is the right thing to do for the institution and its members."

Macasaet said the implementation of the contribution hike would eventually redound in a system that would serve workers better. "The contribution hike will benefit the workers with the SSS being able to provide a financially viable social protection system to Filipino workers and their families," Macasaet said. "It will not be a burden on workers but will be shouldered by employers. Workers earning less than P25,000 per month, who comprise 78 percent of SSS-paying employee members, will not be affected," he added. Macasaet served as President and General Manager of the Government Service Insurance System (GSIS) during the Duterte administration and was appointed by President Marcos to head the SSS last January 5 to replace former SSS PCEO Michael Regino.

At the same time, Macasaet noted that under existing tax laws, employers would be allowed to deduct their share of the contribution hike from their taxable income. "This underscores a whole-of-nation approach in securing the future of our workers with the Philippine government also contributing in the form of tax relief to employers," Macasaet explained.

The SSS is being urged by employer groups, such as the Philippine Chamber of Commerce and Industry (PCCI), the Employers Confederation of the Philippines (ECOP), and the Philippine Exporters Confederation Inc. (PECI), to suspend the implementation of the Social Security Act of 2018 that mandates the one percent increase in SSS contributions starting this month.

The request of the employers' groups was opposed by SSS officials as postponing the measure would reduce the actuarial life of the fund. The SSS said they gave due consideration to the plight of small employers in past contribution hikes, but ultimately had to act in favor of workers' interests and the fund's long-term solvency.

In his statement, Macasaet clarified that employees would not be required to shoulder the addition financial burden that goes with the contribution hike.

"The contribution hike will not be paid by the lowly worker but by financially-stable employers who can afford such adjustments. I am appealing to the PCCI, the ECOP, and the PECI, who we consider our valuable partners in our mission to provide social protection to our workers, to treat the contribution hike not as another operational expense but as a noble investment to ensure the viability of the workers' pension fund," Macasaet said.

"We appeal to our friends in big business to help us provide meaningful protection to the members of the working class and their families against the hazards of disability, sickness, maternity, old age, death, and other contingencies resulting in loss of income or financial burden," he added. "A socially protected working class is our best recipe for continued industrial peace in our coun-

House urged to consider automating Oct. 30 barangay, SK polls

Elpidio Barzaga Jr. urged his colleagues in the House of Representatives to adopt "experimental use" of the Automated Elections System (AES) in the barangay and Sangguniang Kabataan (BSK) elections on Oct. 30 this year.

In House Resolution 717 he filed on Wednesday, Barzaga directed the House Committee on Suffrage and Electoral Reforms to conduct an inquiry, in aid of lution, automated elections

and feasibility" of conducting automated BSK polls.

"It will not only yield faster results and proclamation of winners but will also prevent human intervention or error and confusion in the appreciation of ballot on an experimental basis on the BSK Elections in large barangays preferably in Metro Manila," Barzaga

According to the reso-

Cavite 4th District Rep. legislation, on the "viability have proven to be economical as it can accommodate up to more than 1,000 voters per clustered precinct as opposed to the 500 voters per precinct in manual elections which entails hiring more personnel in manual elections.

> President Ferdinand R. Marcos Jr. on Oct. 10, 2022 signed Republic Act 11935 moving the Dec. 5, 2022 BSK elections to Oct. 30, 2023 and holding succeeding elections every three

years thereafter. As of October 2022, there are 42,022 barangays in the country, each of which has one punong barangay (village chief) and seven Sangguniang Barangay (village council) members, one SK chairperson and seven members.

Barzaga, who chairs the House Committee on Natural Resources, said since there will be two ballots for the BSK elections, one for regular voters aged 18 and above and another one for SK voters aged 15 up to 30, the existing Vote Counting Machines (VCMs) "can be refurbished and modified to accept two ballots from a single voter who qualifies to vote in both Barangay and SK elections and the machines can tabulate separately the results of the Barangay and SK elections."

Historically, the resolution said, manual elections "encounter numerous problems including the inaccurate counting, interpretation and appreciation of ballots, among others, and the consolidation of votes in bigger Barangays usually take two to three days unlike in automated elections which immediately transmit the results to the canvassing center upon closing of the voting."

Barzaga pointed out that the Commission on Elections (Comelec) was lauded for the conduct of the May 9, 2022 national and local elections for having the fastest results and highest voter turnout since the Philippines adopted the AES in 2010 and the public has accepted the results of the elections.

A total of 55,290,821 or 84.10 percent of the 67,745,526 registered voters participated in the 2022 national and local elections.

The resolution also cited the fact that the Comelec owned the 97,000 refurbished vote-counting machines (VCMs) it purchased in 2016 and leased additional VCMs which were used in the 2022 polls "and a portion of these machines can be used in the BSK Elections in the pilot barangays."

Barzaga said since the AES was utilized in 2010, 2013, 2016, 2019 and the 2022 national and local elections, "Filipino voters are well-versed in using the same to cast their votes." (PNA)
