PBBM says gov't on track in pursuing key railway projects

The Philippine government is pursuing key railway projects seen to address the "terrible stories" about lack of quality time for many Filipinos due to traffic congestion, President Ferdinand R. Marcos Jr. said on Thursday.

Marcos made this remark during the signing of the Metro Manila Subway Project (MMSP) Contract Packages 102 and 103 in Malacañang.

The chief executive said the project is seen to reduce the "terrible stories we hear" from those who come home late due to heavy traffic.

"an orderly manner." DSWD Calabarzon Regional Director Barry Chua and Assistant Regional Director for Operations Mylah Gatchalian were absolved from the allegation as they were only following the existing guidelines.

The investigation was made after Noveleta, Cavite Mayor Dino Chua accused the DSWD-Calabarzon officials and personnel of incompetence in the delivery and distribution of reliefs for Paeng victims. "I have informed Mayor Dino Chua of the result of our investigation that I find no fault or mistakes committed by our Region IV-A officials and staff," Tulfo said during Monday's flag raising ceremony.

Earlier, Chua Gatchalian were temporarily transferred to DSWD Central Office pending the investigation of the alleged stringent requirements being asked from victims of the calamity during the payout of cash assistance.

Tulfo also said the identification (ID) card was the sole requirement to receive aid, in compliance with the auditing rules.

"Every centavo we give out to those in need must be accounted for and backed by a piece of document to show that our funds really go to the poor and the needy of this country, and to protect our personnel from graft and corruption cases," he said.

Tulfo vowed to protect and defend DSWD personnel as long as they are committed to fulfilling their duty anchored on the Depart-

ment's mission to "alleviate the suffering of the poor, the needy, the elderly, the vulnerable and the marginalized members" of the society.

"However, make no mistake! I will not condone those members of our agency who treat our clients with disrespect, abuse their position, or get involved in corruption," he said.

He assured to protect the welfare and well-being not only of DSWD's intended beneficiaries but also of its employees. (PNA)

Limited water access besets urban poor communities

Clean water is a basic necessity in human life. But even in this contemporary world, some sectors of society, most especially the urban poor, are still beset with limited access to water. In some poor communities in the Philippines, non-government organization E&V Water & Life said residents are living in unconventional housing arrangements and challenging terrains, making it hard to build a water network.

Having been working on the ground for more than a decade, the NGO said this water access gap has mostly affected women and children, who are often the ones left to do household chores. "Urban inclusion can never be met if you don't have a full access to public services, basic services, and among them water is really the most important one," said Augustin Vatelot, country director of E&V Water & Life Philippines during

the 2gether 4water conference in Makati on Tuesday. Since 2008, the NGO has so far brought 21 areas sustainable access to piped water, including some barangays in Cavite, Cebu, Mandaue and Tanauan.

This is in line with the directive of President Ferdinand Marcos, Jr. to provide Filipinos in affected areas with immediate relief and all the necessary assistance," said Secretary Jose Rizalino L. Acuzar of the Department of Human Settlements and Urban Development and Chairperson of the 11-member Pag-IBIG Fund Board of Trustees. Under the Pag-IBIG Calamity Loan, eligible members may borrow up to 80% of their total Pag-IBIG Savings, which consist of their monthly contributions, the counterpart employer's contributions, and accumulated dividends earned. And in consideration of the plight of the members, the loan is offered at a rate of 5.95% per annum which is the lowest is payable over a

period of up to three years, with a grace period of three months so that initial payment is due only on the fourth month after the loan is released. Qualified borrowers may apply for the calamity loan within 90 days from the date when an area

Acosta, meanwhile, stated that the agency has already released P2.03 billion in calamity loans to help 149,773 members in calamity-hit areas as of September this year. She also added that PagIBIG branches are now in coordination with local government units who have declared a state of calamity in their respective areas for the deployment of the agency's mobile branch, the Lingkod Pag-IBIG On-Wheels, to receive applications for calamity loans from members as well as insurance claims from current PagIBIG Housing Loan borrowers whose properties have been damaged due to the typhoon.

"When calamities strike, we at Pag-IBIG understand that our members in affected areas need immediate financial assistance. For this reason, we make sure that all our services and benefits remain rate in the market. The loan accessible to our members. Even while our offices and personnel in calamity-hit areas have also been affected by the typhoon, our branches remain open and are ready to receive loan applications and housing loan insurance claims. We have also deployed our Lingkod Pag-IBIG on Wheels to initially

Limited water access besets urban poor communities

Clean water is a basic necessity in human life. But even in this contemporary world, some sectors of society, most especially the urban poor, are still beset with limited access to water.

In some poor communities in the Philippines, non-government organization E&V Water & Life said residents are living in unconventional housing arrangements and challenging terrains, making it hard to build a water network.

Having been working on the ground for more than a decade, the NGO said this water access gap has mostly affected women and children, who are often the ones left to do household chores.

"Urban inclusion can never be met if you don't have a full access to public services, basic services, and among them water is really the most important one," said Augustin Vatelot, country director of E&V Water & Life Philippines during the 2gether 4water conference in Makati on Tuesday.

Since 2008, the NGO has so far brought 21 areas sustainable access to piped water, including some barangays in Cavite, Cebu, Mandaue and Tanauan.

Lilibeth Panlilio, one of the beneficiaries, said the struggle of having to run back and forth from her residence to the market where the nearest source of water is located is something she doesn't want to experience again.

"Napakahirap talaga ng walang tubig. Kapag kami ay nag-iigib sa ibang lugar lumalabas pa kami papunta ng

palengke, dala ang kariton. Magbabayad pa kami ng tatlong piso kada timba (Life is really difficult when you don't have water. Back then we had to go out and travel to the market with a cart in tow to get water in containers, which we also have to pay)," she said.

"Noong pumasok sa amin ang Water & Life ay malaking kaginhawaan dahil hindi na namin kailangan magkariton na minsa'y nasusubsob pa kami kakatulak (When Water & Life came, it was a big relief for us because we don't have to push carts carrying heavy load anymore)," she added.

In a 2019 report, the World Health Organization said around one in 10 people in the Philippines still do not have access to improved water sources. (PNA)
